7. Resolution in support of the Page Street Bikeway Improvement Pilot program (Resolution) Jenn Chan

- Popular east/west bike route
- AM peaks, more people travel by bike than those who drive
- Project has been a few years in the making
- Pilot 18-month proposal:
 - Diverter at page and webster
 - Page b/w laguna and octavia to be one way westbound for vehicle, bikes can go in both directions
 - Goal is to reduce the amount of traffic on page for people walking, safer for the children at John Muir Elementary school
 - One block protected
- Those who use haight and page to cut to central freeway, also slow down traffic for people who use the main arteries (oak/fell, etc)
- Don't want to impact muni on Haight street, some safety improvements have been approved on haight as part of the muni project. We're prohibiting left turns on haight from webster to haight. Right turn only from webster and buchanan
- Public engagement, lots of outreach to merchants, open house, offices hours at sunday streets, and smaller focused meetings with residents, door to door outreach
- Pilot project, it's a complex series of turn restrictions. Evaluation plan will include:
 - reviewing safety,
 - o mobility,
 - perception of safety and
 - design effectiveness
- Schedule:
 - o Implement: early 2020
 - Evaluate: spring 2020 + fall 2020
 - o Results: early 2021

 - Kristin making motion to approve Resolution with Amendment, Kisai seconds
