Director's Report to the Mayor's Disability Council

I look forward to today's conversation on access to Golden Gate Park, the Support at Home Voucher Program, and public remembrance of Mayor Ed Lee. Please do not hesitate to recommend action items related to any part of these presentations, or other items discussed in this report, as follow-up to today's Public Hearing.

The December 2017 engagement of the Mayor's Disability Council was a very successful holiday meet and greet held at the Mayor's Office on Disability (MOD). Highlighted here are some of MOD's key collaborations since the November 2017 meeting, and some important upcoming opportunities for public engagement by San Francisco Bay Area residents with disabilities.

Accessible Business Entrance Program: Information about the Accessible Business Entrance Ordinance, legislation passed by the SF Board of Supervisors in 2016 to help ensure that all primary entrances of San Francisco businesses and places of public accommodation are accessible to people with disabilities, was distributed by the Department of Building Inspection to San Francisco property owners last month. The Mayor's Disability Council (MDC) is encouraged to add an update from this program as an agenda item for a future MDC Public Hearing.

<u>Accessible Voting</u>: The Voting Accessibility Advisory Committee (VAAC) met on January 9, 2018 and highlighted two key opportunities for people with disabilities to provide timely feedback.

First, the California Secretary of State Office of Voting Systems Technology Assessment is seeking volunteer user testing of two Remote Accessible Vote By Mail Systems. They are specifically looking for people with disabilities who may provide feedback from any (home or other) computer system with web browsing capability and internet access during the week of January 22, 2018. Second, the San Francisco Department of Elections seeks feedback on implementation of the remote accessible vote-by-mail, as well as the accessibility of San Francisco voting and elections services, by January 26. Timely response will help the Department of Elections incorporate feedback in time for publication and other critical deadlines. Please follow the link to complete the survey:

Volunteers will receive a SF Giants branded gift and special entry into Fan Fest, and will have an opportunity to provide invaluable feedback about the AT&T Park evacuation plan.
