Project and policy solutions to improve safety, accessibility, mobility and equity in Golden Gate Park





Ordinance Approved at Board of Supervisors

3 miles of car-free streets from Kezar Dr to Lincoln Way in Golden Gate Park



- Retains 83% of parking spaces in Golden Gate Park
- Retains 80% of roadways for driving
- Access allowed for emergency vehicles, Muni, paratransit, de Young deliveries, maintenance, and permitted vehicles
- Specific Accessibility Commitments shared with Mayor's Disability Council responsive to the MDC resolution

Disability Access Coordinator

 A new Disability Access Coordinator will work directly with the disability community and other City agencies to provide architectural accessibility compliance analysis for the Recreation and Parks Department. This position adds to existing RPD ADA coordinators.

Winter 2023

Additional Accessible Parking Spaces

 20 new accessible parking spaces in a parking lot next to the Japanese Tea Garden, closer to the Cal Academy and the Botanical Gardens. This work includes path of travel improvements such as re-graded walking surfaces and upgraded curb ramps.

Spring 2022

More Shuttle Improvements

- Start using low floor buses that are easier to board
- Add new shuttle stop signs, seating and key shuttle route and reliability information at all shuttle stops
- Confirm and upgrade stops for level landing, path of travel, and curb ramps, where needed.

Spring 2023

Music Concourse Garage Enhancements

- Communicate the free 15-minute pick-up/drop-off option in the garage;
 work with the garage to make this time longer
- Improve garage waiting areas with seating and drop-off and loading parking spaces.
- Provide additional subsidized parking for everyone via Museums for All and Discover and Go passes

Fall 2022

Safer Streets

 Implement transportation engineering and education improvements to separate faster moving bikes from slower users on shared street spaces and speed management for all the vehicles in the Park

Summer 2022

Wayfinding

 RPD will identify accessible routes with physical signage. Accessible wayfinding directions will also be included on the RPD website.

Summer 2022

 Develop a new map and brochure of GGP, that will be available in large print, tactile, and Braille formats.

Winter 2023

Program and Architectural Access

Special events along the closed stretch of JFK, such as Entwined, and Holiday
Tree Lighting, will develop and execute programmatic access plans to ensure
accessibility for all attendees.

Spring 2022

• Enhance RPD website accessibility and ensure compliance with Web Content Accessibility Guidelines (WCAG 2.0) providing image descriptions and descriptive navigational information for people who are blind or low-vision.

Spring 2022

• Evaluate the access points to the Conservatory of Flowers, a National Historic Landmark and identify improvement opportunities.

Fall 2022

 Renovate curbs and crosswalks along JFK Drive, especially at Peacock Meadow and Conservatory Drive West.

ACCESSIBILITY

- 20 new blue zone spaces, fully compliant under ADA regulations at the Bandshell Parking Lot
 - 4 accessible van spaces
 - New pavement surface
 - ADA-compliant path of travel to the Music Concourse
 - Curb ramps

ACCESSIBILITY


- Immediate fixes to park shuttle operations and routing, including more service, every day
- Improved shuttle information at stops; all stops have benches and clear temporary signage, with marked paths of travel
- Event access plan implementation

- Taxi stands in the Music Concourse (at de Young & Cal Academy)
- Improved driving directions with map providers (Google & Apple Maps)
- Shared road closure
 information with Uber and Lyft
 for drop-off and pick-up at Music
 Concourse
- New tour bus zones next to the Bowling Green

East Side Design Improvements

- Clear, delineated space with stencil marking for the de Young loading dock vehicle users
- Removed un-needed signage clutter for parking and driving along car-free routes

Accessibility Upcoming Work 1

SHUTTLE

- Partnering with Adobe through Office of Innovation Civic Bridge program focused on improving shuttle information
 - Developing shuttle website improvements to make it legible and usable on a smart phone
 - Improving temporary shuttle stop signage accessibility, legibility and information improvements on the A-frames
 - Designing signage in the shuttle bus for on-board orientation and information
- Real time information still in progress, would integrate with Apple and Google maps
- New shuttle contract going through RFP process, anticipated to start in early 2023

Accessibility Upcoming Work 2

CURB RAMPS AND CAPITAL IMPROVEMENTS

- Funding: Accessibility improvements included in FY23 capital budget request
 - Curb ramps along JFK Drive, especially around Peacock Meadow and the Conservatory of Flowers
 - Stanyan Street frontage improvements
 - Shuttle stop location accessibility improvements
 - On track for Summer 2023
 Implementation



Accessibility Upcoming Work 3

ADAPTIVE BIKE PROGRAMS

- Adaptive Bikeshare is returning this summer!
- Free SFRPD & SFMTA program for adaptive recreation in partnership with BORP
- Two locations on alternating weekends: in Golden Gate Park next to the Bandshell Accessible Parking Lot and on the Great Highway at the end of Judah
- BORP will take reservations this year and BORP staff will continue to assist






Upcoming Work 1

WEST SIDE FOCUS

- Restore direct southbound traffic access to Sunset Blvd to reduce traffic congestion on Chain of Lakes – on track for Summer 2022
- Create separated promenade space on Middle Drive and create legible circulation to Polo Fields parking lot
