Program Background & Context




75% of weekday traffic on JFK Drive pre-COVID was cut-through, with no park destination or purpose





Almost 7 million walking, rolling, biking and strolling trips have been made on car-free JFK since April 2020, a 36% daily increase in park visits Golden Gate Park streets are designed for speed: On June 22nd, 2016, Heather Miller was killed on JFK Drive near 30th Ave by a person driving recklessly





In the five years preceding COVID there were more than 100 injury collisions involving people walking and biking in Golden Gate Park. 38 occurred on the current car-free streets alignment; 26 at entries to car-free streets; 42 on other park streets



Program Scope

Decisions for Winter 2021/22:

- 1) Closed street alignment-which streets should be closed to cars in Golden Gate Park post-COVID?
- 2) Supportive transportation policies and projects: make it easier to get to the park by all modes

Decisions beyond Winter 2021/22:

- 1) Broader capital improvements: traffic signals, major park improvements that require civil infrastructure
- 2) Bigger City operations: Muni route frequencies, Music Concourse garage updates



Disability Community Feedback To Date



What we've heard so far from the Disability Community & Older Adults

- Previous approaches to disability community outreach by the city have felt ableist or ageist
- Some people with disabilities and older adults use their cars as mobility devices
- Extensive need for wayfinding signage to assist all parkgoers, including paratransit and personal pick up/drop off
- Some people with disabilities and older adults have expressed that the lack of cars helps them feel safer



What we've heard so far from the Disability Community & Older Adults

- The current park shuttle is not reliable or userfriendly and stops don't have seating or shelter
- Many people with disabilities are low income and have concerns about paying for parking
- Out of town park visitors with disabilities and families with children or older parents with mobility devices express difficulty finding parking that is close enough to park features



Access improvements in progress

Capital

- New, on-street ADA spaces
- Music Concourse drop-off/pick-up zones
 - Conservatory Dr. West./ Dahlia Dell access fully open as of October 1st
 - Bandshell Lot ADA parking in design
 - MLK at Polo Fields circulation in design

Operational

- Adaptive Bikeshare events underway
 - Dynamic parking rates in the Music Concourse Garage
 - Golden Gate Park Shuttle better routing & higher frequency

New accessible parking

- We understand that challenges with accessible parking have existed for a while and feel harder now with the closures
- We have already completed 5 new spaces on MLK and 3 on Nancy Pelosi
- 4 spaces in the Music Concourse Bandshell Parking lot are now free and available 7 days a week
- The Music Concourse Bandshell Parking lot which has been used primarily for tour buses will be converted to 19 free ADA spaces (more than the number of spaces lost on JFK)

Passenger loading zones

- Vehicles can always access the passenger loading zones in front of the DeYoung Museum and the Academy of Sciences
- 15-minute free drop-off and pick-up in the garage; we are exploring options to improve the accessibility of this option






Getting to park destinations now

Example of text directions to accessible parking and passenger loading zones

Conservatory of Flowers, Dahlia Garden and Tennis Center Four accessible spaces are available on Nancy Pelosi Drive in the block between Bowling Green Drive and John F. Kennedy Drive (JFK Drive). One space is located in front of the Tennis Center and three spaces are located at the end of the block near JFK Drive and are closest to the Conservatory of Flowers and Dahlia Dell

Directions from the north and east: Enter park on John F. Kennedy Drive from Stanyan Street or Oak Street. Head west and bend south as the road becomes Kezar Drive. Turn right on to Martin Luther King (MLK) Drive at a traffic signal. Turn right at the next intersection onto Bowling Green Drive. Follow the road including a bend to the left then right. Turn right at Nancy Pelosi Drive.

Directions from the south: Enter the park from 9thAvenue heading north. Turn right at the second street, Nancy Pelosi Drive. Follow Nancy Pelosi Drive for almost half a mile. Continue straight past the intersection with Bowling Green Drive.



Getting to park destinations using paratransit

 We have confirmed with Paratransit that their vehicles can enter the park at 8th Avenue for faster access to the Music Concourse (de Young & California Academy of Sciences)

Project Proposal Considerations

Engineering Considerations:

- Legibility, safety, and engineering feasibility
- Addition of ADA parking blue zones
- Maintain delivery access to park institutions
- Improve pick-up/drop-off to park institutions

Park Experience Considerations:

- Minimizing disruption to current park use and visitor experience
- Prevent or minimize new cut-through traffic in the park



Existing Car-Free Route Option West End



- Prevents cut-through traffic, enhances park experience
- Zero injury collisions since April 2020
- Emergency vehicles can use car-free space
- Additional access solutions needed

Project Proposals

- Revamp the **park shuttle** to make it more useful for everyone
- Improve parking, loading and ADA access on Fulton Street from 6th Ave to 11th Ave
- Set up a new **taxi stand** inside the park
- Improve signage online and in-person to improve navigation
- Install additional bike racks for dockless bikeshare and scooter-share
- Permit docked bikeshare stations
- Permit **pedicab service** within the park



Shuttle Program

We understand the current Golden Gate Park Shuttle is not working well for park users and we are committed to improving it.

Through the Golden Gate Park Access and Safety Program we are proposing substantial improvement to the shuttle program to make it work better, including:



- In the **short-term** (winter 2021-2022):
 - <u>MAINTAIN</u> current shuttle route between McLaren Lodge and Transverse Drive
 - INCREASE weekend service from 2 to 3 shuttle vehicles
 - <u>NEW</u> weekday service with 2 shuttle vehicles
 - <u>UPGRADE</u> existing shuttle stops to be more accessible and visible
- In the longer-term:
 - <u>OUTREACH</u> to determine changes to route, frequency, and transit connections
 - <u>PURSUE</u> low floor shuttle vehicle procurement & new shuttle management



- All park streets re-opened to vehicle traffic
- All parking spaces on JFK available for use
- Induces substantial cut-through traffic activity
- Impacts to traffic safety and park experience
- Substantial delays for the 44 O'Shaughnessy
