The prison incarceration rate for women has increased 518 percent since 1980, jumping from 15,118 to 111,387 incarcerated women in three decades (Guerino, Harrison & Sabol 2012). The number of women in jail nationwide also increased exponentially during this time period—from under 8,000 to nearly 110,000, a 1275% increase—and jails currently house nearly half of all women behind bars in the United States (Swavola, Riley & Subramanian 2016). These profound changes in women's involvement in the criminal justice system stem from broad shifts in investment from social welfare to social control, harsher drug sentencing laws, and barriers to reentry that uniquely affect women situated in varying hierarchies of race, ethnicity, motherhood status, and health. The majority of women in prison are mothers to children under the age of 18 with recent numbers indicating that one in 110 White children, one in 15 Black children, and one in 41 Hispanic children experience maternal prison incarceration (Christian 2009). The numbers are more pronounced when considering children of women in jails, eighty percent of whom are mothers. These women spend an average of 23 consecutive days in jail and often cycle in and out of jail throughout their children's formative years (Subramanian et al. 2015).

Even though the number of women who cycle in and out of local jails far exceeds that of the number of women in prison, research tends to focus on the consequences of prison time on women. Our research will focus primarily on women's jail and reentry experiences with an emphasis on institutional barriers and supports for successful reentry. Criminologists have long focused on the importance of social institutions for understanding involvement in offending with social disorganization theorists emphasizing that the strength of local institutions, the ability of institutions to work together, and access to the resources institutional networks provide are central aspects of crime control (e.g., Sampson, 2011; Peterson and Krivo 2010). In this respect, one might think of jails and prisons as institutions of last resort, or institutions charged with picking up the pieces when other institutions have failed to meet women's core needs. The women in our country's jails and prisons are predominantly poor, minority, mothers who have experienced childhood abuse, low education, mental and physical health problems, and lack the personal and social supports needed to navigate their marginalized lives (Greenfeld and Snell 2000; McDaniels-Wilson and Belknap 2008). It is unsurprising that women cycle in and out of jail when we consider that their already limited institutional access – to jobs, familial supports, and social welfare – is further curtailed by a jail or prison record (see Wakefield and Uggen 2010).

We would like to conduct interviews with 30 women as they reenter society from serving time in jail or prison. Ideally, our interviewees will be women situated in various hierarchies of race, ethnicity, and motherhood status. The women may or may not be in a reentry program focused on building their institutional and social networks. Our primary interest is in learning how the women view the resources and constraints they experienced in accessing institutional amenities on their pathways to the criminal justice system and how they think these resources and constraints have been affected by their experiences in the criminal justice system and will inform their pathways moving forward. Our research will focus specifically on the following questions:

RQ1: How do women in the justice system consider their access to institutional resources within families, schools, and communities as a part of their life experiences and pathways to incarceration? What types of resources and constraints did they experience in accessing resources from core institutions? How do these resources and constraints vary across race and ethnicity?

RQ2: How do women think that their criminal justice experiences have or will affect their access to institutional resources within families, schools, and communities?

RQ3: What resources, formal and informal, do formerly incarcerated women rely on to address the consequences of incarceration? How did they learn about these resources? What barriers, if any, are there to accessing these resources?

RQ4: What resources do formerly incarcerated women see as necessary for successful reentry?

We would be interested in conducting open-ended interviews over zoom following an interview script detailing the key topics that will be covered with participants. Interviews will be recorded and transcribed. After the participant consents to the interview, the interviewer will begin to build rapport and get to know the participant by asking about her family life and background growing up. The interviewer will then segue into questions about constraints and opportunities for accessing institutional supports, asking specific questions about family, education, communities, job opportunities, and so on. The interviewer will then ask the women to discuss how big of a role the criminal justice system has played in their life, what they consider to be the biggest challenge to reentering society, including families, employment, and their community. The focus of the questions will be on concerns women have in reentering various institutions and what resources they think will ease the transition. The interviewer will close by talking with the participant about her needs and the related resources and supports she has (or has not) been able to access to address these needs.

Interview data will be transcribed and coded and then analyzed with qualitative coding software (e.g., Atlas.ti) to identify key themes that frame the experiences of women's criminal justice and reentry experiences and expectations. Key themes we will look for include those related to experiences with core societal institutions and how they might have been structured to better work together to meet the needs of women as they began their pathways to incarceration and what needs women have moving forward with respect to institutions working together, rather than in a fragmented manner, to meet their pressing needs in reentering society and accessing institutional supports.

The ultimate goal of this study is to provide much-needed information on how reentering women navigate the significant amount of stress and adversity in their lives and how core institutions might better help them do so. In doing so, the study will provide insight into the challenges reentering women face and will identify the conditions and resources that might mitigate or exacerbate their stresses and challenges. By identifying the challenges, as well as resources for change, we will provide an evidence-base for better support and services for women reentering society after criminal justice contacts. All data will be de-identified to protect the women's anonymity, and an IRB (Institutional review board) will be submitted to North Carolina State University (an R-1 research University) for approval.
