DISCUSSION

A. HSA Domestic Violence/Imminent Danger Policy Chair Mukami 30 min
The Subcommittee reviewed the draft HSA Domestic Violence/Imminent
Danger Policy.

Subcommittee Members Bohrer and Steen shared their opinion that there was no need for a 15 day denial of service in the policy.

Subcommittee Member Mukami stated his belief that the Policy Subcommittee should pass the recommendations with the edits put in place.

Subcommittee Member Steen stated his support for approving the recommendations with the edits in place.

Public Comment: Minouche Kandel from the Dept. on Status of Women (DOSW) stated that she had submitted a proposal to HSA that contained stronger language which would only allow shelter staff to ask clients to leave if the perpetrator of violence presents an immediate danger.

Subcommittee Member Mukami spoke about the grievance process and how shelters handle denials of service.

Subcommittee Member Steen brought up a question from the last Shelter Monitoring Committee meeting regarding whether or not transgender victims of domestic violence would be allowed to stay in domestic violence shelter beds.

Public Comment: Minouche Kandel stated that some domestic shelters will take in transgender men and women. She stated that she knows that the Asian Women's Shelter will accept transgender women and that she thought they would accept transgender men as well. She stated that she look into which domestic violence shelters would accept transgender men and women and give that information to Committee staff at a later date.

Proposed Action: Approve the recommendations for HSA's Draft Domestic Violence/Imminent Danger Policy with edits and send them to the Shelter Monitoring Committee for approval. The Policy Subcommittee also recommend that the Shelter Monitoring Committee send the recommendations to the Mayor, Board of Supervisors, Local Homeless Coordinating Board, Human Services Agency and the Department of Homelessness and Supportive Housing if they are approved.
