(On July 18, 2023, the Complaint Committee moved that the records were public, there was jurisdiction and to forward the matter to consent calendar under Administrative Code, Sunshine Ordinance, Section 67.29-5 for tardiness in providing the calendar.)

**6B. File No. 23052** Complaint filed by Stiliyan Bejanski against Debra Lew and the Office of the Treasurer and Tax Collector for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, and California

Government Code Section(s) 6253(c), by failing to respond to a records request in a timely and/or complete manner.

(On July 18, 2023, the Complaint Committee moved that this was an Immediate Disclosure Request, that the department responded timely, the final release was about five weeks later and there are legal cases going on with the petitioner and the records had to be reviewed for them to be public and to forward to this item to the Consent Calendar with a recommendation for no violation.)

- 7. **File No. 22112:** Complaint filed by Michael Petrelis against Jonas Ionin and the Planning Commission for allegedly violating Administrative Code (Sunshine Ordinance), Section 67.7 for failure to post an agenda in a complete and/or timely manner. (attachments) (On December 12, 2022, the Complaint Committee moved that the SOTF has jurisdiction, find that the requested records are public and to refer the matter to the SOTF for consideration.)

- 8. **File No. 22010**: Complaint filed by Ron Cicero against the Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a public records request in a timely and/or complete manner. (attachments)

(On May 3, 2023 the SOTF moved by Chair Yankee, seconded by Member Schmidt, to find that the Police Department violated Administrative Code, Sunshine Ordinance, Section(s) 67.21(b), by failing to provide records in a timely manner; send a letter to the Chief of Police to order the persons most knowledgeable of property control and archived public records at 1995 Evans Avenue and Building 606 at Hunters Point Shipyards to search for and turn over the requested records as soon as possible and to refer the file to the Compliance and Amendments Committee for follow up.

On August 22, 2023, the Compliance and Amendments Committee moved that the matter be referred back to the SOTF with the recommendation to refer the matter to the Ethics Commission and possibly consider willful violation.)

- 7. Vote by Task Force (Public comment at discretion of chair on new motion and/or on new motion if vote fails.)

Public Comment will be taken before or during the Committee's consideration of each agenda item. Speakers may address the Task Force for up to three minutes on that item. During General Public Comment, members of the public may address the Task Force on matters that are within the Task Force's jurisdiction and are not on the agenda. Any person speaking during a public comment period may supply a brief written summary of their comments, which shall, if no more than 150 words, be included in the official file.

Each member of the public will be allotted the same maximum number of minutes to speak as set by the Chair at the beginning of each item, excluding persons requested by the Task Force to make presentations, except that public speakers using interpretation assistance will be allowed to testify for twice the amount of the public testimony time limit. If simultaneous interpretation services are used, speakers will be governed by the public testimony time limit applied to speakers not requesting interpretation assistance.

Each member of the public who is unable to attend the public meeting or hearing may submit to the City, by the time the hearing begins, written comments regarding the agenda items. These

Individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [SF Campaign & Governmental Conduct Code, Section 2.100] to register and report lobbying activity. Under Campaign and Governmental Conduct Code, Section 1.127, no person or entity with a financial interest in a land use matter pending before the Board of Appeals, Board of Supervisors, Building Inspection Commission, Commission on Community Investment and Infrastructure, Historic Preservation Commission, Planning Commission, Port Commission, or the Treasure Island Development Authority Board of Directors, may make a campaign contribution to a member of the Board of Supervisors, the Mayor, the City Attorney, or a candidate for any of those offices, from the date the land use matter commenced until 12 months after the board or commission has made a final decision, or any appeal to another City agency from that decision has been resolved.
