11. **File No. 23099**: Complaint filed by Mark LaCroix against the San Francisco Fire Commission for allegedly violating Administrative Code (Sunshine Ordinance), 67.5 by failing to conduct meetings of any policy body open and public; 67.10 conducting a closed session hearing on a non-permitted topic, and 67.11 by failing to properly notice a closed session hearing. (02:14:05)

(On August 7, 2024, the Task Force moved to find a violation of Administrative Code Section 67.10(b), regarding the January 12, 2022 Fire Commission meeting as to item 5C.

The Task Force further found that in light of the previous motion, Ms. LaHood asked the Fire Commission to release the portion of the January 12, 2022 closed session pertain to item 5C and requested a response from the Commission.)

a) Hearing on the complaint. (Discussion and Action)

Action: Moved by Member Wolfe, seconded by Member LaHood, to refer/return the matter to the Complaint Committee for consideration of a violation of Administrative Code (Sunshine Ordinance), Section 67.21.

Public Comment: Michael Crotty [sic] stated that the Fire Commission violated the Brown act in citing personnel reasons for hearing a matter in closed session. Anonymous stated that the Task Force should protect the people from corruption.

12. **File No. 24042**: Complaint filed by Rosa L. against the Office of the Mayor for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.25, by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner. (03:14:00)

(On 10/2/2024, moved by Chair Yankee, seconded by Member Anderson, found that Mayor London Breed violated Administrative Code (Sunshine Ordinance), Section(s) 67.29-7, by failing to maintain and preserve in a professional and businesslike manner the requested correspondence and failing to disclose such records in accordance with this Ordinance.

The Task Force requested that Mayor Breed confirm with the Task Force if she intends to maintain her correspondence in compliance with Administrative Code Section 67.29-7 going forward.

The Task Force, moved by Member Schmidt, seconded by Member Hyland, further found that the Mayor's non-production in this case constitutes a willful failure to comply with Administrative Code (Sunshine Ordinance) Section(s) 67.29-7 and therefore a willful failure under Section 67.34, and referred this matter to the Ethics Commission.)

a) Consider rescinding the Sunshine Ordinance Task Force's prior action referring Mayor London Beed to the Ethics Commission due to the Mayor's upcoming departure from office. (Discussion and Action)

The Task Force members discussed options for proceeding with a referral of File No. 24042 to the Ethics Commission.

Public Comment: Geoff asked if the Task Force has the ability to enforce public records requests. Rosa L. stated that she strongly agrees that the sending the referral to the Ethics Commission because it is important to set a goal or marker. Mark LaCroix supports the referral to the Ethics Commission.

The Task Force members discussed methodologies for valuing the work of the Sunshine Ordinance Task Force and possible effects of Proposition E on its continued operations.

DCA Lopez provided an overview of the timeline and processes that the Budget and Legislative Analyst (BLA) will follow to develop recommendations to the mayor and Board of Supervisors on ways to modify, eliminate, or combine appointive boards and commissions. DCA Lopez further stated that the Sunshine Ordinance Task Force was created by ordinance in August 1993 and amended by the voters in November 1999; therefore, changes are made by a charter amendment that is drafted and recommended by the City Attorney's Office. DCA Lopez stated that the Task Force cannot be amended or rescinded without voter approval.
