I shooed her away, voiced for her to get away from my car banging on my window like she lost her mind. I was on the phone speaking with a woman by the name of Gloria who works at the civil sevice commission when this happened. the lady then went inside of the spca and returned with a large black man to intimidate me as well as another caucasin women, backing me into a corner. I then called the police, who showed up and did nothing, but! took my information and gave it to these people at the spca who then wrote long letters to Nathaniel fords office, claiming that I threatened her and they called the police all fabrication. On July 5, 2010 one of my co-workers attempted to hit me with a 60 ft motor coach, I reported it to Central Control, the dispatcher and my union rep Carmen Quiroz. Carmen then called wallace Johnson at home and asked him to pull the tape off the bus he refused. On july 7th he agreed to pull the tape. At approximately 9am the same operator who attempted to kill me on july 5, 2010 filed charges against me stating that I threatened her in the ladies restroom, with another co-worker cosigning with her who was disgruntled with me prior to this incident. Less then an hour later I was escorted out of the Flynn division by five cars of Police officers. This was embarrassing, humiliating, far-fetched, and un called for.
