Dear Ms. Kanios:

In response to your February 24, 2010 letter, the documents you refer to, fail to respond to my outstanding Sunshine request. You testified at the earlier hearing that you also had checked these files and were committed to looking in other places. The documents mentioned here I have seen and have been in your custody for several years. It's clear that nothing relevant exist. In light of your February 4, 2009 admitting that no records exist. i.e. not even a list of the "large contracts"/johs. You should now comply with Sunshine Ordinance in written form stating that no responsive documents exist.

#### Reference:

1. HRC February 4, 2009 letter, Re: January 16, 2009 Public Records request. "Dear Mr. Kinnard"

"HRC never filed charges against P&K Trucking. So, there are no items that directly satisfy your request. The only item we have that relates to your request is the minutes from the January 13, 2005 HRC Commission Meeting that includes a report of the hearing officer's final determination upholding HRC's denial to P&K Trucking's appeal for re-certification. In fact, you pointed these out to me during our conversation."

Note: You have looked through documents listed above and checked and replied that "there are no items that directly satisfy your request." You have also had more than a year to sift the files to find any other documents, as you testified to at the previous hearing.
