Dear Chair Goldman and Members of the Complaint Committee:

This letter addresses the issue of whether the Sunshine Ordinance Task Force ("Task Force") has jurisdiction over the complaint of Juan De Anda ("De Anda") against the San Francisco Department of Public Health ("DPH").

#### **COMPLAINT**

On June 25, 2008, Juan De Anda, filed a complaint with the Task Force against the San Francisco Department of Public Health (CBHS) and listed Ms. Maria Leach as the person he has had contact with. In his complaint, Juan De Anda claims ethics violation while using county money. Refusal to invite public to meetings and cherry picking who gets invited and who doesn't. Denial of financial records. Juan De Anda claims public records and public meeting violations.

#### SHORT ANSWER

Based on Complainant's allegation and the applicable sections of the Sunshine Ordinance and the California Public Records Act, which are cited below, the Sunshine Ordinance Task Force *does not* have jurisdiction over the allegations. The complaint in its present form is too vague and does not give notice as to what the Department is alleged to have done.

## **DISCUSSION AND ANALYSIS**

Article I Section 3 of the California Constitution as amended by Proposition 59 in 2004, the State Public Records Act, the State Brown Act, and the Sunshine Ordinance as amended by Proposition G in 1999 generally covers the area of Public Records and Public Meeting laws that the Sunshine Ordinance Task Force uses in its work.

The Sunshine Ordinance is located in the San Francisco Administrative Code Chapter 67. All statutory references, unless stated otherwise, are to the Administrative Code. Section 67.21 generally covers requests for documents and Section 67.25 covers Immediate Disclosure Requests. Sections 67.3 through 67.17 cover the conduct of Policy Bodies.

CPRA Section 6253 generally covers Public Records Requests and the Ralph Brown Act; California Government Code Sections 54950 et seq. covers public meetings.

In this case Juan De Anda has claimed an Ethics violation that is not in the jurisdiction of the Task Force and have made allegations about meetings that may not involve policy bodies. He has also made allegations about denial of financial records but it is not clear what records he refers to. Given the lack of information in this complaint, the Task Force does not have jurisdiction over the subject matter of this complaint.

Meanwhile, his complaint regarding ethics violation is not a matter appropriate to the SOTF.


At this time, we have no plans to send a representative to this hearing.

Please see the Department's original response to this complaint in the preceding e-mail of 7/7/08. Mr. DeAnda's complaint states, "Ethics violation while using county money. Refusal to invite public to meetings and cherry picking who gets invited who doesn't. Denial of financial records."

We have no documentation that Mr. DeAnda asked for records. No indication of what records he is referring to. Therefore, we cannot respond to a complaint that lacks such specificity.

The CBHS has its own consumer complaint process and until Mr. DeAnda has either worked through this system or produced records denying him and the public access to whatever meetings he is referring, we are without an ability to articulate a reasonable position relative to this complaint.

Given the baseless nature of this complaint, it is not that we contest jurisdiction, we see nothing of relevance that merits SOTF consideration. We submit this position in lieu of sending staff to this hearing.
