On November 2, 2010, the San Francisco Unified School District ("District") received notice from the San Francisco Sunshine Ordinance Task Force ("SOTF") of Complaint No. 10058—Sean McGuire v. San Francisco Unified School District. In accordance with SOTF Public Complaint Procedure section B.3.b., this letter shall serve as notice of the District's position that the SOTF does not have jurisdiction to process or investigate Complaint No. 10058 insofar as it involves issues pertaining to District operations.

Based on our conversation of November 4, 2010, I understand that the SOTF has requested from the San Francisco City Attorney's Office a review of jurisdiction regarding Complaint No. 10058. Please provide me the results of this review when available. In the event that SOTF is determined to have jurisdiction over Complaint No. 10058, the District reserves the right to respond in substance to the complaint.
