Re: Complaint #07080a by Dan Boreen against the Fire Department for violation of Sections 67.24-67.27; 67.29-5 of the Sunshine Ordinance, and CPRA Section 6254 for alleged failure to provide records, failure to keep withholding to a minimum, failure to justify withholding, and untimely response.

Based on the information provided to the Task Force from the Complainant Dan Boreen, Respondent Rob Boughn, and hearing public comment, the following Order of Determination is adopted:

The Sunshine Ordinance Task Force finds the Fire Department in violation of Sections 67.26 and 67.27 for failure to keep withholding to a minimum and failure to justify withholding. The Fire Department is instructed to provide the "City-paid benefit" type the Department redacted from the time rolls provided to Mr. Boreen within 5 days after the issuance of this Order of Determination.

Dear Sunshine Ordinance Task Force Members,

During the December 12, 2007 Compliance & Amendments Committee meeting, items 07080b and 07080c were tabled to allow the SFFD to finish reviewing its policies and procedures and to address concerns expressed by the Committee. Those concerns included citing exemptions when redacting information, providing explanations of items redacted and maintaining access to calendars by administrative staff. The Department was additionally asked to commit procedures to writing specifically for the provision of calendars, and to submit a copy of those procedures to the Task Force for review.

The SFFD Public Records Request Policy and Procedures is available on the Department's website at the following URL: [http://www.sfgov.org/site/sffd\\_page.asp?id=66933](http://www.sfgov.org/site/sffd_page.asp?id=66933) As stated in the policy, the Department is committed to providing members of the public their full right of access to Department public records under the San Francisco Sunshine Ordinance and the California Public Records Act. This is accomplished by complying with the public records laws, and, when laws are in conflict with legal exemptions or where laws specified are vague, the Department may request legal assistance.

The Department has decided it is not necessary to write individualized procedures for the disclosure of each sub-category of Department public records. The Department merely needs to comply with existing laws.

However, in light of the complaint, Chief Hayes-White has reviewed the information being included in her calendar. The Chief will continue to maintain a Calendar in compliance with §67.29-5, provide information as required by the section, and eliminate or reduce the inclusion of information not pertaining to City business. In addition, Chief Massetani has improved access to his Calendar for his administrative staff.

Dear Sunshine Ordinance Task Force Members,

The purpose of this letter is to provide review of the Compliance & Amendments Committee meeting held on January 9, 2008, and to summarize the history of the complaint against the San Francisco Fire Department made by the complainant, Dan Boreen. Only complaint item #07080a, regarding the disclosure of "pay type codes", was addressed during this meeting.

Mr. Boreen is requesting that all records previously provided with the pay type codes redacted be re-released without any redaction of pay type codes what-so-ever.

The records which the Department originally provided to Mr. Boreen, with all pay types codes redacted, are as follows:

- Employee History: William Storti - 6/1/06 to 8/13/07
- Time Rolls: CD-1 - 6/3/06 to 7/28/06
- Time Rolls: CD-2 - 6/3/06 to 7/28/06
- Time Rolls: CD-3 - 6/3/06 to 7/28/06
- Time Rolls: Assignment Office - 6/3/06 to 7/28/06
- Time Rolls: Assignment Office - 7/29/06 to 8/10/07

At the full Task Force meeting held on November 27, 2007, the Department provided Mr. Boreen with a new set of the records listed above. The new set of records disclosed pay type codes, with the exception of a limited number of codes that indicate certain employee "leave" statuses. Not all "leave" status codes were redacted, however, as jury duty, legal holiday, regularly scheduled day off, suspension, and trade codes were all disclosed. The new set of records provided did not include "Time Rolls: Assignment Office - 7/29/06 to 8/10/07".

The Task Force was not satisfied with the justifications provided for redacting certain

"leave" status pay type codes, and referred the complaint to the Compliance & Amendments Committee. The Department, meanwhile, requested further legal guidance from the City Attorney's Office, as legal interpretation beyond the scope of the Department and the Public Records Officer was required.

It was the Department's impression that Mr. Boreen, and the Task Force, was not interested in the Department providing records with certain "leave" status pay type codes redacted until further legal justification was provided. At the time of the 1/9/08 Compliance & Amendments Committee meeting, legal advice was still pending. The Department therefore provided Mr. Boreen with the remaining records (Time Rolls: Assignment Office - 7/29/06 to 8/10/07), redacting "leave" status pay type codes consistent with the records provided on 11/27/07.

The Department is still awaiting legal guidance from the City Attorney's Office regarding the disclosure of pay type codes. As soon as that guidance is received, the Department will provide both the Task Force and Mr. Boreen its procedure for disclosing pay type codes. If the procedure produces a greater disclosure of information, the Department will provide Mr. Boreen with the appropriate responsive records.

At the 1/9/08 Compliance & Amendments Committee meeting, the Department also provided Mr. Boreen and the Task Force with the following records:

- Time Rolls: Station 25 - 7/1/06 to 7/28/06
- Employee History: Dan Boreen - 6/1/06 to 7/20/07

These records were previously provided to Mr. Boreen with no pay type codes redacted; Pay type codes on the Station 25 Time Rolls were mistakenly not redacted, and pay type codes on the Employee History were not redacted since Mr. Boreen is the subject of those records. Contrary to statements made by Mr. Boreen, the Department does have a history of redacting pay type codes on records requested by other members of the public, although, admittedly, the Department's procedure for making such disclosures and/or redactions has not been consistent. Records provided at the 1/9/08 meeting had "leave" status pay type codes redacted to demonstrate the current pay type code disclosure procedure which is pending further procedural guidance.

Related to Mr. Boreen's other complaints, the Department's procedures for providing department head and non-department head calendars are in the process of being reviewed and shall be provided to the Task Force and Mr. Boreen upon their completion.

Dear Sunshine Ordinance Task Force Members,

This purpose of this letter is to provide supporting information to be considered for the next Compliance & Amendments Committee meeting to be held on January 9, 2008, regarding charges against the San Francisco Fire Department made by complainant Dan Boreen.

At the previous C & A Committee Meeting held on December 12, 2007, four (4) separate complaint items were reviewed for compliance. Those items involved the following subject matter: a) Non-disclosure of all 'Pay Type' codes; b) Chief of Department (Department Head) Calendar containing redactions; c) Form and content of non-Department Head Calendar; and d) Time Rolls not being signed by an officer. To date, the Minutes of that meeting have not been made available; therefore I shall hereby review the results of the December 12, 2007 meeting and include any additional comments. An e-mail reviewing the results of the December 12, 2007 meeting was also sent to the SOTF on December 13, 2007.

a) PAY TYPE-

"TO BE CONTINUED AT NEXT C&A COMMITTEE MEETING (January 9, 2008)"

SOTF Members request the Department to:

- Provide response to SOTF & Mr. Boreen by December 31, 2007
- Response to include:
  - Pay Type code redaction key (if any)
  - Legal justifications and legend/key for any & all redactions
  - All responsive documents requested by Mr. Boreen adjusted & provided

Since the resolution of this matter involves the review and interpretation of several legal statutes, it is beyond the scope of the Department and the Public Records Officer. This matter is therefore being addressed by the Office of the City Attorney. To date, the Department has not received a response from the City Attorney's Office, as a final determination has not yet been made.

b) CHIEF OF DEPARTMENT [DEPARTMENT HEAD] CALENDAR-

"TABLED"

SOTF Members would like to receive:

- Department Head Calendar Procedures- Write-Up of how calendars are to be maintained in the future (what/what not to include)
- Redactions are to be "keyed" [per (§67.26) (§67.27(d))] - include in procedure
- Copy of SFFD Public Records Request Policy & Procedures

The Department is still in the process of reviewing and creating a written procedure for maintaining and providing the Chief of Department Calendar. The Department anticipates the completion of this review prior to the January 9, 2008 Meeting.

The SFFD Public Records Request Policy & Procedures is available at the following URL: [http://www.sfgov.org/site/sffd\\_page.asp?id=66933](http://www.sfgov.org/site/sffd_page.asp?id=66933). This policy and procedure is currently under review and shall be revised in 2008.

In addition, during the December 12, 2007 Meeting, a Committee Member referenced a legal case regarding "substantial misconduct" that, she alluded, broadens the interpretation of the SF Sunshine Ordinance, §67.24(c)(7), and occluded any justifications for such withholdings. If the Department is expected to re-interpret the SF Sunshine Ordinance beyond what is clearly stated in §67.24(c)(7) in order to be in compliance, I suggest the Committee provide the Department with clear legal justification in support of the allegations, and provide guidelines that must be adhered to by all City Departments.

c) NON-DEPARTMENT HEAD CALENDAR-

The SOTF was sent a copy of the Deputy Chief of Administration's Calendar via US Mail on December 21, 2007.

The Department is still in the process of reviewing and creating a written procedure for maintaining and providing Non-Department Head Calendars. The Department anticipates the completion of this review prior to the January 9, 2008 Meeting.

d) UNSIGNED TIME ROLLS-

"NO FURTHER ACTION"

- SOTF Members suggested to Mr. Boreen that the issue of Time Rolls not being signed by officers is not within the scope of the Task Force, but should be taken up in another venue.

This item therefore requires no further action on the part of the Department.
