ORDER OF DETERMINATION

September 1, 2009

DATE THE DECISION ISSUED August 25, 2009

ANMARIE MABBUTT v. RECREATION AND PARKS DEPARTMENT (09038)

FACTS OF THE CASE

Complainant Anmarie Mabbutt alleges that she submitted in the course of the past four weeks a number of Immediate Disclosure Requests ("IDR") with the Recreation and Park Department ("Rec & Park"). To those requests, Ms. Mabbutt states that Rec & Park provided full documentation on some, partial responses on some, "tampering" on others, and a few with no responses.

COMPLAINT FILED

On July 17, 2009, Ms. Mabbutt filed a complaint against Rec & Park alleging violations of Sections 67.21 and 67.25 of the Sunshine Ordinance.

HEARING ON THE COMPLAINT

On August 25, 2009, Complainant Anmarie Mabbutt appeared before the Task Force and presented her claim. Respondent Agency was represented by Olive Gong, the Custodian of Records for Rec & Park.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

Ms. Mabbutt told the Task Force that she has submitted numerous IRDs to which some have been responded to, some have been ignored and some have generated partial responses. There are no laws, she said, that restrict the number of requests a person can make. The department, she said, has not said that the documents she wants are confidential; it has simply slowed down their response to a trickle. She also listed several documents that she wanted released first, and explained that she was attempting to work with the Department to prioritize the items in her requests. Respondent Olive Gong said in the last two months she has received 124 requests and 81 emails from the complainant. The Department has responded diligently and has sent the complainant 88 emails, 147 email documents and 337 hardcopy documents, she said. Ms. Gong alleged that all but

a few of the complainant's requests for documents were labeled "Immediate Disclosure. Request" and required extensive staff time The Department, she added, has asked the complainant to prioritize her requests so that staff could respond in an orderly fashion and also take care of requests from other members of the public. Complicating the process, she said, was that the complainant reprioritizes her top requests several times over.

The Task Force sympathizes with the Department for the burden of responding to the pending requests, which are numerous, but noted that the law requires strict compliance and that Departments are required to do their best to provide accurate, timely responses. The Task Force also wanted to make sure that Ms. Mabbutt would really work with the Department to prioritize her many requests and would refrain from reprioritizing her requests, as that only added to the Department's already heavy burden. The Task Force asked both sides to work together and directed Ms. Mabbutt to send Ms. Gong a "final" list of priorities for the Department to respond to before turning to Ms. Mabbutt's other pending requests. Both sides agreed to that process.

DECISION AND ORDER OF DETERMINATION

The Task Force finds that the agency violated Section(s) 67.21 of the Sunshine Ordinance. Both parties were asked to work with each other and are to appear before the Compliance and Amendments Committee on September 8, 2009 to update the Committee on the status of the responses.

This is to serve as notice that the San Francisco Recreation & Park Department continues to be in violation of numerous sections of the Sunshine Ordinance and as such, I respectfully request that Complaint #09038 be re-calendared before the SOTF immediately.

This is a copy of an email that I received earlier today. In it, Olive Gong writes that the Department has completed its responses to my most recent prioritized list. I have had a chance to review the documents, they are clearly incomplete and absolutely no documents were provided as responsive to IDR #66.

Also, regarding the Department's blanket denial of any documents responsive to IDRs #73-79, that is simply untrue. The Department has already supplied documents to me in regards to other IDRs that clearly state the following organizations received NFP or APBP approval and applicable rates for at least 2008: SF Viking Soccer, SF Glens, SF Seals Junior Academy, Sacred Heart Cathedral Preparatory Camps, Jewish Community Center of SF, St. Ignatius Summer Programs and Stuart Hall High School. These are the exact same organizations that are addressed in IDRs #73-79 so clearly documents must exist that are responsive to these IDRs!

Finally, on at least four occasions now, over the course of the past three weeks, the San Francisco Recreation Department and Olive Gong and Margaret McArthur in particular have denied my request for public access to review public records within their custody, during normal business hours, without requiring an appointment and without unreasonable delay, an inexcusable and very serious violation of Section 67.21(a) of the Sunshine Ordinance.

Please consider the below email as Exhibit #1 for the 10/13/09 compliance hearing re: Complaint #09038.

Please note that Ms. Gong's denial of any documents responsive to IDR #35 is in and of itself a clear violation of Section 67.29-7..(c) of the Sunshine Ordinance.

I further submit that having already received notice of this requirement back on July 19th 2009, if still no responsive documents are available, General Manager Phil Ginsburg appears to clearly be in violation of Section 67.34 of the Sunshine Ordinance for having willfully failed to discharge the duties clearly required under Section 67.29-7.(c).

I also submit that Ms. Gong's blanket denial of any documents responsive to IDRs #73 -79 can simply not be true. Dozens of permits at these non-profit or APBP fees have been issued by the Department to the individuals/organizations identified in IDRs #73-79. In order to have received such rates, all such individuals/organizations would have been required by the Park Code to submit the NFP or APBP applications and attendant fees by an annual deadline before receiving any permits based on those rates.

Dear Olive,

In accordance and cooperation with your request for my newest IDR priorities, I have assembled the following list:

- 1. I want a copy of any and all public records contained in the personnel file of Dana Ketcham regarding her initial hiring. I understand that any disclosed records will need to redact her home address and phone number, social security number, age and marital status. This IDR includes but is not limited to any curriculum vitae, professional biography, resume, letters of reference and any memos, notes, letters etc regarding Ms. Ketcham's prior volunteer work with the City on behalf of the City Fields Foundation, Viking Soccer or any other non profit organization.
- 2. I want an authentic, untampered copy of Receipts #250494 and #250483 that were issued to Soccer Kids and Jaime Parady for Fall 2009 permits for Athletic Field use.

The following IDRs were placed on September 14, 2009 and are clearly overdue. After I placed the following IDRs, you did not respond or object to them other than to state that you were adding them to the list. That is clearly an inadequate response. Any denial of an IDR or any other public records disclosure request requires that you state with specificity the basis for the denial.

Just for the record, the Sunshine Ordinance Task Force never ordered me nor does it have the authority to order me to discontinue making public records disclosure requests.

- 3. I want a copy of the request for Tennis Court Permit# 8758, dated January 30, 2009 issued to University High School and Jim Ketcham..

 I want a copy of any and all public records pertaining to the request for Contract #8758 including but not limited to any online request forms, informal notes, memos, etc. If there is no record of a request, please confirm so in writing.
- 4. I also want an authentic copy of any and all public records related to the order/instruction to issue Tennis Court Permit #8758. I expect any responsive documents to indicate at whose direction and/or upon whose authorization this permit was issued.
- 5. I want a copy of any and all Annual Reports prepared and/or submitted by the Recreation & Park Department General Manager to the Board

of Supervisors regarding the City Fields public-private partnership Agreement since 2006. In accordance with the language of Ordinance #060255, the RPD General Manager is required to prepare and submit an Annual Report to the Board of Supervisors regarding the progress/status of the partnership agreement.

I would like to state for the record that I already attempted to acquire these Annual Reports from the Clerk's Office but they have no record of any such reports.

I am also stating for the record that all of the above IDRs should be fulfilled by the close of business tomorrow. None of the records requested are voluminous, remote in time, require an extensive search or consultation with other departments
