"The purpose of these awards is to highlight the performance of some public servants and departments and to call attention to the performance of those whose compliance has been deficient," said Chair Sue Cauthen, "These awards grow from years of frustration with the lackluster execution of voter-mandated laws that have come to be largely ignored or discounted, leaving the public in the dark in some key areas of our bureaucracy that are, in fact, the public's business. With this carrot-and-stick approach, it is hoped that our public servants will recognize that there are consequences, both good and bad, that come with their reaction to public requests for documents or access to meetings."
