John St. Croix, Executive Director, Ethics Commission discussed the proposed plan to change the due date for the annual Sunshine Declarations from April 1, to December 31 to coincide with requirement of AB1234 filing requirements.

The Rules Committee, by consensus, made the following recommendation for consideration by the Task Force in response to the City Attorney's and Ethic Commissions proposals.

- 1) That live training be provided in every odd year.
- 2) Sunshine training and filing requirement occurs within 30 days after assuming office and/or appointment; that filling of the annual Sunshine Declarations remain

due on April 1.

- 3) That a training budget be developed for both the City Attorney's Office and Ethics Commission for Sunshine and Ethics training.
- 4) Authorizes the Task Force to communicate its recommendations to the Ethics Commission, the City Attorney, the Mayor, and the Board of Supervisors as appropriate.
