

I am writing in response to the Sunshine Ordinance Complaint- number #09081 received in my office on December 17, 2009 at 3:42 pm.

First 5 San Francisco is an enterprise department of the city and county of San Francisco. Our funding is from a tobacco tax distributed to us by First 5 California and Prop H a special city fund. Our sole focus is on children birth to five and their families. Our funding is distributed via grants and work orders to over 45 public and non-profit community agencies in San Francisco.

We have received two different Sunshine Ordinance Complaints from Mr. Alvin Xex and many email and phone calls from him over the past 6 months.

The first Sunshine Ordinance Complaint # 09064 was received on September 30, 2009. Mr. Xex alleged that he requested information from the Economic Opportunity Council of San Francisco (EOC). First 5 never received a request from Mr. Xex directly and first heard of the matter when we receive the official complaint. Mr. Xex did not bring his complaint to the Commission once he was unsatisfied with EOC's response. Had Commission staff known about the complaint, we would have facilitated a resolution before a complaint was filed with the Sunshine Ordinance Task Force (SOTF). Our city attorney advised us that since ECO received over \$250,000 per year in City funds and since First 5 SF was lead agency on the contract, we had responsibility for facilitating a resolution between Mr. Xex and EOC. First 5 requested that this matter be rescheduled for a pre hearing conference. The request was denied. First 5 Executive Director, Laurel Kloomok, attended the SOTF meeting on October 27, 2009. This complaint was listed as item 26. Mr. Xex left the meeting before the item was heard. Ms. Kloomok spoke briefly to Committee members and agreed to try to facilitate a resolution. This became impossible to achieve due to a series of serious events that took place at EOC.

The joint funders of EOC: First 5 San Francisco, the Human Services Agency (HSA), and the Department of Children, Youth and Their Families (DCYF) had grave concerns regarding the executive leadership, fiscal management and program quality of the San Francisco Economic Opportunity Council (EOC). Over the last year, it had become increasingly clear that the agency was experiencing failures of governance, finances and

management. Furthermore, there were serious problems with the provision and quality of EOC provided services. The State of California Department of Community Services and Development (CSD) designated EOC a "high risk" agency. CSD is in the process of redirecting EOC's ARRA contracts to lower risk entities. In addition, they have imposed special conditions on existing and future funding and have made demands for payments of disallowed costs. After several attempts to dialog with EOC staff and Board of Directors, the city departments and the controller's office decided to end all city contracts going to EOC. This occurred on December 3, 2009. As a result, the complaint against EOC by Mr. Xex could not be addressed.

The second Sunshine Ordinance Complaint #09081 was again made against EOC. In this complaint, Mr. Xex wrote "Info requested (2 times) not given-4 questions not given to me or task force. A Laurel Kloomok simply refused to send information-skirting sunshine laws!!" This second request of EOC was never received by First 5. However, Mr. Xex did request information about First 5 SF on October 16 2009. (Please find attached request). After consulting with our city attorney, we responded to this request on October 29, 2009. (Please find attached response). Mr. Xex made an additional request via telephone on November 19, 2009 asking for a copy of the Commission's Family Resource Center Initiative's Evaluation. A copy was sent on December 1, 2009.

On December 2, 2009, Mr. Xex contacted Commission members Kara Dukakis and Suzanne Giraudo stating he had asked for information, that Laurel Kloomok denied knowledge of information available, that the request contained simple questions about outreach efforts by First 5 and asking to address the Commission about First 5's outreach mission. A letter in response to Mr. Xex was sent later that day. (Please see attached Letter to Mr. Xex 12-2-09). Mr. Xex was invited to the Commission meeting. He did not appear.

First 5 SF mission is to instill an enduring obligation in San Francisco residents and government to ensure the opportunity for optimal health and development of every child living in the county. We work hard to fulfill this Mission. The department values honestly, integrity and compassion. As responsible stewards of state and city funds, we operate with transparency and openness. We have tried to understand Mr. Xex's concerns and have offered him opportunities to learn more about First 5. We assume that he has the city's children and family's best interest in mind, one that is shared by us.

Dear Mr. Xex,

With all due respect, it has never been my intention to insult you. In response to your claim that we have not answered your public records requests, the following is a run-down of what we understand your requests to have been and our responses:

1. Regarding items #1-5 from your written request dated November 16, 2009: Per our strategic plan and evaluation framework, we can send you demographic snapshots of the children, parents/caregivers and providers served by a combination of our health, family support and early childhood education grants for most recent year available (2007-08), but if you would like information regarding numbers and types of services that specific ethnic and cultural groups have received that would require additional analysis.

As per Government Code 6253.9 subsection b, if public records are not available to satisfy your request in the format requested "the requestor shall bear the cost of producing a copy of the record, including the cost to construct a record." If you would like to cover the cost of compiling the data and creating a public record to satisfy #1-5 of your request dated November 16, 2009, we would be happy to send you a cost estimate for that project.

- 2. Regarding item #6 from your written request dated November 16, 2009: We sent you our financial statement audits from fiscal years 2007-08 and 2008-09 on November 29, 2009.
- 3. Regarding items #7-8 from your written request dated November 16, 2009: The information you requested is outlined in the Commission's two most recent funding proposals that were sent to you on November 29, 2009.
- 4. Regarding item #9 from your written request dated November 16, 2009: Under the California Public Records Act and the San Francisco Sunshine Ordinance, personnel records are exempt from disclosure.
- 5. Regarding your verbal public records request to Theresa Zighera on November 19, 2009: From your voice message, we understood that you would like to see a copy of the FRC Initiative Evaluation Framework. This information was mailed to you with a cover letter on December 2, 2009. This is within the allowed time period of 10 business days. As a reminder, it is always best to make public records requests in writing in order to ensure that you obtain the documents that you want.
- 6. Regarding your email to Kara Dukakis dated November 30, 2009: In your email, you state that "The requests contained simple questions about outreach efforts by First5 of San Francisco." The written and verbal requests your have submitted have not expressed a desire for information about outreach efforts.

I invite you again to attend our Commission meeting this evening from 5:30 to 7:30pm at 1390 Fox Plaza, Suite 318.
