DESCRIPTION: Below are the alleged violations of the Sunshine Ordinance, in brief, against the San Francisco Arts Commission, Direct of Culture Affairs, Mr. Luis Cancel and San Francisco Street Artist Program Director, Mr. Howard Lazar. Public Records Request: On Sept 23, 2009 and then amended on Sept 29 2009 I sent an "Immediate Disclosure Request" to Mr. Howard Lazar. On Oct. 2, 200 he acknowledged that he received the requested, and at that time he invoked an extension of not more that 14 days from Sept. 29, 2009. Furthermore Mr. Lazar stated in his letter that "The Arts Commission will endeavor to respond to you as quickly as possible and no later than October 13, 2009. Since that time I have received the original requested documents but not the amended requested documents of September 29, 2009. In addition, when I saw Mr. Lazar at the Nov. 4, 2009 SFSA program committee meeting, I requested the status of the remaining documents and Lazar said that he was going to provide them to me by the end of the following week. I have left a subsequent phone message and an email, but to-date over two months after first requested Mr. Lazar has failed to provide me with the requested documents. The San Francisco Street Artist Program (SFSA) Liaison Committee Definition: The SFSA Liaison Committee as originally proposed and described by San Francisco Arts Commissioner Mr. Luis Cancel: "The Liaison Committee would be a separate, independent, advisory body which would act as "a sounding board" on issues. Presently, whenever Mr. Lazar and he meet with the ad hoc committee, they have no assurance that its current members speak for a significant number of street artists." Source:

http://www.sfgov.org/site/sfac_page.asp?id=108420 Five members of the San Francisco Street Artist Program were fairly elected from an official election held by the Arts Commission Staff and approved (see below) by the San Francisco Arts Commissioners on Nov. 4 2009 to be members of the San Francisco Street Artist Program Liaison Committee. Commissioner Melania moved to approve the following candidates (in ranking order) as members of the Street Artists Liaison Committee: Tad Sky, CherylChen, Debra King, Michael Addario, Jimmy Sha; the motion was seconded by Commissioner Calloway and unanimously approved. Source: http://www.sfgov.org/site/sfac_page.asp?id=114121 Mr. Lazar had stated in public announcements prior to the liaison election that he (Lazar) would attend the liaison committee meetings and act only the secretary for the liaison group; to take the meeting minutes and post the agenda on the Arts Commission website. In contrast to Mr. Lazar' statements and against the sprit of the SFSA liaison committee being a "separate, independent body" that was verbalized by Mr. Cancel, Mr. Lazar preceded to do the following: 1.) Lazar reschedule the SFSA liaison

committee meeting date without conferring with elected liaison committee members. 2.) Lazar posted false and misleading SFSA liaison committee election results on SFSA program web site and has refused to correct them when notified as such by me. Source:

Lazar presumably with Cancel approval, inserted a agenda item on the Dec. 7, 2009 Full Art Commission agenda to grant full control of the SFSA liaison committee meeting times, place and agendas from the duly elected liaison committee members, to Lazar and Cancel without first having a public meeting at the SFSA program committee meeting level where the SFSA liaison committee was first approved. In addition Lazar and Cancel are now seeking with this proposal to as they state: "Members of the Liaison Committee, once elected, shall serve at the pleasure of the Director of Cultural Affairs. RE: Sunshine Ordinance Task Force - #09085 Michael Addario v. Arts Commission

Dear Task Force Members:

The San Francisco Arts Commission (the "Commission") submits this response to Complaint #09085, which was submitted on December 6, 2009 and received by the Commission on December 17, 2009. The following is a preliminary response from the Arts Commission, clarifying that the Sunshine Ordinance Task Force (the "Task Force") lacks jurisdiction to hear this complaint, but also summarizing the Commission's compliance with the Sunshine Ordinance and its position that Complaint #09085 is without merit. In the event that there is a hearing on this matter, the Commission reserves the right to provide a more detailed response in advance of the hearing.

In Complaint #09085, Michael Addario alleges the following:

Item #1 of the Complaint.

"On Sept 23, 2009 and then amended on Sept 29, 2009 I sent an "Immediate Disclosure Request" to Mr. Howard Lazar ... but to-date after two months after first requested Mr. Lazar has failed to provide me with the requested documents. ..."



Mr. Addario's "Immediate Disclosure Request" has now been fulfilled. Please see the attached copy of a fifteen-page letter of December 23, 2009 to Mr. Addario, listing and identifying the contents of **over 100 documents**, representing **267 pages**, furnished to Mr. Addario. The reasons that this took nearly three months to fulfill are (1) Mr. Addario

requested documents from three years of files; (2) Mr. Lazar had – and still has - no staff to help him with the research and production of documents in fulfilling such voluminous public documents requests, while still having to fulfill his other, primary, duties and responsibilities to over 400 street artist license holders; and (3) for the entire past month, he had to also perform the duties of the Street Artists Program's licensing clerk, because the licensing clerk was out of the office on leave.

Accordingly, because the request has been fulfilled – and fulfilled under difficult circumstances - we respectfully request that the Task Force dismiss this complaint.

Item #2 of the Complaint.

"In contrast to Mr. Lazar's statements and against the sprit [spirit] of the SFSA liaison committee being a 'separate, independent body' that was verbalized by Mr. Cancel, Mr. Lazar proceeded to do the following: 1.) Lazar reschedule[d] the SFSA liaison committee meeting without conferring with elected liaison committee members. ..."

The Director of Cultural Affairs of the Arts Commission, Mr. Luis Cancel, exercised his right to attend the first meeting of the newly formed Liaison Committee, the very committee, in fact, which he had publicly urged the Arts Commission to make official. Mr. Cancel was unable to attend a Liaison Committee meeting tentatively scheduled for December 2nd; because the only date that was available in his schedule for him to meet was December 10th, he requested Mr. Lazar to schedule the meeting for that date and to inform the members of it. (Please see the attached November 25, 2009 e-mail from Lazar to the Liaison Committee members informing them that "The meeting of your Liaison Committee will not be scheduled for December 2; it will be scheduled for Thursday, December 10th. The Arts Commission's Director of Cultural Affairs, Mr. Luis Cancel, will be attending the meeting on December 10th. Because of prior commitments, he is unable to attend a meeting scheduled for December 2nd.")

For the reasons discussed below, the Sunshine Task Force lacks jurisdiction over Item #2 of the Complaint and Item #2 is without merit.

The Sunshine Task Force Lacks Jurisdiction over Item #2 of the Complaint.

The Arts Commission's Director of Cultural Affairs has the authority to set the date of a meeting of the Commission and/or any of its committees. Furthermore, with respect to the newly created Liaison Committee, the full Arts Commission confirmed by unanimous vote on December 7, 2009, in adopting "Street Artists Liaison Committee Procedures," that (1) the first meeting of the Committee would be "scheduled on December 10, 2009", and (2) that "subsequent dates, times and agendas" would "be set by the Street Artists Program Director" [Howard Lazar] "and the Director of Cultural Affairs" [Luis Cancel] "unless otherwise modified by the Arts Commission through a subsequent resolution." The Commission offered adequate prior notice and opportunity for the public to attend and comment upon the item. We have attached a copy of the relevant agenda of the full Commission meeting for your reference. It is also available at

Because the Commission complied with the public meeting and agenda requirements of the Sunshine Ordinance with respect to the issue of the scheduling of the first Liaison Committee meeting and its subsequent meetings, Item #2 of the Complaint is without merit.

Furthermore, because the Sunshine Ordinance does not provide for consideration of the "spirit" of a committee "being" (as Mr. Addario states on behalf of the Liaison Committee) "a separate, independent, body", Item #2 of the Complaint is again without merit.

Item #3 of the Complaint.

"Lazar posted false and misleading SFSA liaison committee election results on SFSA program web site and has refused to correct them when notified as such by me."

For the reason discussed below, the Sunshine Task Force lacks jurisdiction of the Complaint and Item #3 is without merit.

The Sunshine Task Force Lacks Jurisdiction over Item #3 of the Complaint.

Mr. Addario's complaint under Item #3 is without merit. Please see the attached December 2, 2009 e-mail from Mr. Addario to Mr. Lazar, pointing out Lazar's error (in the minutes of the November 4th meeting of the Street Artists Committee) in the vote count for one of the candidates; and Mr. Lazar's December 16, 2009 e-mail reply to Mr. Addario acknowledging the error and informing him that he will request the Arts Commissioners at the upcoming January 13, 2010 Street Artists Committee meeting to vote to have the minutes of the November 4th meeting amended to reflect the correction.

Because Mr. Lazar's e-mail reply refutes Mr. Addario's assertion that Lazar "has refused to correct" the minutes, Item #3 of the Complaint is without merit.

Item #4 of the Complaint.

"Lazar insert[ed] a line item into the SFSA liaison agenda and posted it on SFSA liaison web site without first conferring with elected members."

For the reasons discussed below, the Sunshine Task Force lacks jurisdiction over Item #4 of the Complaint and Item #4 is without merit.

The Sunshine Task Force Lacks Jurisdiction over Item #4 of the Complaint

The Sunshine Ordinance does not require the Street Artists Program Director (whose job title is provided for in Ordinance No. 291-94) to confer with members of the Street Artists Liaison Committee or the members of any committee of the Street Artists Program, in order to place an item or topic on the Liaison Committee agenda or the agenda of any committee of the Street Artists Program.

Furthermore, as Mr. Addario himself states, the item and the agenda itself were posted online. The item and the agenda were posted on the Arts Commission's website well over 72 hours in advance of the meeting.

Because of these reasons, Item #4 is without merit.

Item #5 of the Complaint.

"Lazar presumably with Cancel approval, inserted a[n] agenda item on the December 7, 2009 Full Art Commission agenda ... without first having a public meeting at the SFSA program committee meeting level where the SFSA liaison committee was first approved."

For the reasons discussed below, the Sunshine Task Force lacks jurisdiction over Item #5 of the Complaint and Item #5 is without merit.

The Sunshine Task Force Lacks Jurisdiction over Item #5 of the Complaint

With respect to Item #5, Mr. Addario alleges that the Commission failed to bring an agenda item "without first having a public meeting at the SFSA program commttee [of the Commission] meeting level where the SFSA liaison committee was first approved." The Task Force has no jurisdiction to adjudicate this allegation. No provision in the Sunshine Ordinance requires an agency to hear a matter concerning committee meeting schedules or any other item of business at an advisory committee level before presenting the matter to the full commission for consideration and action. Nor does the Sunshine Ordinance impose distinct or additional notice requirements for participants in the Street Artists Program. Instead, all members of the public, including any street artists, receive notice in accordance with the same standards set forth in the Sunshine Ordinance. Even if the Commission had failed to follow its own procedures for referral of matters to committees - and, in fact, it did follow its own procedures - the Task Force has no jurisdiction to adjudicate an alleged violation of a commission's internal administrative rules or procedures.

Accordingly, because the Task Force lacks jurisdiction to adjudicate this allegation, the Task Force should dismiss this complaint without addressing the merits.

Item #6 of the Complaint

"In addition Lazar and Cancel are now seeking with this proposal to as they state: Members of the Liaison Committee, once elected, shall serve at the pleasure of the Director of Cultural

Affairs.'"

The statement, to correct Mr. Addario, is part of the unanimous resolution of the Arts Commission on "Street Artists Liaison Committee Procedures" (adopted on December 7, 2009). One of the provisions in the resolution states: "Members of the Liaison Committee, once elected, shall serve at the pleasure of the Director of Cultural Affairs." The wording of the resolution – containing all of its provisions – was stated on the agenda of the full Arts Commission which was duly posted. The Commission offered both adequate prior notice and opportunity for the public to attend and comment on the item.

Because the Commission complied with the public meeting and agenda requirements of the Sunshine Ordinance with respect to the issue of Liaison Committee members serving at the pleasure of the Director of Cultural Affairs, Item #6 is without merit.

We hope this information is helpful.

Dear Mr. Addario:

In your "Immediate Disclosure Request" of September 29, 2009, you state that you "categorically deny" the charges levied against you in a September 8, 2009 "Notice of Warning" which I sent you for allegedly interfering with and obstructing (1) the Arts Commission's supervision of its space-assignment lottery system for street artists (Ord. 41-83, Section 2406(a)) which includes its implementation of a "movie lottery" procedure for obtaining compensation for street artists displaced from their spaces by a film company (Arts Commission Res. No. 1209-96-561, and (2) the Arts Commission's ability to seek compensation for such street artists in accord with the terms of the Arts Commission-Film Commission Agreement of 1999. You then request copies of documents pertaining to six (6) categories of subject matter.

We hereby address the items of your request.

- 1) You request to be furnished with "copies of any and all letters, emails, notes, internal memos that you have received or wrote to any and all parties regarding this matter." Please find the enclosed copies of the following:
 - (1-1) The September 8, 2009 "Notice of Warning" and attached August 18, 2009 e-mailed complaint by street artist Lottery Committee member Kathy Hallinan as forwarded by Howard Lazar to the President of the Arts Commissioners, the Commissioners of the Street Artists Committee, Director of Cultural Affairs Luis Cancel, Arts Commission staffmembers Jill Manton and Evelyn Russell, Deputy City Attorney Adine Varah, and Laura Barsotti of the Film Commission.
 - (1-2) The above "Notice of Warning" and attached complaint



forwarded to street artist members of the Lottery Committee and street artist "Market Managers" of Justin Herman Plaza (your address redacted from the copies sent to the artists).

- (1-3) August 19, 2009, 1:51 p.m. e-mail letter from Howard Lazar to Ms. Stefanie Coyote, Executive Director of the Film Commission, requesting that the film company of the *Trauma* TV series be informed of Michael Addario's lack of authorization "for submission of documents" and to request that the company forward the documents to Mr. Lazar.
- (1-4) August 19, 2009, 2:04 p.m. e-mail reply from Ms. Laurel Barsotti of the Film Commission stating that the film company had "already begun issuing reimbursement checks to the 18 individual vendors per Mr. Addario's request" and that "Unfortunately, they [the film personnel] were not aware that they were required to pay the Street Artists Program."
- (1-5) August 19, 2009, 2:24 p.m. e-mail from Laura Barsotti of the Film Commission with list of names and license numbers of street artists who were denied usage of their spaces by the *Trauma* film company; attached note by Howard Lazar stating that, when he asked her for the street artist documents, Ms. Barsotti "said she was told that Addario had submitted only an Excel spreadsheet", and that Mr. Lazar asked that it be sent to him.
- (1-6) August 19, 2009, 4:47 p.m. e-mail to Howard Lazar from Laura Barsotti of the Film Commission with attached spreadsheet Ms. Barsotti received listing the names, addresses, and Social Security numbers of the street artists who were denied usage of their selling spaces by the *Trauma* film company.
- (1-7) August 18 19, 2009 e-mail correcpondence between Kathy Hallinan and Howard Lazar, with Mr. Lazar requesting information on the artists and the spaces impacted by the filming, and Ms. Hallinan's replies that "Mike A. should turn them [the lottery slips] over", that "Mike told David [Campos] that he already submitted all the paperwork to the movie company for reimbursement for the 17 spaces", that street artist Cheryl Chen told Ms. Hallinan that "Mike A. took all of the slips"

and all of the paperwork ...", and that "Mike A. did NOT seek nor have permission" to "go on his own to the movie company bypassing the Art Commission and the Street Artists Program."

- (1-8) August 21, 2009 e-mailed letter from street artist Kathy Hallinan to Howard Lazar expressing her "displeasure at having my Social Security # transferred to a private street artist without my permission and then returned to me in an open envelope, unsealed. ..."; and Howard Lazar's August 24, 2009 e-mailed reply that "Michael Addario did not communicate with me his intention to take your lottery slips and give your social security numbers and addresses to the movie company. ..."
- 2) You request to be furnished with "copies of any and all evidence you may have that supports your claim that I allegedly '(3) publicly disclosing private street artist addresses and Social Security information without authorization". "Please see the enclosed copies of correspondence and notes referenced in the above items 1) (1-4), (1-5), (1-6), (1-7), and (1-8).
- 3) You request to be furnished with "copies of and and all correspondences to any and all commissioners, art commission staff and / or any and all city agencies that you received or wrote regarding Michael Addario' activities with the San Francisco Street Artists program in the last three years." Please find the enclosed copies of the following:
 - (3-1) March 5, 2007 letter by Bill and Bob Clark to Howard Lazar discussing City Attorney "rulings" made on "manual labor that they (Mike) were referring to ..."
 - (3-2) January 26, 2007 e-mail from Bob and Bill Clark to Michael Addario describing the "time and costs associated with establishing the program which some of the original artists had to pay ..."
 - (3-3) January 23, 2007 e-mail response from Madeline Marrow to January 22, 2007 e-mail statement by Michael Addario entitled "The 'Next to Zero' Street Artist's Cost Myth".

- (3-4) January 24, 2007 e-mail responses from Linda Pedersen and Linda Letts to Michael Addario e-mail statement "The 'Next to Zero' Street Artist's Cost Myth".
- (3-5) February 5, 2007 e-mail statement from Michael Addario to street artists, with attached photos of alleged unlicensed vendors, forwarded by Howard Lazar to Street Artists Committee as part of an item of the Committee's agenda of February 14, 2007.
- (3-6) February 14, 2007 e-mail letter from Kathleen Hallinan to Street Artists Committee regarding the Committee's "Hearing and possible motion to approve a letter by the Arts Commission to the Port Commission requesting legal enforcement against all unlicensed street vendors on Port property" and expressing appreciation for "the hard work Michael Addario has done on behalf of the street artists ..."
- (3-7) February 2, 2007 memorandum by Howard Lazar to Street Artists Committee, forwarding "copies of e-mails of various street artists expressing their observations of problems generated by the presence of unlicensed street vendors ..." including a January 1, 2007 e-mail statement by Michael Addario to street artists.
- (3-8) February 8, 2007 memorandum by Howard Lazar to Street Artists Committee, forwarding "copies of e-mail dialogue between street artists for and against our policy of waiving the fee for honorably discharged veterans who are unable to earn a living by manual labor," including a February 7, 2007 e-mail statement by Michael Addario discussing the cost to the Street Artists Program of waiving fees for veterans.
- (3-9) June 28, 2006 letter from Michael Addario to Mirian Saez, Port of San Francisco Deputy Director, Real Estate, "Re: Street Artists Query regarding Port's Sidewalk, Airspace, Curbspace Encroachment Policy".

The San Francisco Street Artists (SFSA) program was created by voter referendum (Proposition L) on June 4, 1974. The SFSA program' main function is to allow artists to sell their individual art directly to the public on the streets and public areas of San Francisco.

The SFSA program is comprised of approximately 400 members; some as young as 18 to a large contingent of senior citizens well into their 70's. The membership roster includes men, women, straight, gay and transgender. Artists from every country in the world, of all colors, shapes, sizes and political stripes make up this eclectic group. Although the SFSA program is a city program, it is unique that it does not receive any funds from the city of San Francisco. The SFSA program is funded entirely from SFSA membership licensing dues.

The SFSA program in under the authority of the San Francisco Arts Commission with Mr. Luis Cancel being the Director of Cultural Affairs, and unfortunately is structured that the members of the SFSA program are totally disenfranchised and lack any voting rights to directly steer their program, set policy, advance their agenda, set their budget or oversee SFSA staff- two civil servants – Mr. Howard Lazar and Ms. Evelyn Russell, that the artists are required to finance.

Moreover, most members are financial disadvantaged; some with compounding physical handicaps. One artist after having surgery to remove a tumor from his brain, is now deaf, and reads lips to communicate with fellow members and customers. Another member has been hearing impaired from birth. In addition we have ten disabled veterans in our group that the membership fully subsidizes their licensing. There is also a large Asian and Hispanic segment that has limited English language skills and survives by having fellow Street Artists translate rules, regulation and requirements for them. Some members are new immigrants to this country who were traumatized by repressive regimes and are hesitant and suspicious of any government authorities or their actions.

Although, SFSA members, on their own initiative and expense created two computer email trees; this means of communication only reaches approximately 30% of the members due to lack of some member's computer access. In spite of the personal hardships several artists face, many members take a keen interest in the SFSA program; its direction, and continual survival.

Michael Addario has been a member of the SFSA program for 6 years was recently elected to the SFSA Liaison Committee and at the initial SFSA Liaison meeting was elected to chair the committee.

Pervious Complaint filed against Arts Commission

Mr. Addario opposed the Arts Commission proposal to change the SFSA program committee meeting from monthly to bi-monthly (12 to 6 meeting a year). The structure of the SFSA program dictates that all changes to the SFSA rules and violations need to appear before this committee initially. The change from monthly to bi-monthly was brought before the Full Arts Commission without being heard at the SFSA committee level first.

Mr. Addario also discovered that the Arts Commissioners had held a seriatim (serial, non-public) meeting, via email between Arts commissioner and brought a SOFT complaint # 08024 against the Arts Commission. The Arts Commission argued that the Sunshine Ordinance Task Force lacked jurisdiction to adjudicate this complaint, but was overruled. Addario prevailed and the Arts Commission was determined to be in violation of SOFT statue 67.5.

The Task Force finds that the Commission violated Section 67.5 of the Sunshine Ordinance for holding a seriatim meeting at the committee level through the two committee members at a non-public meeting and without public input. The Commission shall appear before the Compliance and Amendments Committee on August 13, 2008, to further discuss the violation.

A.) Allegation # 1 against the Arts Commission Failure to hold a proper meeting open to the public Summary

The Arts Commission after holding an official election for a San Francisco Street Artist Liaison committee, validating the election and confirming the winners, changed the bylaws of said committee without the proper authority or holding a public meeting where the SFSA Liaison committee was first created at the SFSA program committee.

The Arts Commission staff met privately to form a new set of bylaws for the SFSA Liaison Committee without the input or discussion from the public, SFSA

members, or elected SFSA liaison Committee members. Subsequently, the Arts Commission again in private had their proposal that would change the liaison meeting from monthly to quarterly, have the date, time of the meeting and the agenda set by the program director, and the members of said committee once elected, serve at the pleasure of the Director of cultural affairs, rushed through and agenized at the Full Arts commission level before the elected members of the liaison could meet for the first time to create their own bylaws.

Upon being notified of the Arts Commission propose action Mr. Addario attended the Full Arts Commission meeting and under "Public Comment" informed the Commissioners that they were going against the spirit and intent of why the SFSA Liaison Committee was originally created. In addition to the reason Mr. Addario and the other members were originally elected for. Moreover, Mr. Addario caution the Full Arts Commission that this item should be heard first at the SFSA program committee level and was possibly a violation of the Sunshine Ordinance. The Full Arts Commission' chairperson PJ Johnson dismissed Mr. Addario' argument, saying that the Arts Commission staff conferred with the city attorney and found no conflict. In fact, PJ Johnson said if it were up to him, he would have "kept a tighter leash on the liaison committee." The motion to change the SFSA liaison Committee bylaws was passed unanimously by the Full Arts Commission.

Therefore, I request that the SOTF find the Arts Commission violated SEC. 67.5. or any other Sunshine Ordinance regulation that the SOTF finds applicable

Timeline of SFSA Liaison Committee creation

May 2008

The original SFSA liaison/steering committee was formed to allow a group of interested artists to lobby the Arts Commission for changes to the SFSA program that it felt were being ignored by SFSA staff. All SFSA members were notified at lottery space sign-ups that they were eligible to join this ad-hoc volunteer group. Mr. Addario along with four other members joined. The liaison committee members met monthly, approximately eight times, in additional to later in the year having two meetings with Mr. Cancel and Mr. Lazar.

At the first meeting the ad- hoc liaison committee had with Mr. Cancel, among other thing discussed, Mr. Cancel expressed a concern to know how the committee was "constituted" and how would he know if when he was speaking to this group that he was speaking to the majority of members of the San Francisco Street Artist Program. Mr. Cancel expressed a desire to make official, the now ad-hoc liaison committee with an official Arts Commission election.

At the second meeting the SFSA liaison /steering committee had with Mr. Cancel he put forth the proposal to have an official election for a SFSA liaison committee. He

asked for our recommendations. I caution Mr. Cancel that an official liaison committee would fall under the Sunshine Ordinance and I was concerned that the added costs to our program were costs that the program could ill afford. At the time Mr. Cancel said that he did not want that to happen and appeared to drop the idea. Only to have Mr. Cancel' reverse himself and his proposal reappear at the following SFSA program committee meeting. Following is the progression of meetings that have occurred to-date regarding this issue.

1.) The San Francisco Street Artist Program Committee.

March 11, 2009

Call for election of members to street artist "Steering Committee." Mr. Lazar requested that the next (May) agenda of the Street Artist Committee include a possible motion to have an election among the street artists for members to serve on the artists' ad hoc "Steering Committee."

2.) The San Francisco Street Artist Program Committee. July 8, 2009

"Mr. Cancel stated that the Liaison Committee would be a separate, independent, advisory body which would act as "a sounding board" on issues. Presently, whenever Mr. Lazar and he meet with the ad hoc committee, they have no assurance that its current members speak for a significant number of street artists. The proposal would provide for a committee elected by, and representing, the artists."

Below is an abbreviated form of the original election bylaws submitted for approved by the Arts Commissioners at the SFSA program committee meeting of July 8, 2009.

STREET ARTISTS ADVISORY STEERING COMMITTEE

ELECTION OF MEMBERS

Number of Members: 5 members

Term of Members: Two years provided that the terms of the three members receiving the highest vote in the first election shall be for a period of two years, and the terms of the remaining two members shall be for a period of one year; and upon the expiration of these and successive terms, the terms shall be for two years....

...Any vacancy during a term will be filled by appointment by the Director of Cultural Affairs and the concurrence of the Street Artists Committee, to serve during the vacant term until an election shall be held for the position during the following July.

Commissioner Calloway moved to recommend approval of the proposed election procedure for five (5) members of the Street Artists Liaison Committee; the motion was seconded by Commissioner Delaney and unanimously approved.

3.) The San Francisco Street Artist Program Committee. September 9, 2009

Presentation of ballot materials for election of Liaison Committee. Mr. Lazar presented drafts of documents created by Director of Cultural Affairs Cancel and Mr. Lazar relating to the upcoming voting procedure for the street artists' Liaison Committee. The drafts were of a candidates' sign-up sheet, an official ballot, and a ballot envelope.

4.) The San Francisco Street Artist Program Committee. November 4, 2009

Action. Counting of candidates' ballots for Street Artists Liaison Committee; motion to approve elected candidates.

In keeping with the procedure approved by the Arts Commission for an election of five (5) candidates to serve on the Street Artists Liaison Committee, ballots with return envelopes had been disseminated among all street artists attending space-assignment lotteries of the Wharf, Downtown, and Justin Herman Plaza areas for an election period of three (3) weeks, ending October 31, 2009. Two hundred twenty-eight sealed ballot envelopes had been received by the Program Director and

were now delivered to the Commissioners to open and tabulate at this, the November 4th, meeting of the Street Artists Committee.

The results of the election, among the ten candidates, were as follows:

Commissioner Melania moved to approve the following candidates (in ranking order) as members of the Street Artists Liaison Committee: Tad Sky, Cheryl Chen, Debra King, Michael Addario, Jimmy Sha; the motion was seconded by Commissioner Calloway and unanimously approved.

As Commissioners Haryati and Calloway had to leave, the Street Artists Committee lost its quorum. Commissioner Melania adjourned the meeting at 5:00 p.m.

Dear Members of the Liaison Committee,

At Mike's request, I have looked into reserving Suite 70 (25 Van Ness Avenue) for a meeting for you to be held on Wednesday, December 2nd, from 3:00-5:00 p.m. The room appears to be available.

I would like to hear from each of you that this is the date and time that you want. If so, I will reserve the room.

I will not be in the office for the next three days, and will pick up my phone messages and e-mail messages next Monday (November 23).

As seen below, unexpectedly Mr. Lazar sent the liaison members an email that said the date and room had been changed due to a scheduling issue with Mr. Cancel. At no time, prior to this email were the elected liaison committee member aware that we would be working around Mr. Cancel' schedule. In addition not one of the members were asked beforehand if this date or time was suitable for their schedule.

November 25, 2009

Dear Liaison Committee Members,

The meeting of your Liaison Committee will not be scheduled for December 2; it will be scheduled for Thursday, December 10th. The Arts Commission's Director of Cultural Affairs, Mr. Luis Cancel, will be attending the meeting on December 10th. Because of prior commitments, he is unable to attend a meeting scheduled for December 2nd.

Whereas the Arts Commission has determined that the Street Artist Liaison Committee's purpose is to make recommendations on behalf of the Street Artists to the Street Artists Program and the Arts Commission regarding Street Artist Program policies and procedures; and

Whereas the Arts Commission has determined that quarterly meetings would help the efficient and coherent gathering and presentation of such recommendations; and

Whereas the Arts Commission has discovered that the original resolution creating the Committee failed to address the tenure of Committee members; now therefore be it

RESOLVED, that resolution of July 8, 2009 and corresponding Election Procedures are hereby amended to add the following provisions as a new subsection (9):

The Street Artists Liaison Committee's purpose is to make recommendations on behalf of the Street Artists to the Street Artists Program and the Arts Commission regarding Street Artist Program policies and procedures. The Street Artists Liaison Committee shall function for a two-year period ending on July 31, 2011 and shall meet on a quarterly basis, starting with the meeting scheduled on December 9, 2009 with subsequent dates, times and agendas to be set by the Street Artists Program Director and the Director of Cultural Affairs, unless otherwise modified by the Arts Commission through a subsequent resolution. Members of the Liaison Committee, once elected, shall serve at the pleasure of the Director of Cultural Affairs.

In the Arts Commission' proposal submitted Dec 7, 2009 the Arts Commission falsely state that they discovered that the original resolution creating the Committee failed to address the tenure of Committee members.

As seen below, it is plainly evident in July 8, 2009 and again in Nov. 4, 2009 meeting of the San Francisco Street Artist Committee, tenure was discussed and approved. As this was the first election, the three top vote-getters would be serving for two-year terms, and the next two top vote-getters would be serving for one-year terms. Upon subsequent elections, all five top vote-getters would serve for two-year terms.

In addition and contrary to what Mr. Cancel stated previously that the SFSA Liaison "would be a separate, independent, advisory body" the Arts Commission was now proposing that meetings would be quarterly as opposed to monthly, that the dates, times and agendas to be set by the Street Artist Program Director and Director of Cultural Affairs...in addition to...Members of the Liaison Committee once elected, shall serve at the pleasure of the Director of Cultural Affairs.

Moreover, as you can see in the emails above, Mr. Lazar who had originally volunteered to be the secretary to the liaison committee and before Arts Commission proposal was even heard, changed the date of the initial SFSA liaison meeting, misstated the election results, when notified, delayed in acknowledging or correcting the results, and inserted an item into the liaison committee agenda: Discussion on cost and impact on the Street Artists Program of "immediate disclosure" (public records) requests. without the consultation or approval of the elected members.

Therefore I contend that:

- 1.) If changes were to be made they should have been at the very least, agenized and heard at the Street Artist program committee level where the liaison committee was first approved and prior to the election.
- 2.) If any changes were to be made in the bylaws once the election was completed that was now the authority of the duly elected liaison committee members.

Consequently, I assert that the Arts Commission purposefully, illegally and in bad faith, used subterfuge, misinformation and manipulations to eviscerate the SFSA liaison committee' authority by not having a public meeting at the San Francisco Street Artist program committee, thereby violated SEC. 67.5. MEETINGS TO BE OPEN AND PUBLIC; APPLICATION OF BROWN ACT, or any other Sunshine Ordinance regulation that the Sunshine Ordinance Task Force finds applicable.

B.) Allegation #2 against the Arts Commission Failure to provide Requested Documents in a timely manner or on a rolling basis.

On December 23, 2009 I received word that the "Immediate Disclosure Request" documents that I had requested on September 29, 2009 and as stated by Mr. Lazar in his Oct 2, 2009 letter to me "The Arts Commission will endeavor to respond to you as quickly as possible and no later than October 13, 2009." were available for pick up. This amounts to a delay of over three months or 69 days later than was promised by Mr. Lazar.

During that time period between Oct 13, 2009 and Dec. 23, 2009 I had asked Mr. Lazar at numerous meetings what was the status of the request. Mr. Lazar stated on Nov. 4, 2009 at the SFSA program committee to me that I would received the documents within a week and later on Nov. 23, 2009 at the SFSA office (where incidentally Ms. Russell was present and working with members) that I would have them in the following week. It was not until after I submitted the SOTF Complaint # 09085 that I received word on Dec. 23 that I would be able to pick up the documents.

At no time did Mr. Lazar express that he was have trouble fulfilling my request due to a staff shortage. In fact, the first time that I heard that Ms. Russell was out of the office for a month, was in the Dec. 23, 2009 Arts Commission response to this SOTF complaint. In their response they state: Mr. Lazar has – and still has – no staff to help him with the research and production of document in fulfilling such voluminous public documents requests, while still having to fulfill his other, primary, duties and responsibilities to over 400 street artist license holders; and (3) for the entire past month he had to also perform the duties of the Street Artist Program's licensing clerk, because the licensing clerk was out of the office on leave." Moreover, Mr. Lazar has presented no evidence to document that Ms. Russell was out of the office for a month, and no evidence to and from what time period. In addition, Mr. Lazar apparently had no difficulty leaving the office during this time prior to appear in a "YouTube" video, mainly featuring Mr. Lazar speaking about the SFSA program. Even if this staff shortage were so, it is not a legitimate excuse and certainly not one when I was repeatedly promised the paperwork by Mr. Lazar and only able to retrieve them once this SOTF complaint was filed.

Therefore I request that you find the Arts Commission in violation of 67.25 (a) and 67.5 (d) of the Sunshine Ordinance for failure to provide me the requested in a timely, or on a rolling basis, or any other Sunshine Ordinance regulation that the Sunshine Ordinance Task Force finds applicable, to insure that these violations of the Sunshine Ordinance by the Arts Commission are not repeated.
