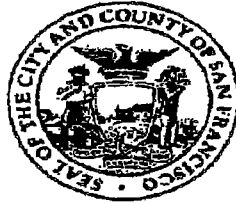

The local paid Reed \$500,000.00 for gender discrimination in 2008. This information is on the local's 2008 LM2 Report with the Dept. of Labor.

This is of great concern to me and many others, due to the fact that this Board of Supervisors voted for F.X. Crowley to be on any San Francisco City Commission, much less the President of S.F. P.U.C. I am interested in the process that allowed this individual that continues to discriminate against women was allowed to hold any political office in San Francisco.

Mayor Newsom's office was made aware of this issue when Crowley was being considered. Everyone that has been contacted in City Hall has ignored our calls for caution and truth. The hypocrisy of this Board mirrors the hypocrisy in Washington, D.C. The Mayor is another example of how S.F. Politics is fine with women being treated poorly, especially his relationship with one of his female staff members!

Theresa Sparks at the Human Rights Commission has sent me back to the Board to investigate Crowley and his actions against women.

Susannah Greason Robbins at the SF Film Commission pled ignorant of any problems with this local as did the leadership of the SF Labor Council. In fact, when I contacted Tim Paulson, Executive Director of the SF Labor Council, stated that he did not believe me and he would get back with me. It's been about a year and I have yet to hear back from Paulson. This is typical of San Francisco politics. Victoria Lewis and I have visited

your office and left messages with your office on several occasions and have yet to hear back from anyone.

However, Victoria Lewis and I visited your office this September and informed your office about the Dept. of Labor LM2 Report to one of your staff. The male staffer said that someone would followup with us but that has never happened.



Dear Mr. Rustom:

Thank you for your March 25, 2011 email notifying us of Sunshine Complaint #11018.

I take all requests for information from the public very seriously and want to be sure to provide you and the Task Force with the information you need to resolve this issue.

In fact it is only because of your email and notification that I first learned that there was an outstanding Sunshine request that our office had not yet provided a response to. After receiving your email, I reviewed our office procedures on correspondence and found that our volunteers had inadvertently failed to notify me or my legislative aides of the sunshine request. As a direct result, we have changed our office procedures so that all letters submitted to our office are also reviewed by my legislative aides who are trained on the requirements of the Sunshine Ordinance. Additionally, we will also provide training to our volunteers on how to flag requests for information from the public. Our goal is to make sure we can avoid these miscommunications in the future.

Your notice has also provided my office with the opportunity to respond to the request for information. Specifically, our office does not have any documents to provide in response to Items 1-4 of the request including: (1) City Labor Agreements and Side Letters with Local 16 & F.X. Crowley, (2) Hiring Lists with Local 16 & F.X. Crowley, (3) Crew Lists with Local 16 & F.X. Crowley or (4) Permits with Local 16 & F.X. Crowley. The Department of Human Resources, instead, would be the appropriate organization to request the most current labor agreements. Our office also does not have any documents to provide in response to Item 5 which is a request for information on campaign contributions from Local 16 & FX Crowley to the Board of Supervisors. For information on campaign contributions, the Ethics Commission and their online database would be appropriate sources because they maintain public records on campaign contributions as required by law.

I thank you again for the opportunity to respond because prior to your email, I was not aware of the request for documents. I also want to thank you for the opportunity to review and improve our office processes.
