

To Whom It May Concern:

This letter is in response to a complaint dated March 15, 2011 submitted to the Sunshine Ordinance Task Force regarding Tides Center by Debra Benedict. Notice for the Tides Center March 30th board meeting was mailed to the Clerk of the Board of Supervisors and the Government Information Center, although the notice was mailed late, on March 1, 2011. Actually it is the Nonprofit Public Access Ordinance that applies, not the Sunshine Ordinance. The applicable Ordinance requires that two public meetings be noticed and held each year. Tides Center properly noticed two public meetings within the past year. As the remaining the 2011 board meetings have not yet been scheduled, Tides Center cannot be in violation of the notice provisions for 2011. The applicable Ordinance does not specify that board meetings be held in San Francisco.
