Dear Executive Director Robbins:

There have been many attempts over the last few years by several members of I.A.T.S.E., Local 16 to investigate the Local's actions against women specifically. The most recent legal action against Local 16 was filed by Matt Gonzalez in California State Court in Sandy Reed v I.A.T.S.E., Local 16. The local paid Reed \$500,000.00 for gender discrimination in 2008. This information is on the local's 2008 LM2 Report with the Dept. of Labor.

This is of great concern to me and many others, due to the fact that the San Francisco Film Commission is well aware of the discriminatory practices by F.X. Crowley and Local 16. Lorrae Rominger is aware of this local's history.

Mayor Newsom's office was made aware of this issue when Crowley was being considered. Everyone that has been contacted in City Hall has ignored our calls for caution and truth. The hypocrisy of this Commission mirrors the hypocrisy in Washington, D.C. The Mayor is another example of how S.F. Politics is fine with women being treated poorly, especially his relationship with one of his female staff members!

Theresa Sparks at the Human Rights Commission has sent me back to the Board to investigate Crowley and his actions against women.

During our phone conversation in October, you pled ignorant of any problems with this local as did the leadership of the SF Labor Council. In fact, when I contacted Tim Paulson, Executive Director of the SF Labor Council, stated that he did not believe me and he would get back with me. It's been about a year and I have yet to hear back from Paulson. This is typical of San Francisco politics. Victoria Lewis and I have visited the film office with P.J. Johnston covering up for his friend, F.X. Crowley.

If gender discrimination is illegal, why do the politicians ignore the situation? Money?

If you need more proof of their hostile actions, call Investigator Michael Ng at the Dept. of Labor at (415) 625-2666. He is working on my case in which Crowley, the local and their attorneys have denied me my rights in viewing the Bargaining Agreements for productions and have libeled me in letters to Ng. This has been going on for years and Ng informed me today that he has sent the case to D.C. for a hearing.

Remember in June 2010, Angela Alioto was quoted in the paper about a gender discrimination lawsuit for her niece against Lucas Films when she stated that look what a woman standing up for her rights has to go through. Well, I'm here to tell you it is unjust and unfair that men can continue discriminating against women and others when one has all the ears for listening and the other has no one because they are not powerful or can help someone climb the political ladder. The coverup is enormous.


Therefore, I am requesting under the Sunshine Ordinance: Chapter 67 of the Administrative Code for the following information regarding Local 16 and any business dealing with F.X. Crowley for the past five years:

1. All City Labor Agreements and Side Letters w/Local 16 & F.X. Crowley
2. All Hiring Lists w/Local 16 & F.X. Crowley
3. All Crew Lists w/Local 16 & F.X. Crowley
4. All Permits w/Local 16 & F.X. Crowley
5. All campaign contributions from Local 16 & F.X. Crowley
6. All names of film, t.v., stage and commercial productions that have already shot or will be shooting in Local 16's jurisdiction

I would appreciate acknowledgement in receipt of this letter. I am looking forward to hearing from you asap. I am also requesting a meeting with you and others to stop the discrimination practices in the film industry that is widely known.

Dear Task Force Members:

The San Francisco Film Commission (the "Commission") is submitting this response to Complaint #11020, which was submitted on March 11, 2011 and received by the Commission on March 29, 2011. The following is a preliminary response from the Commission summarizing the Commission's compliance with the Sunshine Ordinance and its position that although the Task Force may have jurisdiction over this complaint, Complaint #11020 is without merit. In the event that there is a hearing on this matter, the Commission reserves the right to provide a more detailed response in advance of the hearing.

In complaint #11020 Ms Laughton alleges a "Failure to provide information on TV/film production," the Commission's "failure to provide all requested information" and that the Commission was "not truthful about not knowing what shows are unionized."

We do not understand the basis of her complaint because the Film Commission provided the responsive records.

Item #1 of the Complaint is without merit

"Failure to provide information on TV/film production"

Ms. Laughton's complaint under item one is without merit. In her request dated December 28, 2011 she asked for "all names of film, t.v., stage and commercial productions that have already shot or will be shooting in Local 16's jurisdiction." In response the Commission provided Ms Laughton with the titles of all TV series', documentaries, movies of the week, student projects, television commercials, TV pilots, and educational productions permitted by the Film office 1/1/2007 through 12/31/2010. We had no further responsive records.


