constant ringing in my ears, tinnitus. For the first time in my life, I feel threatened each and
every day that they will kill me, I have never felt this ever. Hello Honorable Chief of Police
George Gascon, San Francisco, CA, There has been the strangest series of unfortunate events in
my life. This is all with a home owner association at 720 York Street, San Francisco, CA 94110,
Bryant Square Lofts. All of these events were really for a piece of paper, that Deborah Davids
had to fill out, but instead she lied to the Attorney General, and then takes revenge, covertly, so
only I can see, but at times, I have witnesses to the crimes against me. I tell my story because I
nearly died because of the technology used against me, and at this point, she already destroyed
my body, and who knows what else she, and they, will do, but at least my story, or at least parts
of it will be told. Hopefully, they will be held accountable for nearly killing me, and taking my
life and privacy away from me. I do not believe in revenge, war, or retaliation, but I do believe in

(I found on the internet), works for the Mission Street police station in San Francisco. Espionage,
stalking, spying for nearly 2 years. June 2008 -Started to get strange prank calls, with phone
numbers 000-000-0000 or 999-999-9999 My phones have echos and hang up while on the
phone, my phones, cell and home phones are tapped without a warrant out of revenge. July and
August 2008-I would request contact information, many times, information from the president of
the HOA, she never responded. July 2008-I sent for a Notice of Complaint to the CA Attorney
General Complaint ID#230697. August 5, 2008-Deborah Davids, president of HOA, 720 York

Street, San Francisco, CA 94110 (Unit #226, she finally gave me after I emailed the HOA attorney) We both received the Notice of Complaint from the Attorney General, requesting her contact information. August 7, 2008-Stalked by two men, I have detailed story, covert warfare, both in undercover police car, my husband is witness to them driving around while riding his bike to work. I had realized that Michelle Beazley, the property manager, her husband Sergeant Raymond Beazley, from the Mission Street police station, Deborah Davids and Peter Davids conspired to send stalkers into a privately owned building, and gave them access to stalk me. After realizing I was stalked, I researched, and found that this technique was used by the KKK to harass, stalk, intimidate the Black Panthers. People who stalk do it for revenge. They are psychologically very unstable. August 16, 2008-I walked into the lobby to get my mail, and an entire group of people, including Michelle Beazley, was in the lobby. The meeting was in lobby with HOA board and owners, we were not invited, and I emailed to get the minutes and president and property manager denied it ever existed. This is illegal in a homeowner association. August 21, 2008-Response letter back from Attorney General for the state of California, and Deborah Davids gives a very strange answer, much like a lie, in a round about way. PIU #230697

September 8, 2008-I emailed the HOA attorney to tell her about stalking and prank calls, and electronic harassment, phones and fax stopped, internet interference, interference on my cell phone, and home phones. August 19, 2008-Second stalker came back in a black dodge truck, but I did not get the license. This stalker is the one who has gray hair, and gray mustache, and I have reason to believe this man/stalker, is Sergeant Raymond Beazley. August 21, 2008-Deborah Davids, president of HOA starts to stalk me. Strange text messages, harassing phone calls from strangers. I was visiting neighbors and after I left unit #112, visiting the Kenneth Fang, I received a text messaging saying something like this, "Visiting neighbors are you". I did not save this text nor did I take a photo as it made my skin crawl to say the least. August 27, 2008-I write to the SF DA and Mayor asking for a meeting, no meetings. August 31, 2008-Went to Mission Street police to report stalking, but was denied to report. September 22, 2008-Filed police report on gang stalking, (this is after I sent a police report via on-line) Police Report #081008560.

September 25, 2008-I started to send stalking incident to everyone in the building, and neighborhood, posted all over the building and neighborhood titled "Neighborhood Alert". September 29, 2008-Deborah Davids and Michelle Beazley sent me a note stating not to send owners any letters, and to clean the tape residue off of the windows. October 5-20, 2008-Went away for two weeks. October 24, 2008-Sent in for copy of police report #081008560 I had to request from the city Mayor, and Board of Supervisors copies of my police reports, otherwise, the reports were refused. October 2008-This is when I noticed my home phone had echos, and hang up when I would use the home phone. I can tell when others are on the line by the strange sound, echo, that had never been there before. November 4, 2008-I had three officers come over after I saw Deborah Davids and Michelle Beazley at my window looking at me like they were going to kill me. My Father was my witness to the conversation. I told them the gang stalking incident, and that I knew Sergeant Raymond Beazley was involved in conspiring with his wife and Deborah Davids to send stalker to me. The officers called in another Sergeant, and they threatened me, and said they would sue me for slander. I told them I was going to see an inspector at 850 Bryant Street. I was right about being afraid and fearing for my life, as I have nearly died three times from directed energy weapons. Hospitalized twice. Police Report #081180497. The blonde female officer gave me a pep talk after I told her I chased the stalker in the Black Dodge truck, who I believe is Sergeant Raymond Beazley. November 5, 2008-My husband and I went to 850 Bryant to see an inspector, and he was bald, and said my case was

lost. He gave me a yellow note with Officer Dunn's number. November 6, 2008-I called officer Dunn, and it said it was the psychology department. I realized they were trying to criminalize me for their crimes. Side Note-Officer Kelly Dunn works for the Psychiatric Liason Unit, psychiatric technician, 6 years with SFPD, education is a psychiatric technician at Napa State Hospital; Mt. Zion Crisis Clinic; San Francisco General Hospital; UC San Francisco ER and Langely Porter; Mobile Crisis Unit, San Francisco and Oakland.

She is not a doctor of any kind, and does she have a college degree in psychology? November (after this date above) 2008-I saw a man, in the middle of the night, who had the silhouette of the second stalker at my building, pointing a red light that shined on me in the window (window inside the courtyard where he had to have been given access into the building), and energy hit my body. I started to get violently ill, and researched and realized a directed energy weapon was used on me. I know what this person looks like, as he is a police officer at the Mission Street police station. He should be held accountable for his crimes against me, using a microwave weapon in the privacy of my own home. I have strong reason to believe this man is Sergeant Raymond Beazley. This man has been consistently stalking me for nearly two years. November 2008-We put our condo up for sale. Deborah Davids stalks me. I go down to the ACCESS center, and try to file a restraining order against her, but after having a conversation, I realize she would get more angered, and feared what she would do, so I decided against this method. February 13, 2009-Peet's coffee, Burlingame, (this is where I met my friend). I sit next to a large man, trench coat, and he pulls out his computer, with a photo of Bush with cross bones, and proceeds to talk with me, and says the word LOVE all the time, a word that I use, which I thought was interesting, then he tells me he went to the same university as me, which is strange, I have never met this guy, and I never told him where I went to school. He looks at me to tell me how angered he is about class action lawsuits, which is strange, then I give him the Organized Stalking booklet, and he leaves. I look on Jones Day Law firm to see his face, and I do, Robert Marshall, partner,rgmarshall@jonesday.com, 415-875-5720, in San Francisco office, <http://www.jonesday.com/rgmarshall/> He works with Peter Davids, the president of my home owner association's husband. This confirms for me, that they are in on this organized crime, and are harming me. I have strong reason to believe this man is involved in serious crimes against humanity, and has access to technology. Electronic Harassment, Electronic Assault. www.angelfire.com/or/mctrl/akewi.html is an illegal human experiment, that many US citizens, and human beings around the globe are experiencing. This man may has access to the worlds most powerful technology, the Star Wars Weapons, and/or is part of the gang/organized stalking. I made a comment to this man about how money cannot buy everything, and he said "Oh yes it can". He also asked me out of the blue why I was so calm for someone who is going through so much, and I thought this was a very strange comment, since I never told this man anything about me. How could he possibly know what I am going through if I had never met him, never knew him, and never told him anything about myself, ever? February 15, 2009-I sent a note to Kevin Ward, board member, telling him that there is a person in the building who is stalking me. February 18, 2009-I believe this was the day, I was hit very hard with directed energy weapons, and I nearly died, all of my organs burned, and my eyes blurred, and hearing loss. I did not realize where this was coming from, but I was with a group called www.freedomfchs.com, and started being on Yahoo groups for support. I emailed all my friends to tell them I love them because I thought for sure, I was going to die. The day that this happened, I went to the front

window at 720 York Street, #111 San Francisco, CA 94110, and noticed Deborah Davids, was at my window, while the directed energy hit my entire body. I opened the window, and said that we could get along, and live in the same building. I looked directly at her, and she said to me "I am not doing anything wrong to you Christine", which I thought was a strange statement, as I never asked her if she was doing anything wrong. February 18, 2009, Started all the electromagnetic radiation. There is a constant source of electromagnetic radiation on me 24/7, daily. It is done through the "Frey Effect" and Remote Neural Monitoring. There is a constant source of systematic organized stalking, electronic harassment, and directed energy weapons. The electromagnetic radiation stopped in July, 2009, when Jan Schakowsky and Leon Panetta said they were going to investigate a covert operation in the United States. The organized stalking, wire tap of phone lines, prank phone calls, etc. still exist. February 19, 2009-I went to visit Misha, who deals with police brutality, and she noticed I was not well. She put me in touch with a reporter Marlon Crump, who supported me through this ordeal. February 23, 2009-I went to the ER, as my condition was getting worse. I could not breathe well, and my body burned inside so bad, my feet had welts on them, my eyes blurred vision, and hearing loss. I have both an eye exam showing lens damage, and an hearing exam showing hearing loss, high pitched sounds and loss in right ear. February 25, 2009-I sent the board a letter requesting mediation, or seminars to have reconciliation. They write back and deny anything is wrong, and will not meet with me, and send the VP of HOA, Phil Bryan. February 26, 2009-I was with my friend, reporter Marlon Crump, and we were at Peet's coffee, off of Brannon Street, I had just went into my trunk to get a copy of the organized stalking booklet, for Marlon, we had coffee, I dropped him off at home, went to pick up my friend Lee, and we noticed all the booklets were stolen, I have a receipt. Police Report #090208543. March 13, 2009-My car was towed illegally for revenge, the citation and tow are not the same address Invoice #468599. March 20, 2009-I email a friend to tell her a story of someone like me, and she emails me back to tell me that she was working by my building, and she too was hit with what she called electromagnetic pulse. She is a witness to this event in some way. March 2009-Reporter writes article called Electronic Harassment www.poormagazine.org by Marlon Crump. March 31, 2009-Meeting with Phil Bryan, VP of HOA at 3:00 P.M., Starbucks on Mariposa, SF, CA.. This day, I have harassing phone calls from people who pretend to be with AT & T, and a stalker who claimed to be with AT & T, who left a note on my door. AT & T, are always professional with real legal notes, not scratch paper. April 2009-Somewhere around here, two tow trucks were going to tow my car again for revenge for getting a police report, I have the tow truck on video questioning him. I stopped them from towing my car. Yellow Tow Truck, SideLine Towing, San Francisco, CA, Truck #6011, license plate 7E17077, driver is hispanic. <http://www.youtube.com/watch?v=i5-f2uYWNQM> April 12, 2009-I was coming back from Boston, MA, to San Francisco, on United, Flight #181 (gate C17 in Boston), departing at 2:39 P.M. section 3 seating, confirmation #NBR JG9NLW. While I was watching a film, my head started to hurt, and I never get headaches, until all of this psychotronics, and electromagnetic radiation started. I realized that whoever was doing this was trying to use V2K on the plane. I looked up during the film, and saw a tall caucasian in a button down shirt, with pants on was staring at me intently to see if how I was reacting, and he was seated at 7C. April 15, 2009-I talk with the groups psychologist Cyndie in PA, as she deals with trauma patients, and victims of organized stalking, directed energy weapons, and psychotronic weapons. April 24, 2009-Wrote city attorney to get refund back on tow. City attorney gives refund. April 2009, I had a day when I was meeting with Phil Bryan and my mediator for our HOA Bryant Square Lofts, at Starbucks, Mariposa, and Deborah Davids and Michelle Beazley

refused to meet, because they are guilty. About 10 police officers showed up at Starbucks to surround us while we had our meeting. Thank goodness we had the meeting room, as to not be harassed. Phil Bryan told us, Misha and I, that Deborah Davids was very angry that she received the Notice of Complaint from the Attorney General of CA, for not complying with the law. April 2009-Stalker were video taping Richard, Greg, and me, while we were having coffee at Peet's Coffee, by Safeway 16th/Bryant, shopping center, license plate number 7R35161, black Chevrolet Truck, that has a rim around the license with Oakland stated at the top, and Chevrolet at the bottom. May 15, 2009-10:00 A.M. in the morning, I was with very hard in the heart with directed energy weapons again, almost died. Went to the ER, this time, no IV, no pain medication, no oxygen. During these months, I have also experienced what is called psychotronic weapons as well. I have strong reason to believe my phone conversations are no longer private. I have strong reason to believe the day my car was towed they GPS and bugged my car. June 16, 2009, Today, I was in China town with a friend, and when I went to get into my car a DVD was by my door, that said the word "Murder" on it, not sure if this was directed at me, but it was strange. Date: Thursday, October 1, 2009, 8:23 AM Hello Honorable Board of Supervisors, I have strong reason to believe that Sergeant Raymond Beazley, one of my perpetrators was stalking me today on his motorcycle police bike, in his uniform, as he came behind my car today around 1:30 P.M. today while I was at Rainbow Grocery yesterday about 12:30 P.M.. He looked like the same person, on a motorcycle, who was stalking me in Walnut Creek several weeks ago. He has gray hair, and a mustache, and over weight. If this is not Sergeant Raymond Beazley, then maybe it is the second stalker who stalked me at 720 York Street, San Francisco, CA. 94110, and who used a hand held laser microwave weapon on me in my own home, November 2008. I do not know what Sergeant Raymond Beazley looks like, but I can recognize this person stalking me. October 2009-While seeing a doctor in Walnut Creek, I believe Sergeant Raymond Beazley, gray curly hair, with mustache, the same man who stalked me at 720 York Street, San Francisco, CA 94110, the same man who stalked me on a police motor cycle when I was trying to find parking to shop at Rainbow Grocery, was stalking me again, not in uniform, but on a brown and tan large motorcycle on a main street in Walnut Creek, and he was on my left side, my drivers side of the car, right next to me. We are going west on Ygnacio Valley Road, Walnut Creek. I have to check my records to see what month this may have been. I did not write the exact day or month of this incident. At this point, I was hoping this would all go away, and the stalking would stop. August to October, I believe, I would have to look at my records, this is when I was going to Walnut Creek, CA, for doctors visits. October 1, 2009, I finally file paperwork with the Office of Citizens Complaints regarding being stalked by two under cover police officers, Sergeant Raymond Beazley conspired with his wife, and president of home owner association. I emailed the OCC, faxed the OCC, and sent via certified mail OCC my dated incidents of all my perpetrators. Today, I called to check in because I was stalked again yesterday by either Sergeant Raymond Beazley or one of his stalkers, and I recognized the face, but I do not know what Sergeant Raymond Beazley looks like. I actually have a case number, and an investigator on my case, so you all know. CASE NUMBER, 0780-09 and senior investigator Dennis Maxson is covering my case. I spoke with Officer Torres today at 2:05 P.M. at 415-241-7711. October 6,

2009, I checked my voice mail at 415-235-6466 c, today about 2:00 P.M. Officer Barcina (spelling) left two messages for October 5, 2009, regarding my email, and complaints to the OCC, Officer Barcina can be reached at 415-553-1141. I called twice today, the first time I left a voice mail message. The second time I called today and a woman passed me along, again, to the psychology unit. I hung up and called again, and, again, she passed me a long to the psychology unit, and I told her this is not what is needed from SFPD. October 15, 2009, a letter from the OCC, SFPD, Case No. 0780-09, states this is "out of OCC jurisdiction", and that my "complaint is of "Informational Only", from Joyce M. Hicks, Executive Director. October 13, 2009- I receive a letter from the FBI, Washington, DC, saying I cannot get a FOIA to see if the Davids put me on the Main Core List. October 14, 2009-Global Protest, San Francisco, CA

I believe he has access to the satellite directed energy weapons. I have had two calls this week from the "Navy", out of the blue, after an email with another person on our groups who happens to know this Tim W. Anderson. March 4, 2010, 415-434-0193 man called and said he was with Navy. 650-603-9658-called March 8, 2010. March 9, 2010- Today, a man knocked at the door, and got into a private, security, surveillance building. He was a African American man, man of color, about 6'1", from the Navy, with Navy brochures. At 1:20 P.M. He knocked at my door, and would not leave the building. He drove away in an American dark blue car. This is covert stalking, covert war, and harassment. I asked him to leave the building, many times, and he took his sweet time leaving, a private building with security. I have a photograph, and video of this man entering into our building. March 29, 2010-Police Report #100307544 7:12:52 PM Monday Text I received on my Sprint BlackBerry (415-235-6466) From phone number 510-409-9908 "Yeah, everyone, keep yourself clean. Nothing they can use against you. Their MO is to arrest some dumb group of people and then go after the real target who is usually someone who has a following, gets attention and is usually outspoken. Since they monitor everything, they just keep u on the list." I received this text message after I spoke on Dr. John Hall's show, The Control Factor. April 3, 2010-12:53 P.M. I was on my way home, and Sergeant Raymond Beazley was on a police motor cycle with a yellow rain coat stalking me, and the bald Sergeant Police Officer who was at my home threatening me for slander was also stalking me at Clay and Mason, San Francisco, CA. This stalking occurred right after I file for a police report on April 2, 2010, for the harassing, threatening text message I received. April 8, 2010-Organized stalker, Nathan Ny, Staff Sergeant Recruiter, Marines, Nathan.ny@marines.usme.mil, cell 408-422-0637, stopped by my home to "recruit" me. I emailed him once to let him know he is not welcomed to contact me in anyway. He emailed me back saying it was his job, and I emailed him back (copying public officials) to never contact me, and that any form of him or the military contacting me will be viewed as harassment, and stalking. April 21, 2010-I received a letter from SPFD, from F. Luo, stating that police report #100307544

was not on file to be able to give me a police report. However, they were able to send me my police report request form that I filled out, and send it back to me with my envelope, but "lost", the rest of the important information, and documents. April 29, 2010-I received two phone calls today, from Officer Navaro, 9:50 A.M. and 10:53 A.M. regarding my many request for my police report regarding the text message that was sent to my Blackberry cell phone, March 29, 2010, 7:12:52 P.M., from phone number 510-409-9908, stating this... "Yeah, everyone, keep yourself clean. Nothing they can use against you. Their MO is to arrest some dumb group of people and then go after the real target who is usually outspoken. Since they monitor everything, they just keep u on the list." I have a photograph of the text message, the one I forwarded to another victim Richard Centeno. On the first call from Officer Navaro, I called him back, and he wanted me to give a statement over the phone. I have gave my statement directly at the police commissioner meeting. I have given a statement via fax, email, mail to every department at the San Francisco Police Department. I find all of this one big circus act since an officer, Sergeant Raymond Beazley, his wife Michelle Beazley, Peter Davids, a lawyer with Jones Day Law Firm, his wife Deborah Davids, president of my old home owner association 720 York Street #226, San Francisco, CA 94110, are all involved in conspiring to harm me, and murder me. Police officers are supposed to protect and serve, not stalk, microwave, and terrorize people who their wives disagree with, so very silly. May 1, 2010-SFPD calls the house phone (415-861-1041) at 3:12 P.M. and does not leave a message. May 5, 2010-I gave a public, live TV, recorded statement about the harassing/threatening text message I received, in front of the Chief of Police George Gascon, and the police commissioners at the 5:30 P.M. police commissioners meeting and about how it has been a month and I am not able to receive my police report from anyone at SFPD. May 11, 2010-I spoke with Officer James Ramsey San Francisco Police Department Special Investigations, from 2:15 P.M. to 4:00 P.M. regarding my dated incidents. He said that SFPD was recording our conversation. He kept offering to have me speak with Officer Dunn, Psychology, but I said this is not going to help me. Trust is not something I have for SFPD, as they are not on my side nor are they my advocate. He said that Sergeant Raymond Beazley is very upset. The San Francisco Police Department has done nothing but protect the criminals. May 21, 2010- Today I was driving on Harrison Street about 12:10 PM a police man, white with gray mustache fat was on a police motorcycle driving next to me at Harrison and Division. His plate number was 294. Please, this same person who I have strong reason to believe is sergeant Raymond Beazley, needs to stay far away from me. He needs to stop stalking me. He stalks me each time I get s police report on the four perpetrators including himself. It is against California state law to stalk. This is my old property managers husband at 720 York Street SF CA 94110 SFPD is not helping me. This same man has consistently stalked me for nearly two years. He has stalked me in Walnut Creek, CA in the fall of 2009 on Mt. Diablo Blvd while going west in the afternoon on his brown and tan motorcycle. This means that my car has a GPS system that they put on my car when they towed my car in 2009. This stalking occurred after I received a copy of the police report which took me a month and a half to get from sure determination. This is how I know that the Beazley's and Davids are involved, as it would not be so difficult to get police reports if they were not involved. October 1, 2010, I received a covert harassment, very unnecessary letter from Claude Wang, Manager, at the US Postal Service 1300, Evan Avenue, San Francisco, CA 94124, requesting that I use the proper address when mailing. I always do this, as I always print labels when I address people, all people. I have been mailing letters my entire life, I am 46 1/2 years of age, and all of a sudden I get a "notice" from them. I suspect that this person, Claude Wang, is part of these crimes, organized stalking. I sent him a letter, and

copied the letter by mail, fax, and email, to many public figures, and this letter is asking for his cooperation in giving us the hate, revenge "List". October 27, 2010, I met Doug Millar and Peter, and Michelle, downstairs in the basement of City Hall. October 29, 2010, 9:30 A.M., Call to Sheriff's Department Regarding: Raj Naicker stalking me and saying I was on this list to be raped. Doug Millar and Peter questioned him. 415-554-7251 Katie answered the phone, and said that her supervisor would contact me. January 12, 2011, Raz, or Raj Naicker, this person who looks like he descends from India, has stalked me consistently at many police commissioner meetings. He seems to work for Officer James Ramsey who is in special investigations, and the electronic crimes task force. They have tried to deter me from exposing the crimes against me and my perpetrators. In this video, Raz, Raj, says several times, that THEY are going to get, hurt, me and my family. Officer Dunn is a psychiatric technician for SFPD. February 23, 2011, at 9:14 AM, a person claiming to be Genevieve Morgan called from 808-538-9011, and left a message on my cell phone 415-235-6466. I googled this number and found that it was the The Queen's Medical Center in Hawaii. This number belongs to the psychiatric unit of the hospital. March 3, 2011, I attended a Board of Supervisors Public Safety meeting at 10:30 AM. A middle aged Asian man was sitting in the very back row during the meeting. After I spoke and left the room, he followed me out and said he knows Officer Kelly Dunn as well. He said he was a whistle blower at San Francisco General Hospital, and that they are now after him. He asked for my cell phone number so I gave it to him, and he left a message on my cell phone today, a few hours after the meeting at 3:32 PM. His phone number is 415-990-5184. He claims his name is Douglas Yep. I googled his name and found he works for San Francisco General Hospital, and Laguna Honda Hospital. On Monday, March 14, 2011, at 7:21 PM, I received a voice mail message on my cell phone number, again, from Raj Naicker. He called from phone number 415-756-8513. Raj says "They can kill your family, they can kill your family". This call comes the day Michelle Beazley received her federal lawsuit from me, from Federal Express, Summons To Waiver Service. This report was on several prank phone calls that she received. Police officers do not call victims of prank phone calls, as they do not have time for this kind of work. Doug Millar and I, Christine Harris, were attending the San Francisco Police Commission meeting tonight, and as we started to walk into the main room at city hall, "Raj Naicker" the person who continues to stalk me was there again, even after our run in with him at the same location, October 27, 2010, 5:15 P.M.

"Raj Naicker" has been stalking me at many police commissioner meetings. We had many Sheriff's Deputies surround him the evening of October 27, 2010. I have repeatedly asked him to stop stalking me, and I have not only called, but also written SF Police Officer James Ramsey, who referred my stalker to me, and to have this monster stop stalking me, but he continues to keep stalking me.

When Doug Millar, met with San Francisco Police Commander Dan Mahoney tonight, he informed Mahoney that he was going to go back into the meeting and do a citizen's arrest on "Raj Naicker", Mahoney said "no you are not." Millar said "Yes I am." They argued back and forth, and Mahoney said, "You are not going to touch him in there." He said "I do not need to touch him."

Millar said "Wait a minute, I organized the Anchorage, Alaska Support Your Local Police Committee, and I studied two years to become an FBI agent while in college. So don't try to tell me he is not working for you!" He asked Millar some questions, and Millar said "Christine is here, she should answer that question."

SFPD Commander Mahoney had one star on his collar, but the commander who was questioning Christine had three stars on his collar. Christine did not get the Commander's name, but Christine was told by him to get a restraining order on "Raj Naicker".

1 3. **Statement of Facts and Claims**

2 Plaintiff, in pro se, Christine Lynn Harris is the moving party to this civil action against
3 above said parties, the City and County of San Francisco, Bryant Square Lofts Homeowner
4 Association (HOA), Sergeant Raymond Beazley of the San Francisco Police Department #2073,
5 Michelle Beazley, Deborah Davids, and Peter Davids. Plaintiff, in pro se, Christine Lynn Harris
6 accuses the above said defendants of engaging in the following criminal activities, which have
7 resulted in serious physical irreparable damage to her vital body organs, her emotional
8 wellbeing, and her safety. Christine Harris requests to file this lawsuit as a means of ceasing all
9 crimes against her and to seek all payment of damages incurred due to both physical assault and
10 emotional distress. Christine Harris has sought legal counsel but has been denied at all times.
11 Christine Harris has sought help from multiple city, state, federal, and world authorities but to no
12 avail. Christine Harris' life has been destroyed and ruined. Before these crimes started, and her
13 body destroyed, Christine Harris used to run, bike, swim, hike, and lift weights. Christine Harris
14 was planning on having children, but her body and her organs have been destroyed. Breathing is
15 painful and very difficult. Christine Harris has been in constant pain and suffering for over two
16 and a half years, and it still persists today. Christine Harris has chosen to try to heal her body
17 from the damage instead of waiting to decay and die. These crimes are inhumane and torturous.

18 Plaintiff, in pro se, Christine Lynn Harris was a condominium property owner at Bryant
19 Square Lofts, located at 720 York Street #111, San Francisco, CA 94110. Christine Harris
20 resided at this location with her husband, James Jacobs, from September 2003 to May 2009. The
21 first time Christine Harris met Michelle Beazley, the property manager for Bryant Square Lofts,
22 Michelle Beazley was very abrasive towards her. Christine Harris presented Michelle Beazley a
23 small gift to build rapport with the relationship. This appeared to sooth tensions that were
24 exhibited by Michelle Beazley upon their first meeting. This first meeting occurred shortly after
25 Michelle Beazley had been hired by the Board of Directors at Bryant Square Lofts. Soon after
26 Christine Harris's husband, James Jacobs, became a board member of Bryant Square Lofts. It
27 seemed as though Michelle Beazley was providing satisfactory services at the time to the Bryant
28

1 Square Lofts Homeowner Association.

2 At some point in 2006, Christine Harris noticed, as well as other property owners in the
3 building, that Michelle Beazley was becoming aggressively authoritative to many of the property
4 owners. Michelle Beazley was having issues with a property owner at Base Studios, unit #102
5 (BJ Heinley, property owner, howdy@heinley.com). This became very apparent when the
6 president of the HOA, Patrick Everett, had to rewrite and proof read Michelle Beazley's
7 correspondence so that her message did not appear abusive.

8 Christine Harris discovered a statement within the Covenants, Codes & Restriction's (CC
9 & R's) regarding the responsibility of a property manager. The statement referenced that it is not
10 the property manager's duty to be an authoritative figure in the building but a person of service
11 to all owners. In the CC & R's for Bryant Square Lofts, page 23, Section 5.2 Powers, Section C,
12 Manager, states "Notwithstanding, the above, no manager or officer may be delegated the power
13 or authority to levy fines, hold hearings or impose discipline, make capital expenditures, file suit,
14 record a claim of lien, or foreclose for failure to pay assessments." Christine Harris emailed a
15 copy of this CC & R's section to Michelle Beazley to remind her of her responsibilities.

16 On Monday, February 26, 2007 at 10:18 AM, Michelle Beazley responded to the email
17 asking why this was sent to her. Christine Harris responded back by explaining that it was not
18 within the responsibilities of Michelle Beazley to be an aggressive authoritative figure on the
19 property, but only to provide services and support to property owners.

20 On Tuesday, February 27, 2007 at 11:18 AM, Christine Harris states that this is when the
21 good rapport between them ended. When Christine Harris' husband, James Jacobs, was a board
22 member Christine Harris felt there was a reasonable relationship with Michelle Beazley.

23 One evening in March 2007, Christine Harris noticed a pipe was leaking inside their unit.
24 Christine Harris' husband was not home at the time so she notified Michelle Beazley by phone.
25 Michelle Beazley was very rude and brief on the phone, providing no assistance of the matter. It
26 was not in the interest of Christine Harris to engage in a heated argument or take it personal, so
27 she proceeded with the problem at hand. Christine Harris contacted a plumbing company,
28

1 O'Grady Plumbing, to repair the leaking pipe. Two plumbers arrived at her residence and
2 proceeded to repair the pipe. While observing their work, Christine Harris noticed that the
3 contractors burned the white insulation pipe that covers the adjacent pipe. Since these pipes are
4 exposed utilities hanging from the ceiling of their loft unit, Christine Harris requested in writing
5 that O' Grady Plumbing replace the burned white insulation pipe. She made numerous requests
6 via phone, and two requests in writing to the plumbing company for the pipe to be replaced
7 exactly the way it was before the plumbers worked in the area. Michelle Beazley immediately
8 sided with the vendor instead of the property owner. Christine Harris faxed several letters to
9 O'Grady Plumbing company to replace the insulation sleeve entirely, and properly. Christine
10 Harris felt that, once again, there was a lack of a cooperative working relationship between her
11 and Michelle Beazley. She expressed her frustration in an email dated March 6, 2007, 10:00
12 AM, with a copy sent to Christine Harris' husband, James Jacobs. It took O'Grady Plumbing
13 three times to try and fix the pipe insulation properly. Christine Harris felt strongly that she had
14 to fight to get it done correctly.

15 On Saturday, November 17, 2007 at 7:55 AM, Christine Harris emailed Michelle Beazley
16 to request that the person living above her refrain from repeatedly dragging a personal piece of
17 property across the floor, as this sounded like nails on a chalkboard.

18 On Saturday, November 17, 2007 at 2:51 PM, Christine Harris emailed Michelle Beazley
19 again, requesting that the property manager handle the complaint lodged to the property owner
20 who was responsible for the noise. Christine Harris did not give the reason at the time, however
21 the reason Christine Harris requested Michelle Beazley handle the complaint was due to the fact
22 that Christine Harris has been subjected to retaliation from other property owners on various
23 occasions and retaliated against for lodging complaints. Christine Harris felt that if the property
24 manager handled this complaint, there would be less resentment from property owners. Christine
25 Harris had not received any emails from Michelle Beazley at this point and felt as though she
26 could not handle the job at hand.

27 On Monday, November 19, 2007 at 10:22 AM, Christine Harris sent an email to Michelle
28

1 Beazley stating "I prefer to have a positive, and cooperative relationship with you as our property
2 manager. As I have mentioned in the past, we are all your clients. We all pay for your salary. It
3 is the responsibility of the property manager to see that our needs our met. I am not sure why
4 you resist your duties, at least with me, but I do not like requesting things from you several
5 times. James is no longer a board member, but this does not allow excuses to not perform the
6 job. With Kindness, Christine."

7 On Tuesday, November 20, 2007 at 4:58 PM, Christine Harris requested to speak to the
8 attorney for the Homeowner Association, as she did not feel she was taken seriously, nor her
9 needs met.

10 On Saturday, November 24, 2007 at 11:35 AM, Christine Harris requested from David
11 Spitzer, the HOA's Vice President, to have the contact information for the Homeowner
12 Association's attorney.

13 On Sunday, November 25, 2007 at 2:57 PM, Christine Harris emailed Michelle Beazley,
14 copied to her husband James Jacobs. "The reason why it is so important for the property
15 manager to be the mediator of the building is so that people do not retaliate, as I have personally
16 experienced in this building. I believe that the scope of the property manager's duties need to be
17 detailed so there is an understanding of what a property manager needs to do to fulfill the needs
18 of the clients at Bryant Square Lofts. Thank you. Christine #111."

19 On Monday, November 26, 2007 at 9:28 AM, Christine Harris emailed David Spitzer,
20 again, and copied her husband James Jacobs, stating "This has been an on going issue with her.
21 For some reason, she thinks she does not have to do her work for me. When James was on the
22 board she responded, with many emails, now she does not respond at all. She is less than
23 professional. We all have a right to have our voice heard." Christine Harris emailed David
24 Spitzer on the same day at 9:40 AM stating, "I believe that we should, as a community, interview
25 other property managers at this time. Thank you. Christine Harris #111". Christine Harris does
26 not know whether or not this email was viewed by Michelle Beazley.

27 On Monday, November 26, 2007 at 10:28 AM, Christine Harris emailed David Spitzer
28

1 stating "I will gladly meet with you to tell you all the requests she has denied, and excuses she
2 has made for vendors. I have reached my limit with her. Thank you, Christine Harris."

3 On Monday, November 26, 2007 at 5:03 PM, Christine Harris emailed the President of
4 the HOA, Patrick Everett, the Vice President, David Spitzer, and copied her husband, James
5 Jacobs, stating "I want to be informed on all levels of the HOA." She also states "The HOA will
6 be held responsible for anyone who retaliates against me again."

7 On Monday, November 26, 2007 at 10:33 PM, Christine Harris emailed Patrick Everett,
8 and David Spitzer, stating "These issues are about protecting property owners of Bryant Square
9 Lofts, not about egos or power struggles. It is about doing the right thing. From what I see and
10 hear, the Board is not protecting me or hearing my point of view. I ask you all, whose side are
11 you on, Michelle, the property manager or the property owner? Respectfully, Christine."

12 On Tuesday, November 27, 2007 at 8:33 AM, Christine Harris emailed Patrick Everett,
13 and David Spitzer the basic (CID) Laws, Community Interest Development, after trying to
14 communicate and be heard. Patrick Everett, David Spitzer, and James Jacobs have an off site
15 meeting to discuss issues, (James Jacobs goes for Christine Harris as he has a relationship with
16 the Board members). Christine Harris sent this email "Michelle lacks a do-whatever-it-takes
17 attitude. All I care about is working together, even if we pretend there is community. It sounds
18 like this is all about a misunderstanding, and miscommunication. Hopefully things can be
19 resolved in a positive manner. James will be able to meet with both to discuss issues, as you all
20 have a great relationship. Thank you for your consideration. Respectfully and Peacefully,
21 Christine." Christine Harris only sought to sustain resolution, and problems solved in a
22 reasonable manner.

23 On Thursday, November 29, 2007 at 8:33 AM, Christine Harris emailed all Bryant
24 Square Lofts board members: Avi Benjamini, David Spitzer, Greyson Mitchem, Kevin Ward,
25 Michelle Beazley, and Patrick Everett, and copied her husband James Jacobs, and the attorney
26 for Bryant Square Lofts, Ann Rankin, stating "Because I have personally been retaliated against
27 in all ways, I no longer will make request to neighbors, and will request that the board and
28

1 property manager support me”.

2 An example of a property owner retaliating was about a year ago. Christine Harris
3 requested that the group of people at Base Studios (Gallery), clean up all of their bottles, etc.,
4 after their party. They yelled, said rude things, and physically attacked her, in the presence of
5 her father as a witness. Christine Harris and her father were a lady and a gentleman, never said
6 or did anything to harm anyone. The group of people turned it around, and lied in emails, which
7 were deformation of character, libel, and slander. Christine Harris did not keep these emails, as
8 she just wanted peace, and wanted to let go of the emails.

9 On Saturday, December 1, 2007 at 9:38 AM, Christine Harris emailed Patrick Everett,
10 David Spitzer, Ann Rankin, and her husband, James Jacobs, stating “All I want is for things to be
11 worked out, with cooperation. I do not want struggle or conflict. I stopped going to board
12 meetings because I was retaliated against, and Michelle was rude to me. Here are just a few
13 issues with Michelle Beazley, the property manager. I understand no one is perfect, but we are
14 all her clients. In this building, we all pay for her salary, and she should treat us all fairly and
15 equal. Michelle treated me poorly when I called her to talk about the pipe leaking, and acted like
16 I was bothering her.” (Maybe this was personal, or not). Michelle Beazley made excuses for the
17 plumbers about burning their pipe insulation, saying they could not replace it, and she would not
18 stand up for Christine Harris. Christine Harris had to write many letters to get the correct pipe
19 insulation replaced, finally. Michelle Beazley kept making excuses for any and all vendors.

20 On March 21, 2008, when Deborah Davids became the new President of the HOA,
21 Deborah Davids claimed in an email to have civil litigation experience.

22 Christine Harris started to seek legal council about a few issues, bought a book on the
23 Davis Stirling Act, and spoke with an attorney, of which did not resolve any issues, while
24 spending \$500.00 of her own money. Christine Harris never intentionally pursued a lawsuit, and
25 never wanted conflict, but wanted resolution. Christine Harris is, in her own words, “A
26 reasonable person who believes that people can work together through communication,
27 cooperation, and collaboration.”

1 On May 9, 2008 at 2:08 PM, Christine Harris received a document from a vendor she
2 requested from the HOA stating the chemical content of the carpet cleaner a vendor used on the
3 common area carpets. Prior to this email, Christine Harris had a phone conversation with the
4 vendor Rich Holt (richeholt@sbcglobal.net) 650-588-0534. Rich Holt contacted Christine Harris
5 to discuss the issue of the carpet cleaner chemical. Rich Holt threatened Christine Harris, and
6 said "I hope this is the last I hear about this issue". Christine Harris was very uncomfortable
7 with this statement. Christine Harris has the right, as a property owner, to request what
8 chemicals are used in the common areas of the building. Christine Harris was concerned about
9 the chemical content of the carpet cleaner because it was in the main hallway upstairs, and could
10 potentially harm children and animals using this hallway.

11 In the spring or summer of 2008, Christine Harris started constantly receiving strange
12 prank phone calls, and text messages from phone numbers 000- 000-0000 and 999-999-9999.
13 Christine Harris noticed these calls were happening right after Deborah Davids became the
14 President of the HOA. Christine Harris also noticed that both her home phone and cell phone
15 had strange echos that were never there before. She believes her phones were being wire tapped,
16 somehow, either from the companies, or remotely. Christine Harris believes that the person (s)
17 who listens to the calls hangs up now and again during the calls, based on the change in the
18 background noise. AT & T came out to check the lines after Christine Harris notified them of
19 the recent issues. However AT &T claims they did not notice anything had been tampered with.

20 Since a few of the HOA board members were new, Christine Harris and James Jacobs
21 requested to receive their contact information. The board was continually non responsive.
22 Christine Harris was frustrated about asking the board so many times for this information, that
23 she sought other means then bringing on an attorney into the situation. One may contact the
24 Attorney General for the State of California for free to provide service for property owners that
25 cannot solve issues with their board of directors. On July 24, 2008, Christine Harris contacted
26 the Attorney General for the State of California, with a Notice of Complaint. (EXHIBIT 1)

27 On August 5, 2008, Christine Harris received a copy of the Notice of Complaint, Public
28

1 Inquiry Unit (PIU) #230697 that was sent to Deborah Davids, board president, for not complying
2 with the law of providing her contact information. Christine Harris believes this is the same day
3 that Deborah Davids received her copy of the Notice of Complaint as well. The information that
4 is required by law is the address of the board of directors. Christine Harris, at this point, had
5 never met Deborah Davids, or Peter Davids, her husband, and did not know what either of them
6 looked like. (EXHIBIT 2)

7 On the morning of August 6, 2008, Christine Harris walked over to 19th Street, at York
8 Street, and on her way, said hello to a neighbor's dog. While petting the dog, Christine Harris
9 noticed a woman with blonde hair walk close by and gave Christine Harris a look of anger.
10 Christine Harris was a little frightened by this look, and thought that may have been Deborah
11 Davids, but was not sure. After a month or two went by, Christine Harris noticed, while looking
12 out her unit window, this same blonde woman putting something into her car.

13 On August 7, 2008 around 8:45 AM, Christine Harris states this incident occurred: "I
14 went into the lobby, and a guy with shaggy brown hair was in the lobby, over weight, kneeling
15 down on the floor by the sliding door, fiddling with the combination lock for quite some time.
16 As I walked by him, he stared intently, and a strange feeling came over me, as if I was being
17 watched and stalked. I have never had this feeling before. I forgot something in my home, so I
18 went back to retrieve something, and when I came back he was still fiddling with the lock, never
19 to open or close the door or the lock, and was whistling the entire time. If he was trying to look
20 like a janitor, it was strange, because our contracted janitors visit our building on Mondays,
21 Wednesdays, and Fridays, not Thursdays. Around 3:00 PM I came back home through the front
22 door, and another man with the mustache, with gray hair, blue shirt, khaki pants, about 5' 10",
23 carrying a brief case, but it looked as if he never carried one in his life, came into the building
24 right after me, and than started walking in front of me, walking ever so slowly, whistling. As I
25 entered into my unit, I watched him enter the other door, staircase, to go upstairs. What is so odd
26 about this is that if someone new is entering the building to go upstairs, you would enter the
27 building from the front as he did, and then go to the upstairs through the stair case in the front of
28

1 the building, you would not go through the front door, to go through the back sidewalk area, to
2 go to the upstairs units. It was strange, it felt liked I was being followed and stalked. Both of
3 these men were given access into the building.” Christine Harris claims she can identify both of
4 these men in a line up. She believes that both of these men are police officers at the Mission
5 Street Police Station, and that the gray haired man could possibly be Sergeant Raymond Beazley,
6 the property manager’s husband. This incident happened two days after Deborah Davids
7 received the Notice of Complaint from the California Attorney General.

8 When Christine Harris’ husband came home from work that evening, she told him what
9 had happened. He told Christine Harris that he saw two Caucasian men, both with mustaches,
10 one with gray hair, the other with shaggy brown hair, driving around the area in a blue
11 undercover police vehicle, the morning of August 7, 2008, while James Jacobs was riding his
12 bike to work. He was riding on Harrison Street when the car drove along side him for a block,
13 where he was able to recognize the computer panel mounted on the dash that you typically see in
14 a police vehicle. The car drove ahead and took a right on Mariposa Street headed east towards
15 Potrero Avenue. Because of the misunderstandings with Michelle Beazley, and Deborah Davids,
16 Christine Harris concluded that one of the stalkers might be Michelle Beazley’s husband.
17 Christine Harris had discovered in a phone conversation with Michelle Beazley that her husband
18 was a police officer. Christine Harris realized that these people had conspired to send stalkers.
19 The incident definitely scared her.

20 Stalking is illegal in the state of California, and the United States (California Stalking
21 Law, Penal Code 646.9 PC). This form of stalking is called gang stalking or organized stalking
22 (otherwise known as COINTELPRO, Counter Intelligence Program). This stalking incident has
23 caused Christine Harris severe emotional distress and physical damage.

24 On the evening of August 7, 2008, Christine Harris stayed awake all evening searching
25 the internet trying to figure out what had happened to her. She started researching stalking, as
26 she had never been stalked before. Christine Harris believes it was done to harm her, and
27 realized through her research, that it was for the purpose of revenge. Christine Harris could not
28

1 sleep, eat, or function for many months following the incident. Since Christine Harris believes
2 police officers were involved, she was skeptical about filing a police report, and if she did, would
3 it do any good or would they retaliate even more. Christine Harris contacted District Attorney
4 Kamala Harris and asked for assistance. The DA's office sent an email back stating that
5 Christine Harris should file a police report before they can investigate. Christine Harris feels
6 strongly that if the District Attorney, Kamala Harris, and any authorities she contacted, had
7 stepped in to investigate, the crimes against her would have ceased.

8 On August 13, 2008, Deborah Davids responds to the Notice of Complaint (PIU
9 #230697) that Christine Harris filed with the California Attorney General. In Christine Harris'
10 opinion, Deborah Davids did not give an answer, but makes excuses as to why she does not need
11 to comply with the law. (EXHIBIT 3)

12 On August 16, 2008 at 6:54 PM, Christine Harris sent an email stating "Hello Board and
13 Property Manager, While getting my mail on Saturday, August 16, 2008, around 2:30 PM, in the
14 lobby, there was an entire group of people, including Michelle Beazley. We were never
15 informed of this meeting. Please provide us with the minutes for the meeting. Best, Christine
16 Harris Bryant Square Lofts Property Owner." Mrs. Beazley responded, but it did not appear to be
17 something Mrs. Beazley would write. "Dear Christine: In response to your email: "You are
18 mistaken, there is no way that I was there on Saturday or anytime on the weekends. I would only
19 be there if there was an extreme emergency. As a matter of fact, I was in Home Depot from
20 Noon to 2:30 p.m. I have a receipt that I can send you if you need proof. By the way, this is very
21 funny that someone looks like me, would be interested in meeting my double. As you well
22 know, if there is a board meeting, it is posted in advance on the bulletin board in the lobby. For
23 the past 5 years, there has never been a board meeting on the weekend. On another note: In
24 researching my computer, I received 85 emails from you since 1/28/08 and it has taken a toll on
25 my work load. Therefore, I kindly request that your emails to Management be only for work
26 orders that pertain to the Association. I do not want to increase my management fee for the time
27 spent in reading non-related items to the Association. I would appreciate your cooperation very
28

1 much. Respectfully, Michelle Beazley.”

2 Property owners relied on emails for meetings, not postings on the bulletin board.
3 Christine Harris believes this email may have been written by someone else, other than Michelle
4 Beazley, as this is not Michelle Beazley’s style of writing. Per the Davis Stirling Act, any
5 meeting pertaining to the Homeowner Association, all property owners are to be invited. They
6 had a meeting without inviting Christine Harris and James Jacobs, which is illegal per the Davis
7 Stirling Act. They lied and denied this meeting ever occurred when Christine Harris clearly saw
8 them all in the lobby. In addition, they harassed Christine Harris in this email regarding her
9 communication with the property manager.

10 On August 18, 2008 at 7:01 PM, Christine Harris sends another email to Michelle
11 Beazley, Deborah Davids, and Kevin Ward requesting, yet again, the contact information of
12 board members. This email also contains a resource for conflict resolution and reconciliation.
13 Again, Christine Harris only wants resolution and open communication with the HOA Board
14 members.

15 On or about August 21, 2008, Christine Harris notices a woman with brown bobbed hair
16 starts stalking her around Bryant Square Lofts, 720 York Street, San Francisco, CA. Based on
17 very few encounters, of which will be explained later, Christine Harris believes this stalker to be
18 Deborah Davids (Definition per the Webster’s Concise Dictionary: *Stalk*, 1.to approach game,
19 etc., stealthily. 2. To walk in a stiff or haughty manner).

20 On or about August 21, 2008, Christine Harris visited the two next door neighbors.
21 Shortly after her visits she received strange text messages stating “Visiting neighbors are you”.
22 Christine Harris was very disturbed by this text message and deleted them as fast as she could.
23 Christine Harris states that this text message “Made my skin crawl”.

24 On August 26, 2008 at 9:49 AM, Christine Harris emailed Kamala Harris, District
25 Attorney (DistrictAttorney@sfgov.org) requesting support. (EXHIBIT 4)

26 On August 26, 2008 at 10:22 AM, Christine Harris writes to Mayor Gavin Newsom,
27 requesting a meeting. Christine Harris only received a few calls from Mayor Gavin Newsom’s
28

1 assistant. However, no meetings occurred, and nothing was accomplished or resolved. Christine
2 Harris feels that if any of the public officials, or any of the San Francisco authorities had
3 intervened, the crimes against her would have ceased.

4 On Sunday evening, August 31 2008, after eating at the 17th Street Taqueria in the
5 Mission District, El Toro, Christine Harris and her husband went to the Mission Street Police
6 Station to file a police report on the stalking incident. Christine Harris handed the officer at the
7 window a piece of paper that had the stalking incident written down so it would be easy for the
8 police officer to take the report. Christine Harris never stated in this report that police officers
9 were undercover, stalking her, and did not state Officer Beazley's name out of fear of further
10 revenge. In this letter Christine Harris states that she would have reported this sooner, but felt no
11 one would have helped her. Christine Harris was denied the opportunity to file a police report.

12 On or about September 3, 2008, Christine Harris contacts the HOA's attorney, Ann
13 Rankin, and requests Deborah Davids (although Christine Harris did not say her name, but
14 insinuated) be removed from the Board. Ann Rankin responds by saying that she cannot do
15 anything without instruction from the Board.

16 On or about Monday, September 8, 2008 at 1:10 PM, Christine Harris was being
17 followed by a big, black Dodge truck, with a man that looked liked the man with gray hair and
18 mustache that followed her on August 7, 2008 through the lobby of Bryant Square Lofts around
19 3:30 PM. Christine Harris positioned her car to get behind the truck and followed him in hopes
20 of getting the license plate number. She followed him for several blocks on Potrero Avenue until
21 he sped away on Highway 101. Christine Harris was very distraught and was not successful in
22 getting the license plate. Christine Harris researched more about stalkers and found a detective,
23 Mike Proctor, who wrote a book called *Stalk The Stalker*, which gives advice on how to handle
24 stalkers. Christine Harris was stalked the day after sending out an email to Ann Rankin. The
25 two people who were most likely sent her email are Deborah Davids, the President of the Board,
26 and Michelle Beazley, the property manager. Christine Harris feels she was stalked, again, for
27 her freedom of speech and for emailing Ann Rankin.

1 On September 22, 2008, Christine Harris was scared and did not feel supported by
2 anyone, except her husband. Christine Harris felt as if she needed to report this stalking incident
3 as she feared for her life. Christine Harris reported the prank phone calls and strange text
4 messages on-line to the SFPD. An officer responded by email to let her know they could not
5 clearly understand the report so they were going to send someone out to take a report. Christine
6 Harris stated that she wanted to wait that evening until her husband was home. Two officers
7 showed up that evening and took the report (#081008650). Christine Harris still did not report
8 that police officers were involved, as she feared retaliation, and felt as though the officers would
9 not take the report if she stated such. (EXHIBIT 5)

10 In September, 2008, Christine Harris was in her white Volvo at 19th Street and Bryant
11 Street when she noticed that a SFPD car was right next to her. The police officer in the car was
12 the same man that stalked her around 8:45 AM in the lobby of Bryant Square Lofts on August 7,
13 2008. However the man was now bald. This police officer shaved his head, but was back in the
14 area at the same time as Christine Harris. She looked at him, and he nodded his head at her.

15 On September 18, 2008, the HOA Board writes a letter to Christine Harris and James
16 Jacobs stating that Michelle Beazley will no longer receive any emails from them.

17 On or about September 25, 2008, Christine Harris realized that she should inform all the
18 neighbors about the stalking incidents. Christine Harris read on the internet that stalking victims
19 should let all of their neighbors know as to keep the stalkers away. Christine Harris started to
20 conduct more research and found that the stalking incident is called gang stalking, and this is a
21 technique used by the KKK to stalk the Black Panthers. Christine Harris starts to reach out to as
22 many people as possible, including public officials. Christine Harris sends out the
23 "Neighborhood Alert" notice to everyone at Bryant Square Lofts, 720 York Street, San
24 Francisco, CA 94110, but excludes Deborah Davids and Michelle Beazley. Christine Harris sent
25 out the "Neighborhood Alert" without a return sender address, to remain anonymous out of fear
26 of further revenge. Christine Harris believes that people that do these kinds of inhumane acts
27 will most likely continue their criminal behavior, and the defendants have exhibited continued
28

1 criminal behavior. (EXHIBIT 6)

2 On September 29, 2008, Christine Harris and James Jacobs received a letter from
3 Michelle Beazley stating "Management and the Board are receiving complaints from several
4 owners that you are posting neighborhood alert notices all around the building. "You may not be
5 aware of this, that posting letters/signs around the building is violation of the CC & R's. Since
6 you chose not to be on the Yahoo group to inform the residents, your only recourse is to post
7 notices on the community bulletin board. Please remove all the notices around the building. If
8 any notices are posted on the glass of the building, please make sure you clean the residue from
9 the scotch tape. We appreciate your cooperation. Sincerely, Michelle Beazley, Property
10 Manager."

11 This was a form of harassment, revenge, and retaliation from Deborah Davids, and
12 Michelle Beazley, for exposing their crimes of stalking, and conspiring to stalk Christine Harris.
13 How would they know it was Christine Harris when the Neighborhood Alert notice does not
14 have Christine Harris' name on it, nor a return address? In addition, no one is around to see
15 Christine Harris posting notices. All the notices Christine Harris posted in Bryant Square Lofts
16 and around the neighborhood, including the "approved" bulletin board in the lobby, were
17 mysteriously removed. One day Christine Harris and a friend post a Neighborhood Alert notice
18 on the bulletin board and within ninety minutes, the notice was removed.

19 On October 24, 2008, Christine Harris sent a request to SFPD to get a copy of her police
20 report #081008560. Christine Harris had to email the SF Board of Supervisors, and Mayor
21 Gavin Newsom, in order to request a copy of her police report. Christine Harris noticed, again,
22 that both her cell phone and home phone had echoes, as if someone was listening in. She can
23 hear other people hang up on the other "side" of the phone line. This echo has continued for
24 nearly two and a half years, until present. Her cell phone is with Sprint, and her home phone
25 with AT & T. Sprint is coincidentally an account of Jones Day Law Firm, where Defendant Peter
26 Davids is employed.

27 On October 28, 2008, Christine Harris sends a letter to the San Francisco FBI office for
28

1 support. (EXHIBIT 7)

2 On November 4, 2008, Christine Harris was looking out her front window, as she started
3 to do since all of these incidents, and saw that a brown bobbed haired woman, similar to the one
4 she noticed on August 21, 2008, was parking her red BMW, (plate number 2PJY682, two door,
5 tan interior), in front of Christine Harris' unit on York Street.

6 (<http://www.youtube.com/watch?v=kObwv1m5oyQ>). The woman went into the trunk to get

7 bags, and stared at Christine Harris in the window. In Christine Harris' words, "like she was
8 going to kill me, a look I had never received, ever, in my entire life." Christine Harris notices

9 this car parked nearly every day at this point in front of her window at 720 York Street. As

10 Christine Harris kept looking at her in the window, Michelle Beazley showed up, and started

11 staring at Christine Harris as well, exactly with the same look. Christine Harris was very afraid

12 and felt as though her life was threatened. Christine Harris called SFPD. Christine Harris also

13 called her father, Jim Harris, and told him about the on-going situation. Jim Harris came over to

14 be with his daughter, and was aware that she had called the police. After a few minutes, two

15 police cars showed up. Christine Harris was still looking out the window while the two police

16 cars pulled up to 720 York Street. As the police cars arrived Michelle Beazley and Deborah

17 Davids ran into the building as fast as they could, as witnessed by Christine Harris herself. The

18 three police officers came into Christine Harris' home; a Caucasian female with brown hair, blue

19 eyes, about 5'-3" tall, with her hair pulled back; another female, Caucasian with blond hair, and

20 dark hair roots, brown eyes, about 5'-7" tall, (both women on the little over weight side), and an

21 Asian man, slender, about 5'-6" tall. Christine Harris started to tell them how Deborah Davids

22 and Michelle Beazely were in her front window glaring at her like they wanted to kill her.

23 Christine Harris said she called SFPD as she feared for her life. Jim Harris came into the home

24 about five minutes after the three SFPD officers arrived. Christine Harris started to tell them

25 about how she had strong reason to believe that Deborah Davids, and Michelle Beazley, had

26 conspired to send stalkers after her and that she believed Sergeant Raymond Beazley was one of

27 the stalkers. Jim Harris witnessed this conversation. The three officers started talking among

28

1 themselves, then walked into Christine Harris' living room proceeding to have private
2 conversations. They phoned to have another police officer join them. A Sergeant arrived, a bald
3 man, and stood next to the door the entire time watching Christine Harris and her father. The
4 other three officers were threatening Christine Harris, telling her they would sue her for slander
5 if Christine Harris said anything to anyone. Christine Harris told them she feared for her life.
6 (Penal Code Section 136.1 does not allow intimidation of witnesses or victims. Penal Code
7 136.2: of various orders, intimidation of witness and witness. Penal Code Section 139, stating
8 cannot use threats to use force or violence upon witnesses). Christine Harris told the officers that
9 she was stalked by a gray haired male in a big, black Dodge truck, who she believed to be
10 Sergeant Raymond Beazley, and that Christine Harris tried to follow him to get the license plate
11 number. The two women gave Christine Harris a pep talk to let her know that following this
12 person was not appropriate. They also gave Christine Harris a pep talk about posting notes in the
13 neighborhood about the stalking incidents. Christine Harris told the officers, that her and her
14 husband were planning on going to 850 Bryant Street, SFPD main offices, to speak to an
15 inspector that week. The officers got on the phone again with someone. This was such a strange
16 reaction from police officers. Christine Harris had never thought that they would protect the
17 criminals and threaten a victim. Christine Harris told the blond haired officer that this was what
18 happens to rape victims- they are told to be quiet, right? Christine Harris has never been raped,
19 but it is what you hear in the victims' cases. Christine Harris used this as an analogy only. The
20 blond haired officer looked at Christine Harris with glazed eyes, as if not to hear her, and looked
21 at Christine Harris in disgust. Christine Harris filed a second police report, and again this was
22 very difficult to obtain. Police report #081180497. (EXHIBIT 8)

23 On November 5, 2008, Christine Harris and her husband, James Jacobs, went to 850
24 Bryant Street, to speak to an inspector. They arrived early in the morning, before 10:00 AM, and
25 went to the 4th Floor. Christine Harris gave a bald inspector the police report number she
26 received on November 4, 2008, #081008560. He took the note, and went into the back office,
27 out of sight. Soon after he left this office and went somewhere else in the building. He returned
28

1 about 15 minutes later and told Christine Harris that the case was lost. James Jacobs is the
2 witness to this conversation. He gave Christine Harris a light yellow post it note with a name
3 and number to call, Officer Dunn. He told Christine Harris that Officer Dunn would get right
4 back to her. That evening James Jacobs asked Christine Harris if she called the phone number.
5 Christine Harris hesitated and said she had not made the call yet.

6 On November 6, 2008, Christine Harris called Officer Dunn, when the answering
7 machine picked up it said it was the Psychology Unit for the San Francisco Police Department.
8 Christine Harris knew right away that they were trying to stop her from telling anyone. She
9 realized they were trying to criminalize her, to cover up the crimes against her. Christine Harris
10 has never had any issues with the police her entire life, and has a perfect driving record. That
11 evening, and for nearly a week, Christine Harris was very depressed, saddened, and could not
12 eat, sleep or function in anyway. She felt helpless, and did not know where to turn since the
13 people who are supposed to protect her are stalking her, conspiring against her, and now, doing
14 everything in their power to protect the criminals. Christine Harris was in shock. She never
15 knew this had happened to people. Christine Harris has never done anything to anyone and is a
16 law abiding resident of San Francisco since August 1989. Christine Harris found Officer Dunn's
17 photo on SFPD's website, along with her credentials. Officer Dunn is supposedly evaluating
18 people for the San Francisco Police Department but is not a doctor of any kind. She is a
19 psychiatric technician.

20 Sometime in November 2008, Christine Harris noticed strange technical difficulties on
21 her computer, as if her computer was being hacked into. DSL was very slow most of the time.
22 All of these compounded issues started to scare Christine Harris. She feared for her life. She
23 could not function. She changed her daily habits and stayed home most of the time for fear of
24 being followed, stalked, or intimidated. She could barely eat, sleep, or do much of anything out
25 of fear. Christine Harris noticed police cars showing up around her more than ever. Christine
26 Harris noticed the bald Sergeant, the one that came to her home on November 4, 2008, was often
27 in the neighborhood in a police car.

1 One evening in November 2008, Christine Harris was lying in bed alone, while her
2 husband was traveling for business. Late in the evening, early morning, Christine Harris felt a
3 jolt of unseen energy hit her body. She looked out towards the back walk through the window
4 and saw a man standing outside. The walkway lights allowed her to recognized the man; it was
5 the same man who stalked her on August 7, 2008, and who also was driving the big, black
6 Dodge truck. He was holding a device and pointing it at Christine Harris through the window.
7 Christine Harris did not know what to do and just laid awake for the rest of the days following
8 this incident.

9 In the following days, Christine Harris became violently ill with flu and cold symptoms,
10 but knew it was neither. Christine Harris had diarrhea, sweating, stomach cramps, severe and
11 violent coughing , and a burning sensation all over her vital organs. Christine Harris started to
12 research and found that such a device is called directed energy weapons, microwave weapons, or
13 D.E.W.'s. This information is all over the internet. Christine Harris feared for her life for a
14 reason. Somehow this person had access into the building again. This man, who Christine
15 Harris believes is Sergeant Raymond Beazley, did this during sleeping hours in the privacy of
16 Christine Harris' own home, without any ability to defend herself. Christine Harris did not go to
17 the doctor because she was very disturbed, confused, and still did not understand how someone
18 could do such an act. Christine Harris does not have an active imagination nor the capacity to
19 make up such incidents and crimes. This is science fact, not fiction (see Judy Wall's
20 Electromagnetic Weapons Timeline <http://www.raven1.net/jwalltil.htm>) (EXHIBIT 9)

21 In the month of November 2008, after having conversations with Christine Harris'
22 husband, and a long time friend who is a real estate agent, Christine Harris and James Jacobs
23 decided to sell their property, and move away from a place that is causing so much harm, stress,
24 and anxiety. They intended on keeping this property since they originally both fell in love with
25 the building and their condominium unit, but felt it was time to move on.

26 Christine Harris outreached to many organizations, public officials, and media agencies
27 at this time to seek support in any way. She still has not received any assistance from any public
28

1 official, any authorities, or human rights organizations other than Freedom From Covert
2 Harassment and Surveillance.

3 Christine Harris had no one to go to for support. She connected via internet with a police
4 abuse person by the name of Kamu. Christine Harris saw on the news of a woman who was
5 stalked and murdered in San Mateo, CA, and this frightened her even more. Christine Harris
6 reached out to all police stations in the San Francisco bay area, but to no avail. Christine Harris
7 communicated via email to the San Mateo Police, and because of the stalking and murder
8 incident, she got a response from one of their Officers. Christine Harris went to the San Mateo
9 Police station and told the story of the stalking and that she strongly believes Sergeant Raymond
10 Beazley was involved in the stalking. The officer at the San Mateo Police Station told Christine
11 Harris there was nothing they could do for her since it was out of their jurisdiction, and did not
12 further assist Christine Harris. The officer was interested in hearing from her until she told him a
13 police officer was involved.

14 On November 17, 2008, Christine Harris sends a letter to San Francisco Chief Heather
15 Fong requesting a copy of her police report #081008560.

16 On November 26, 2008, Christine Harris sends a letter to Chief of Police Susan E.
17 Manheimer in San Mateo, CA, to get assistance. Christine Harris is searching for help from
18 someone.

19 On November 27, 2008, Christine Harris sends a letter to Chief of Police Wayne G.
20 Tucker in Oakland, CA, to try to get assistance since she is unable to get support from SFPD.

21 The month of November 2008 is when Christine Harris believes she connected with
22 Mesha Monge-Irizzary via the internet. Mesha Monge-Irizzary provides support for victims of
23 police brutality.

24 In November 2008, Christine Harris and James Jacobs put their condominium up for sale,
25 but did not heavily market it due to privacy issues. (EXHIBIT 10)

26 On December 20, 2008, Christine Harris sends a letter to Police Commissioner Theresa
27 Sparks requesting assistance.

1 On December 23, 2008, Christine Harris meets with Mesha Monge-Irizarry for support
2 and to talk about being stalked by who she believes to be Sergeant Raymond Beazley. Mesha
3 Monge-Irizzary is the founder of the Idriss Stelley Foundation, Law Enforcement
4 Accountability, 415-595-8251.

5 On January 29, 2009, Lt. Joseph Reilly, the Secretary from the San Francisco Police
6 Commission sends Christine Harris a letter acknowledging her letter of the crimes against her.

7 On or about February 13, 2009, Christine Harris met her friend at Peet's Coffee in
8 Burlingame. Christine Harris only emailed her friend and she did not have a phone conversation
9 to verify the meeting (Email was not saved). Christine Harris encountered a man, who she
10 believes, somehow cyber-stalked her, and then stalked her at Peet's Coffee. Christine Harris
11 entered into Peet's Coffee in Burlingame around 12:00 PM to meet her friend. Her friend was
12 not there yet, so she ordered a tea, and decided to sit and wait for her friend. She noticed a very
13 heavy weight man, Caucasian, sitting next to her. He proceeds to start having a conversation
14 with her. He told Christine Harris his first name was Rob. He also told her that he was a
15 consultant. Christine Harris was fearful but talked to him anyway. She has never met or spoke
16 with this person in her entire life. He states to Christine Harris, at the start of the conversation,
17 "You are calm for someone who is going through so much." Christine Harris never told him
18 what she was going through. Why would this man, who she never met, or talked to before, make
19 such a statement? He had a computer that he put on the table. He opened up the computer, and
20 on the screen was an image of George W. Bush Jr. with the Skull and Bones. Christine Harris
21 had read a booklet by Eleanor White, called *Organized Stalking* (EXHIBIT 11), and in fact had
22 several booklets in her bag with her to give out to people to expose the crime of organized
23 stalking. Christine Harris gave him an *Organized Stalking* booklet. Christine Harris already
24 knew about stalkers techniques from this booklet. Christine Harris noticed this man started
25 talking about things that were very personal to Christine Harris. He volunteered that he went to
26 the University of Oregon, just like her. Christine Harris never told this man that she went to
27 college, nor mention going to the University of Oregon. Christine Harris often sends text
28

1 messages to her friends and family using the word "love". This man at Peet's started using this
2 word out of nowhere, a lot, in the conversation with Christine Harris. Christine Harris started to
3 realize this man was an organized stalker, and that he was doing what is called "street theater".
4 He told Christine Harris with a condescending tone, that he was grateful for all the information
5 she had provided him. He said he was very angered by class action lawsuits. This was another
6 strange statement since Christine Harris was hoping that a group she connected with, Freedom
7 From Covert Harassment and Surveillance, would file a class action lawsuit. Christine Harris
8 filed forms and paperwork for the lawsuit that she only saved on her computer. The only way
9 this person would have known any thing about Christine Harris was from stolen files on her
10 computer. Christine Harris feels strongly, based on the technical difficulties from her computer,
11 that her computer was hacked into during these crimes against her. Christine Harris does not
12 have money to get hard evidence of these crimes. When Christine Harris got home, she knew
13 she had been stalked. Within the week or so, she decided that she should look at Jones Day Law
14 firm to see if this man from Peet's was possibly an employee of the firm. She discovered he is
15 one of the partners in the law firm, Robert Marshall (rgmarshall@jonesday.com, 415-875-5720).

16 On or about February 15, 2009, Christine Harris sent a note to Kevin Ward, an HOA
17 Board member, to let him know someone in the building was stalking her.

18 On or about February 18, 2009, Christine Harris states that a form of energy was directed
19 at her body, again, and it felt like it burned all of her vital organs. As this energy hit Christine
20 Harris' body, she went to the window in her home at 720 York Street, to see if it was coming
21 from the direction of the front window. There was a woman standing on the sidewalk at her
22 window, the brown bobbed haired woman. Christine Harris opened the window and asked
23 "Are you Deborah Davids?" The woman answered, "Yes, but I am not doing anything wrong to
24 you Christine." Christine Harris never asked her if she was doing anything wrong to her.
25 Deborah Davids and Christine Harris had never met before, and Christine Harris did not know
26 what Debroah Davids looked like before this encounter. Christine Harris thought this was a
27 strange statement from Deborah Davids. Deborah Davids' red BMW was parked in front of
28

1 Christine Harris' window at the time of this incident. After this event, there seemed to be a
2 constant state of electromagnetic radiation energy on her 24 hours a day, while at home, or
3 anywhere else. This constant state of electromagnetic radiation stopped when head of the CIA,
4 Leon Panetta, and Congresswoman Jan Schakowsky, said they were going to investigate a very
5 serious covert operation that was happening in the United States.

6 (<http://www.americanchronicle.com/articles/view/9752>) (EXHIBIT 12)

7 Christine Harris states this has been the most painful experience in her life. Her feet were
8 burned on the outside. Christine Harris did not take photos at the time due to being completely
9 traumatized. Christine Harris' eyes are damaged with scar tissue, suddenly causing her to have
10 very blurred vision. She proceeded to have eye exams to find a solution. Christine Harris has
11 lost some hearing, has lost her ability to hear some high-pitched noises, and has tinnitus. She has
12 exams to document her loss of hearing. Christine Harris had perfect vision and hearing up until
13 the first incident of these microwave weapons, which was in November 2008.

14 On or about February 19, 2009, Christine Harris went to see Mesha Irizzary. She put
15 Christine Harris in touch with a reporter, Marlon Crump, who has also experienced police
16 brutality. Marlon Crump has emotionally supported her, and helped Christine Harris cope with
17 being a victim of police brutality.

18 On February 23, 2009, Christine Harris went to the emergency room as she noticed her
19 physical condition was getting worse. Christine Harris had trouble breathing, and her organs felt
20 burned, and her feet had welts on them. She also noticed the whites of her eyes were yellowish
21 in color. Christine Harris researched this symptom and found that this could be an indication of
22 jaundice and liver damage. Christine Harris takes very good care of her body and the whites of
23 her eyes had been very white until this crime of violence. Electromagnetic radiation cannot be
24 detected in the human body with the technology that is currently available at hospitals. If there is
25 technology available, Christine Harris is not aware, nor has she been told about the possibility of
26 the technology being accessible to patients. The military has access to these weapons, according
27 to numerous internet resources, and possible access to medical technology to detect
28

1 electromagnetic radiation in the human body. These electromagnetic weapons render the victim
2 defenseless.

3 A document by the Department of the Navy, United States Army Intelligence and
4 Security Command, was given to Don Friedman, another victim of electromagnetic radiation
5 who has filed a lawsuit. This document provides information pertaining to the microwave
6 auditory effect, microwave hearing effect, Frey Effect, artificial telepathy, and/or any
7 device/weapon which uses and/or causes such effect, and any covert or undisclosed hypnosis.
8 This unclassified document is called *Bio-Effects of Selected Non-Lethal Weapons*. (EXHIBIT
9 13)

10 On or about February 25, 2009, Christine Harris sent the Bryant Square Lofts Board two
11 letters requesting mediation, or seminars, to have reconciliation. The Board responds denying
12 any disputes and refuses to meet with Christine Harris to resolve any issues.

13 On February 26, 2009, Christine Harris was with Marlon Crump at Peet's Coffee on 16th
14 Street and Bryant Street, by Trader Joes. Christine Harris had about 80 copies of the *Organized*
15 *Stalking* booklet in the trunk of her car. She opened the trunk and gave a copy to Marlon Crump.
16 Marlon Crump witnessed the booklets in the back of her trunk. Christine Harris left, to go see a
17 friend in the Marina district, and when she opened the trunk to get a booklet for her friend the
18 booklets were no longer there. Christine Harris has the receipt for the copies of the booklets.
19 She filed a police report for the incident (#090208543). (EXHIBIT 14)

20 On February 27, 2009 Christine Harris writes to Phil Bryan, Vice President of the HOA,
21 requesting mediation with Deborah Davids and Michelle Beazley. Christine Harris request this
22 letter be shared with all the Board members.

23 On Saturday, February 28, 2009 at 12:23 PM, Christine Harris writes to Derrick
24 Robinson, the president of Freedom From Covert Harassment and Surveillance, stating "I cannot
25 function normally anymore, cannot work out, can only handle this stuff. I will get copies of all
26 three police reports. We have our condo for sale because of all of this. My husband and I are
27 having a hard time, having mediation today, counseling for the first time in 9-1/2 years that we
28

1 have been together. My hands shake, most likely due to nerve damage. This is so unfair, so
2 unkind so inhumane.” The mediation counselor was Mesha Monge Irizzary.

3 Christine Harris realized there was a human rights organization Freedom From Covert
4 Harassment and Surveillance that was assisting victims of electromagnetic radiation weapons
5 and organized stalking, and she connected with them via internet. Wilson Law Center LLC,
6 Jonathan O. Wilson, Attorney at Law, was representing the group in a class action lawsuit.
7 (P.O. Box 1102, Morrison, Colorado, 80465, 720-219-8366, jon.wilson.law@hotmail.com,
8 www.WilsonLawCenter.com). Christine Harris filled out the forms to join the lawsuit. This
9 lawyer, for whatever reason (s) decided to cancel the case. (EXHIBIT 15)

10 On March 4, 2009, the Board of Bryant Square Lofts writes Christine Harris a letter
11 stating that Deborah Davids and Michelle Beazley “declined” to meet with her. The Board
12 decides to send another representative, Phil Bryan.

13 Sometime in March 2009, Christine Harris made an appointment to visit a radiation
14 oncologist, a referral through her general practitioner who she has known since fall of 1990. Her
15 appointment was confirmed, until one day, out of the blue, the doctor’s office called to cancel
16 her appointment. The doctor gave no reason for the cancellation.

17 On Friday, March 13, 2009, Christine Harris’ car was illegally towed from York Street,
18 San Francisco. After retrieving her car from the tow lot on Saturday, March 14, she notices the
19 citation ticket and the towing ticket did not have the same address noted. Christine Harris
20 emailed Bevan Dufty, San Francisco Board of Supervisors, to complain about the situation. He
21 states in an email that this ticket is not in their system. Christine Harris protested the citation,
22 and was successful. Christine Harris believes this was revenge. Christine Harris has strong
23 reason to believe they installed a GPS tracking device and a listening device in her car when it
24 was illegally towed. Christine Harris believes this due to the constant stalking by strangers,
25 police vehicles and by who she believes is Sergeant Raymond Beazley.

26 On March 20, 2009, Christine Harris emailed a friend to tell her what is happening to her.
27 The friend sent an email back telling her she has also experienced this directed energy,
28

1 electromagnetic radiation while working at a place near Christine Harris' residence, at the time
2 of 720 York Street, San Francisco, CA 94110.

3 In March, 2009, Marlon Crump, writes an article for Poor Magazine called *Electronic*
4 *Harassment* (<http://www.poormagazine.org/node/2303>). Marlon Crump has been a supporter and
5 advocate for Christine Harris and many of the victims in the San Francisco bay area. Marlon
6 Crump also wrote an online letter to President Barack Obama
7 (<http://www.poormagazine.org/node/2410>).

8 In March 2009, Christine Harris called a friend, Debra, who she has known since 1995 to
9 talk and to tell her about how her health is all of a sudden declining, after being perfectly healthy.
10 Her friend Debra concurs with Christine Harris about being gang stalked and harassed by police
11 officers, and then proceeds to tell Christine Harris, "We need to meet soon." Christine Harris
12 and her friend Debra met the next evening. Christine Harris brought over as much information
13 as possible. Her friend Debra said to Christine Harris "I knew you would know, as you research
14 everything". Debra works for an affluent architecture firm, and the wife, who owns her own
15 business related to architecture, put Debra on this "list" as well. Debra is coincidently a victim
16 of the same kinds of crimes.

17 On March 31, 2009, Christine Harris and James Jacobs meet with Phil Bryan, Vice
18 President of the HOA to discuss the gang stalking incident. Both Christine Harris and James
19 Jacobs did not tell Phil Bryan who they thought was involved in the crimes, they just wanted him
20 to know what was going on in the building. This same day, Christine Harris receives harassing
21 phone calls from people who pretend to be with AT & T, and a stalker who arrives claiming to
22 be with AT & T, leaving a hand written note on scratch paper at their unit door.

23 Sometime in April 2009, two tow trucks were parked behind Christine Harris' car on
24 York Street right in front of her home. Christine Harris notices this through her window and
25 went outside to confront the drivers. She has the conversation on video questioning one of the
26 drivers (<http://www.youtube.com/watch?v=i5-f2uYWNQM>). Side Line Towing (yellow truck),
27 San Francisco, CA, Truck #6011, license plate 7E17077. Christine Harris believes this was in
28

1 revenge and retaliation for the article that was written by reporter Marlon Crump. Christine
2 Harris chased them to video tape them so she could stop them from towing her car. (EXHIBIT
3 16)

4 On April 12, 2009, Christine Harris was flying back from Boston, MA to San Francisco,
5 CA with her husband on United, Flight #181 (gate C17 in Boston), departing at 2:39 PM
6 (confirmation #NBR JG9NLW). Christine Harris states "While I was watching a film, my head
7 started to hurt, and I never get headaches until all of these crimes, psychotronics and
8 electromagnetic radiation started. I realized that whoever was doing this was trying to use
9 synthetic telepathy on the plane. I looked up during the film, and saw a tall, Caucasian male in a
10 blue button down shirt, with dress pants, he was staring at me intently to see how I was reacting.
11 He was seated in 7C". If she is now part of an MKULTRA, this man may have been part of the
12 crimes and "experiment". There is even an organization (maybe more), called the United States
13 Psychotronic Association (<http://www.psychotronics.org>).

14 On April 15, 2009, Christine Harris talked with Cyndie Spanier who lives in
15 Pennsylvania, the psychologist for Freedom From Covert Harassment and Surveillance. Cyndie
16 Spanier counsels and supports trauma patients, victims of organized stalking, directed energy
17 weapons, and psychotronic weapons.

18 On April 24, 2009, Christine Harris wrote the San Francisco City Attorney to get a refund
19 on the illegal towing of her car associated with the dismissed citation from March 13, 2009. The
20 City Attorney sends a full refund to Christine Harris invoice #468599. (EXHIBIT 17)

21 In April 2009, Christine Harris met with Phil Bryan and her mediator, Mesha Monge-
22 Irizzary, for the issues and crimes that occurred at Bryant Square Lofts. They met at Starbucks
23 at the corner of Mariposa and Bryant Street, San Francisco. About ten police officers showed up
24 at Starbucks and surrounded Christine Harris and Mesha Monge-Irizzary while they initiated
25 their meeting in the café. Christine Harris, Phil Bryan, and Mesha Monge-Irizzary moved into
26 the private room inside Starbucks so they would not be harassed or intimidated. Phil Bryan told
27 Mesha and Christine that Deborah Davids was very angry that she received the Notice of
28

1 Complaint from the Attorney General of CA for not complying with the law. Christine Harris
2 noticed that Phil Bryan had a pair of small white speakers near his chest, hanging over his shirt.

3 Sometime in April 2009, stalkers were video taping Richard, Greg (other victims), and
4 Christine Harris, while they were at Peet's Coffee, by Safeway at 16th/Bryant Street shopping
5 center. The stalkers were driving a black Chevrolet truck, license plate number 7R35161, with a
6 frame around the plate with "Oakland" stated at the top, and "Chevrolet" at the bottom. Richard
7 Centeno used Christine Harris' cell phone camera and video taped the stalkers
8 (<http://www.youtube.com/watch?v=nlauEFHqY6Q>).

9 On May 13, 2009, Christine Harris and James Jacobs moved out of Bryant Square Lofts.
10 The moving company, Delancy Street Movers, required they get permits to secure curb areas for
11 loading at both locations, old and new. Christine Harris filed for the permits at the SFPD
12 Mission Street Station (where Sergeant Raymond Beazley happens to work).

13 On May 15, 2009 at 10:00 AM, Christine Harris experienced the electromagnetic
14 radiation (unseen weapons), directed energy weapons, again, and now directed at her heart.
15 Christine Harris felt as though she was near death again. James Jacobs drove Christine Harris to
16 the emergency room that evening. The emergency room doctors did not give her an IV, no pain
17 medication, no oxygen, nor anything else to help her. Christine Harris was upset, confused, and
18 disturbed since they had just moved, thinking the attacks would cease now being away from
19 Bryant Square Lofts.

20 On May 15, 2009, Christine Harris went to see a doctor in San Francisco's China Town.
21 Christine Harris made a call to her father, letting him know that she was badly burned, again, by
22 the electromagnetic weapons. After this phone call to her father, she was then followed at 12:40
23 PM by a dark blue under cover police car. She did not get the license plate as she was
24 traumatized and very nervous. Christine Harris contacted the Office of Citizen Complaint at
25 1:45 PM at 415-597-7711, and the California State Bar 800-528-6011. Christine Harris called
26 Mesha Monge-Irizzary for support.

27 In the spring and/or summer of 2009, Christine Harris had a phone call from 925-333-
28

1 9185, and many emails from taadev@gmail.com, taa@is.netcom.com, taadv@yahoo.com; a man
2 claiming to be a victim of the crimes, Tim W. Anderson. Christine Harris felt the need to have
3 this man investigated. Mesha Monge-Irizarry investigated Tim W. Anderson and found that he
4 may know Sergeant Raymond Beazley. Tim W. Anderson may have been in the Navy, may
5 have worked for MIT, and mentioned he is a computer programmer in a phone conversation to
6 Christine Harris. Christine Harris believes he may have access to this electromagnetic radiation
7 technology. Tim W. Anderson says he is a victim of the crimes, however, Christine Harris
8 believes, based on his strange emails and phone conversations, that this man may be directly
9 responsible for the operation of the technology. Anytime Christine Harris speaks out about Tim
10 W. Anderson, and the defendants, the organized stalking increases. Tim W. Anderson started a
11 Yahoo group, terror_stalking@yahoogroups.com. (EXHIBIT 18)

12 During the spring and summer of 2009, Christine Harris and James Jacobs noticed a very
13 unusual odor to Christine Harris' body. It was a stench one relates to decay. Her organs were
14 burned so badly that she started to "die" in her words. She had never smelled poorly before due
15 to hygiene and healthy eating habits. Christine Harris has worked relentlessly to heal her body
16 for the past two and a half years, until present.

17 On June 16, 2009, Christine Harris was in San Francisco's China Town with a friend.
18 When she returns to her car she saw a DVD that was placed by her door that said the word
19 "Murder" on it. She was unsure if this was directed at her, but it was strange, and made her very
20 fearful. Christine Harris did not take a video or photo, nor did she keep the DVD.

21 On July 23, 2009, Christine Harris was interviewed by reporter Myrna Lim of Access SF
22 Live. Dr. John Hall was also a guest on the show to speak about these covert crimes being
23 conducted on innocent victims.

27 On August 28, 2009, Senator Dianne Feinstein writes Christine Harris a letter stating that
28

1 she cannot help her. (EXHIBIT 19)

2 On August 29, 2009, Christine Harris writes to Congresswoman Jan Schakowsky,
3 Senator Barbara Boxer, and Senator Dianne Feinstein regarding organized stalking, and
4 electromagnetic weapons. (EXHIBIT 20)

5 In the month of October 2009, while seeing a doctor in Walnut Creek, CA, Christine
6 Harris was stalked again by who she believes to be Sergeant Raymond Beazley. A gray curly
7 haired man, with a mustache, the same man who stalked her on August 7, 2008 at 720 York
8 Street, San Francisco. However, in Walnut Creek, the man was not in uniform, and was driving
9 a large brown and tan motorcycle. The man was following Christine Harris along the driver side
10 of her car while heading west on Ygnacio Valley Road, Walnut Creek. By now, she was hoping
11 this would all go away and the stalking would stop.

12 On or about Wednesday, October 1, 2009, Christine Harris gave a speech at the San
13 Francisco Police Commissioner meeting. Christine Harris said to the Commissioners "I have
14 strong reason to believe that Sergeant Raymond Beazley, one of my perpetrators was stalking me
15 today on his SFPD motorcycle in his uniform. He came behind my car today in the early
16 afternoon while I was parking at Rainbow Grocery. He looked like the same person, on a
17 motorcycle, who was stalking me in Walnut Creek several weeks ago. He has gray hair, and a
18 mustache, and over weight." Christine Harris has never met Sergeant Raymond Beazley in
19 person face to face.

20 On or about October 1, 2009, Christine Harris filed paperwork with the Office of Citizens
21 Complaints (OCC) providing detailed dates of the crimes against her, including being stalked by
22 two under cover police officers, Michelle Beazley conspiring with her husband and President of
23 Bryant Square Lofts HOA. Christine Harris emailed, faxed, and sent via certified mail the dated
24 incidents to Office of Citizens Complaint. Christine Harris was given a case number (0780-09),
25 and assigned an investigator, Dennis Maxson. Christine Harris called the OCC at 2:05 PM on
26 October 1, 2009, at 415-241-7711, and spoke to Officer Tores. Christine Harris emailed the
27 Office of Citizens Complaint and requested to have mediation with Sergeant Raymond Beazley,
28

1 but she has yet to get a response from the Office of Citizens Complaint.

2 On October 6, 2009 around 2:00 PM Christine Harris checked her voice mail on her cell
3 phone. Officer Barcina (415-553-1141) left two messages on October 5, 2009, regarding
4 complaints to the OCC. Christine Harris returns the call and left a voice mail message. She
5 called a second time and the woman who answered the phone passed her along to the Psychology
6 Unit within SFPD. Christine Harris hung up and a few minutes later called again. She was
7 passed along to the Psychology Unit again. Christine Harris told this person, politely, this is not
8 what is needed from SFPD.

9 On October 13, 2009, Christine Harris receives a letter from the FBI, Washington, DC,
10 saying she cannot get a Freedom of Information Act to see if the Davids' or Beazley's put her on
11 the Main Core List as a "ghost detainee or under house arrest". The MKULTRA victims are
12 supposedly on this list.

13 Christine Harris has read in several articles (she did not save or know the exact
14 statement), that, during the Bush Sr. administration, the mind control victims, MKULTRA, were
15 put on the Main Core List, as a "ghost detainee" as under house arrest. She has heard that these
16 victims (like herself) of these crimes, may be on this "list" as well. Some victims may believe
17 that they have been put on a "list", un-consented, covert "experiment".

19 On October 14, 2009, Christine Harris takes part in organizing a Global Protest, in San
20 Francisco, CA for victims of electromagnetic weapons, organized stalking, and un-consented
21 human experiments. (<http://my.barackobama.com/page/community/post/soleilmavis/gGMy7L>)
22 (<http://peacepink.ning.com/profiles/blog/show?id=2351430:BlogPost:27729>)

23 On or about October 15, 2009, Christine Harris receives a letter from the Office of
24 Citizen Complaint, (SFPD, Case No. 0780-09) stating this is "out of OCC jurisdiction", and that
25 her "complaint is of "Informational Only". This letter is signed by Joyce M. Hicks, Executive
26 Director.

27 In the month of November, 2009 at 5:30 PM, Christine Harris attended a San Francisco
28

1 Police Commissioners meeting with retired FBI Agent, Ted Gunderson, and Doug Millar.

2 Christine Harris did not have a prepared speech, but spoke during public comment about the
3 crimes against her.

4 In the month of November, 2009 at 5:30 PM, Christine Harris gave a prepared speech at
5 the San Francisco Police Commissioners meeting about the crimes against her, and information
6 and resources about the crimes. (EXHIBIT 22)

7 On December 2, 2009 at 5:30 PM, Christine Harris gave a prepared speech at the San
8 Francisco Police Department Commissioners meeting of the crimes against her. (EXHIBIT 23)

9 On January 1, 2010 around 1:00 PM, Christine Harris and Richard Centeno, another
10 victim of these crimes, walked on Polk Street, San Francisco, CA, to have coffee at Peet's.
11 Christine Harris video taped a man, who they believe was stalking them based on his odd
12 behavior. (<http://www.youtube.com/watch?v=EAtIC1Px9CM>) (EXHIBIT 24)

13 On March 4, 2010, Christine Harris receives a call from a man at 415-434-0193 and said
14 he was with the Navy. She received another harassing call on March 8, 2010 from phone
15 number 650-603-9658. Neither of their names can be understood in their messages.

16 On March 9, 2010 at 1:20 PM, a man knocked at the door of Christine Harris' apartment
17 within a private, surveillance building. He was African American, about 6'-1", stating he was
18 from the Navy, with Navy brochures in his hand. Christine Harris asked him to leave the
19 building repeatedly, and finally had to escort him down three flights of stairs out the lobby door.
20 He drove away in an American made dark blue car. She has a video of this man entering into the
21 building. This is covert stalking, covert war, and harassment. She was on the phone with a
22 friend, Shinobi, so she has a witness to the conversation when she opened her front door
23 (<http://www.youtube.com/watch?v=4uQqe9ENGIQ>). (EXHIBIT 25)

24 On March 22, 2010, Christine Harris filed a police report (#100269126) of the stalker
25 who may have impersonated a U.S Naval officer.

26 In the month of March, 2010, Christine Harris receives a call from a woman at 415-760-
27 9187, claiming to be from the National Guard. She left a voice mail on Christine Harris' cell
28

1 phone.

2 On March 24, 2010, Christine Harris filed a police report on line (#106038440), for three
3 harassment calls she received from a private number. (EXHIBIT 26)

4 On March 24, 2010, at 5:30 PM, Christine Harris gave an extensive packet of information
5 to Lt. Reilly at the San Francisco Police Commissioner meeting. She did not speak during public
6 comment.

7 On Monday, March 29, 2010 at 7:12:52 PM, Christine Harris received a text message on
8 her cell phone, from phone number 510-409-9908: "Yeah, everyone, keep yourself clean.
9 Nothing they can use against you. Their MO is to arrest some dumb group of people and then go
10 after the real target who is usually someone who has a following, gets attention and is usually
11 outspoken. Since they monitor everything, they just keep u on the list." Christine Harris
12 received this text message after speaking on Dr. John Hall's show, "The Control Factor". This
13 phone number supposedly belongs to Sean Ackley (rhawk301@gmail.com). Sean Ackley claims
14 to be an activist with "We Are Change". Christine Harris filed a police report #100307544 of
15 the disturbing text message. Christine Harris had to email, fax, and call SFPD, and attend a San
16 Francisco Police Commissioner meeting, to retrieve a copy of this police report. (EXHIBIT 27)

17 On April 3, 2010 at 12:53 PM, Christine Harris was driving in San Francisco, at Clay and
18 Mason, when she was stalked again. She believes it was Sergeant Raymond Beazley, and the
19 same SFPD Sergeant (bald man), who was at her home on November 4, 2008. Both men were
20 riding on SFPD motorcycles. The man who she believes is Sergeant Raymond Beazley was
21 wearing a yellow rain coat. This stalking occurred right after she filed a police report on April 2,
22 2010, for the harassing, threatening text message she received.

23 On April 7, 2010 at 5:30 PM, Christine Harris gave a prepared speech at the San
24 Francisco Police Commissioner meeting during public comment. (EXHIBIT 28)

25 On April 8, 2010 Nathan Ny, a Staff Sergeant Recruiter for the U.S. Marines,
26 (Nathan.ny@marines.usme.mil, cell 408-422-0637), stopped by Christine Harris' home to
27 "recruit" her, leaving his business card for her to reach him. She emailed him once to let him
28

1 know he is not welcomed, nor have any reason, to contact Christine Harris in anyway. He
2 emailed Christine Harris back saying it was his job. Christine Lynn Harris is 46 years of age.
3 Her return message to him (copying public officials) noted to never contact her and that any
4 form of him or the military doing so will be viewed as harassment, and stalking. Nathan Ny's
5 business card reads: Marines, Lakeshore Plaza, Suite 333B, 1569 Sloat Blvd. San Francisco, CA
6 94123, Office 415-242-2113, Fax 415-242-2116. Christine Harris has never been, and would
7 never be, interested in joining the military.

8 On April 21, 2010, Christine Harris received a letter from F. Luo, SFPD, stating that
9 police report #100307544 was not on file and therefore they would not be able to give her a copy
10 for her records. However, they were able to send Christine Harris the police report request form
11 that she filled out, and send it back to her with her original envelope, but somehow "lost" the rest
12 of the important information and documents.

13 On April 27, 2010, Christine Harris request from Mesha Monge-Irizzary to write a letter
14 of support showing that Mesha Monge-Irizzary has assisted her during the time period of the
15 crimes against Christine Harris. (EXHIBIT 29)

16 On April 29, 2010 at 9:50 AM and at 10:53 AM, Christine Harris received two phone
17 calls from SFPD Officer Navaro regarding her many requests for a copy of her police report
18 #100307544. On the first call, Officer Navaro request she give a statement over the phone.
19 Christine Harris refuses and reminds him that she provided a statement via fax, email, and
20 mailed to every department at the San Francisco Police Department. Christine Harris states in an
21 email "I find all of this one big circus act since an officer, Sergeant Raymond Beazley, his wife
22 Michelle Beazley, Peter Davids, a lawyer with Jones Day Law Firm, his wife Deborah Davids,
23 President of my old HOA for 720 York Street, are all involved in conspiring to harm me, and
24 murder me. Police officers are supposed to protect and serve, not stalk, microwave, and terrorize
25 people who their wives disagree with".

26 It appears that these organized crimes and stalkers use a technique called gaslighting.
27 (Defined by Wikipedia: Gaslighting is a form of psychological abuse in which false information
28

1 is presented to the victim with the intent of making them doubt their own memory or perception).

2 On May 1, 2010 at 3:12 PM, SFPD calls Christine Harris' home phone (415-861-1041)
3 and does not leave a message.

4 On May 5, 2010 at 5:30 PM, Christine Harris gave a live, recorded statement on public
5 TV about the harassing/threatening text message she received, to the Chief of Police George
6 Gascon, and the San Francisco Police. She also commented on the fact that has not been able to
7 receive a copy of her police report (#100307544) she filed on April 2, 2010. (EXHIBIT 30)

8 On May 11, 2010 from 2:15 PM to 4:00 PM, Christine Harris spoke with Officer James
9 Ramsey from San Francisco Police Department Special Investigations, regarding the dated
10 incidents, and crimes against her. He said that SFPD was recording their conversation. He kept
11 suggesting Christine Harris speak with Officer Dunn, from the Psychology Unit, but she said
12 "this is not going to help me". Trust is not something she has for SFPD, as they are not on her
13 side nor are they her advocate. Officer Ramsey said that Sergeant Raymond Beazley is very
14 upset. Marlon Crump, reporter for Poor Magazine, was with Christine Harris as a witness to the
15 conversation.

16 On May 21, 2010, Christine Harris states in an email "Today I was driving on Harrison
17 Street about 12:10 PM, a police man, white with gray mustache fat was on a police motorcycle
18 driving next to me at Harrison and Division. His plate number was 294. Please, this same
19 person who I have strong reason to believe is Sergeant Raymond Beazley, he needs to stay far
20 away from me. He needs to stop stalking me. He stalks me each time I get a police report on all
21 the perpetrators, including himself." It is against California state law to stalk. This same man
22 has consistently stalked her for nearly two and a half years.

23 On May 27, 2010, the Executive Director of Office of Citizens Complaint, Joyce M.
24 Hicks, writes Christine Harris a letter, OCC Case No. 0288-10, stating "The allegation of
25 Conduct Reflecting Discredit on the Department against a police officer for inappropriate
26 behavior is of "No Finding".

27 On July 14, 2010 at 5:30 PM, Christine Harris attended the San Francisco Police
28

1 Commissioner meeting and gave a prepared speech during public comment about the crimes
2 against her. (EXHIBIT 31)

3 On August 18, 2010 at 5:30 PM, Christine Harris attended the San Francisco Police
4 Commissioner meeting and gave a prepared speech during public comment about the crimes
5 against her. (EXHIBIT 32)

6 On September 29, 2010 at 5:30 PM, Christine Harris attended the San Francisco Police
7 Commissioner meeting and gave a prepared speech during public comment about the crimes
8 against her. (EXHIBIT 33)

9 On September 10, 2010, Christine Harris' husband, James Jacobs, took their car to have it
10 detailed at California Detailing, 340 Fell Street, San Francisco, CA, a place that her husband has
11 used for more than a decade. Christine Harris drove the car the next day and noticed two interior
12 parts broken around the coin holder in the center counsel. Neither of these parts were broken
13 when delivered to the detailer. She noticed that the parts were both aggressively broken.
14 Christine Harris has reason to believe this is where someone came into the shop and bribed
15 Carlos, the shop manager, to take out the GPS system and listening device that she believes were
16 installed when the car was illegally towed on March 13, 2009. She is not making accusations, as
17 this is from observation, gut instinct, and common sense. When Christine Harris talked with
18 Jim, the owner, about the broken parts, he was defensive but ultimately replaced the parts in
19 kind. Jim, the shop owner, told Christine Harris it was very strange that his team, and Carlos,
20 had not reported the damage to the car to him, as they would normally do.

21 On October 1, 2010, Christine Harris received an unsolicited letter from Claude Wang,
22 Manager, at the US Postal Service, 1300 Evan Avenue, San Francisco, CA 94124, requesting she
23 use proper addresses when mailing. Christine Harris includes printed computer labels when
24 sending mail to anyone. She suspects Claude Wang is part of these organized stalking crimes.
25 Christine Harris sent him a return letter, copied to many public figures by mail, fax, and email,
26 asking for his cooperation in providing us the hate revenge "list".

27 On October 2, 2010, Dr. John Hall, Dr. Terry Robertson, both active members for
28

1 Freedom From Covert Harassment and Surveillance, and Dr. Peter Philips from Sonoma State
2 University (www.projectcensored.org), who has written an extensively on this topic held a
3 Multidisciplinary Symposium On Non-Consensual Experimentation And Electronic Harassment.
4 Christine Harris attended this symposium along with other select victims. (EXHIBIT 34)

5 On October 12, 2010, Christine Harris received a letter from the Bryant Square Lofts
6 attorney, Ann Rankin, threatening her with a lawsuit if she exposes Sergeant Raymond Beazley,
7 and Michelle Beazley, "and others". Christine Harris believes this letter was actually not written
8 by Ann Rankin, but was drafted by a "ghost writer", possibly Deborah Davids. The envelope is
9 the same color as Ann Rankin's stationary, however, the letter is printed on white paper, not the
10 typical colored stationary by Ms. Rankin's office. This may be fraud, forgery, identity theft, and
11 an illegal act impersonating a lawyer.

12 On October 12, 2010, Christine Harris received a letter from Speaker of The House,
13 Congresswoman Nancy Pelosi, stating Christine Harris should contact Kamala. D. Harris for her
14 concerns. Christine Harris contacted Kamala D. Harris in the very beginning of the crimes
15 against her, but she never had a response from the District Attorney, thus the reason for
16 contacting Speaker of The House, Congresswoman Nancy Pelosi.

17 On October 27, 2010, Christine Harris met friends Doug Millar, Peter Tscherneff, and
18 Michelle Schauer, in the basement floor of San Francisco City Hall. Before going to a San
19 Francisco Police Commissioner meeting, a man who goes by Raj Naicker was there stalking
20 Christine Harris again. Doug and Peter asked Raj Naicker for his identification, but he said he
21 did not have any. They filed reports, and have requested them, but to no avail. Sheriff's Deputy
22 Cabrera spoke with Christine Harris and wrote down information about being stalked by Raj
23 Naicker. Eight months prior, when Christine Harris first met and was stalked by Raj Naicker, he
24 made a comment to her "that she was on a list to be raped". She has notified SFPD at Police
25 Commissioner meetings of this disgraceful statement. SFPD has done nothing to protect
26 Christine Harris.

27 On October 29, 2010 at 9:30 AM, Christine Harris calls the San Francisco Sheriff's
28

1 Department (415-554-725) regarding Raj Naicker stalking her and saying she was on this list to
2 be raped. Raj Naicker always shows up at the San Francisco Police Commissioner meetings
3 when Christine Harris arrives. Christine Harris spoke to Katie at the Sheriff's Department and
4 said that her supervisor would contact her. No one from the San Francisco Sheriff's Department
5 has contacted her thus far. All of Christine Harris' constitutional, civil, and human rights have
6 been violated.

7 On November 17, 2010, Christine Harris sent a fax to Sheriff Michael Hennessey
8 requesting copies of the reports that she had filed on October 27, 2010 regarding Raj Naicker,
9 stalking and harassing Christine Harris. After getting no response, Christine Harris sent an email
10 to many public officials, including San Francisco Chief of Police George Gascon, and San
11 Francisco Special Investigations Officer James Ramsey. Christine Harris has yet to get a
12 response from the San Francisco Sheriff's Department.

13 On Friday afternoon of November 19, 2010, Doug Millar and Christine Harris went to the
14 San Francisco Sheriff's Department in person to request copies of the reports they had filed on
15 Raj Naicker on October 27, 2010. They spoke to Frederick Alonzo, Deputy Sheriff, Star #1357.
16 No reports have ever been given to Mrs. Harris to date on this incident.

17 On December 8, 2010, at 1:00 PM, Doug Millar (who made the appointment), Michele
18 Schrauer, Marlon Crump, and Ilberto Sophia, all of which are victims of these crimes, met with
19 two officers, inspectors of Internal Affairs, and Special Investigations Inspector Darcy Keller,
20 Star #2178. Christine Harris gave them a copy of her affidavit stating the crimes against her.
21 The conversation was held at 850 Bryant Street, room # 558, San Francisco, CA 94103, and
22 recorded on tape. Christine Harris has had no response from Inspector Darcy Keller.

23 On Saturday, January 8, 2011, Christine Harris called in a take out order (using her cell
24 phone, which is wire tapped), to Manora's Thai restaurant, 1600 Folsom Street, San Francisco,
25 CA, 94103. The following day both her husband and her became very ill, vomiting, severe
26 stomach cramps, and what they believe was attributed to food poisoning. Christine Harris and
27 James Jacobs have eaten at Manora's countless times with never any problems. After emailing
28

1 Manora's about the incident, they volunteer to reimburse Christine Harris. Christine Harris
2 thinks this may be related to the crimes against her. This could be a coincidence, however, most
3 victims of these crimes claim this is a common experience.

4 On January 12, 2011 at 5:30 PM, Christine Harris and Mesha Monge-Irizzary attended a
5 San Francisco Police Commissioner's meeting in support for a wheelchair victim being shot by
6 police officers. Christine Harris gave a speech in person. Once again, Raj Naicker was present
7 and proceeds to say disturbing things to Christine Harris, threatens her and her family, and was
8 not willing to look Christine Harris eye to eye. Christine Harris videotaped the harassment.
9 (http://www.youtube.com/watch?v=KrhSaAoQ_Rg). Raj Naicker threatens Christine Harris,
10 and her family, several times by saying, "They can attack you and your family, you have to be
11 careful", "Christine, listen, they could really hurt you", "You just have to be careful, they could
12 really attack you Christine". Christine Harris does not know who "they" are that Raj Naicker is
13 referring to (Christine Harris says to please forgive the "f" word in the video). Christine Harris
14 states "I am entirely disappointed that no one in our justice system is supporting me or stopping
15 the criminals." Christine Harris has attended many Police Commissioner meetings for
16 testimony, support, and for the crimes to stop, but the crimes have not ceased. SFPD has done
17 nothing for Christine Harris while trying to prevent her from speaking out against the defendants,
18 by harassing her, and intimidating her. SFPD has done everything to cover up for the crimes of
19 the defendants. (EXHIBIT 35)

20 On January 13, 2011 at 2:14 PM, Raj Naicker called Christine Harris, again, from phone
21 number 415-597-7759, to harass and intimidate her after she spoke at the January 12, 2010
22 Police Commissioner's meeting. Christine Harris did not answer the call. However, Raj Naicker
23 leaves a disturbing message. Christine Harris has repeatedly emailed Officer James Ramsey (the
24 contact of Raj Naicker, as Officer James Ramsey told her during their two hour phone interview
25 on May 11, 2010) requesting that Raj Naicker stop calling her, harassing, and stop stalking her at
26 meetings.

27 On January 14, 2011 at 1:41 PM, Raj Naicker called Christine Harris again from phone
28

1 number 415-597-7759, to harass and intimidate her. Christine Harris does not answer the call.
2 Raj Naicker leaves another disturbing message.

3 On January 21, 2011 at 1:38 PM, Raj Naicker called Christine Harris, again, from phone
4 number 415-597-7759. This call comes after Christine Harris made a phone call to the
5 courthouse requesting information on how to file for a lawsuit. The harassment always seems to
6 occur directly following any action Christine Harris takes to express the First Amendment Right
7 of Freedom of Speech. Christine Harris feels her phones are illegally wire tapped by the
8 defendants. Christine Harris has been constantly stalked by various police vehicles, and other
9 types of vehicles, since August 2008, until her car went into the detail shop on September 10,
10 2010. "I have never seen more police officers around me in my entire life", says Christine
11 Harris.

12 On January 22, 2011, Christine Harris received a letter from the Office Of The Inspector
13 General, United States Postal Service, dated January 18, 2011, responding to Christine Harris
14 inquiry and request for a hate revenge list from Mr. Claude Wang, Manager of US Postal
15 Service, San Francisco, CA. Mr. Claude sent Christine Harris a covert harassment letter
16 previously, so Christine Harris thought he may have access to this "list". P.E. Poulsen, Freedom
17 Of Information Act Analyst, 1735 N. Lynn Street, Arlington, VA 22209-2020, 703-248-2100 p,
18 703-248-4626, denies any such list exist.

19 On February 17, 2011, around 4:00 PM, Officer Kelly Dunn and Officer Choy, both
20 female, showed up unannounced at Christine Harris' husband office in downtown San Francisco,
21 CA. Officer Dunn told James Jacobs that she has been trying to reach his wife in person to
22 inform her that her case is closed. She also encouraged James Jacobs to have Christine Harris
23 come down to SFPD and talk to Officer Dunn (Kelly.dunn@sfgov.com, kelly.dunn@sfgov.org).
24 Christine Harris, and James Jacobs consider this to be another attempt to harass and intimidate,
25 and both are illegal. The San Francisco Police Department, and the perpetrators have violated
26 all United States Constitutional Laws, Civil Rights, and Human Rights. Christine Harris has the
27 right to speak out about the heinous organized crimes against her, and she will continue to do so.
28

1 The San Francisco Police Departments continual harassment, intimidation tactics, and
2 gaslighting, needs to cease and desist immediately.

3 Christine Harris, and other victims, noticed postings around San Francisco about this
4 organization stating that they may be connected to these organized crimes.

8 Christine Harris receives messages in her christinelynnharris@yahoo.com account about
9 police training and police schools, and the FBI. Christine Harris never received these kinds of
10 harassing emails until the retaliation started with Sergeant Raymond Beazley. Christine Harris
11 feels that many of the harassment tactics of Sergeant Raymond Beazley, the defendants, and
12 other involved parties' acts and behaviors are criminal. (EXHIBIT 37)

13 Jim Guest, State Representative from Jefferson City, Missouri, has written two letters
14 stating his support to the victims of electromagnetic radiation weapons torture, and covert
15 harassment groups, (other wise known as COINTELPRO, organized stalking). Document one
16 dated October 10, 2007 and document two dated May 21, 2009. (EXHIBIT 38)

17 Christine Harris' affidavit is included in this complaint. Christine Harris has given this
18 document to the Mayor of San Francisco (hand delivered), the Board of Supervisors of San
19 Francisco (hand delivered), the Sheriff of San Francisco (hand delivered), Senator Dianne
20 Feinstein (mailed), Senator Nancy Pelosi (mailed), U.S. Attorney General Melinda Haag (hand
21 delivered), and other public officials in the United States. Christine Harris has emailed the
22 crimes against her to the European Court for War Crimes, The World Court, and the
23 International Prosecutor. (EXHIBIT 39)

24 Christine Harris used to enjoy her very private life. Now she has become a person in the
25 public eye, and has written documents, letters, and emails to authorities all over the world.

26 Christine Harris is very concerned about the loss and invasion of her privacy. She is now a
27 victim of a complex organized crime scandal that no one wants to admit, claim, or do anything to
28

1 stop, investigate, or prosecute the defendants, and other perpetrators involved in these heinous
2 organized crimes. Since spring of 2008 until present, Christine Harris has been intentionally
3 harassed and has been put through things most humans would find disgraceful. Christine Harris
4 has done everything in her power to get help and support. No one is helping her. Christine
5 Harris is filing this lawsuit because she cannot find a lawyer to defend her, nor any public
6 officials. She has been suffering. Christine Harris did not know she could file a lawsuit in Pro
7 Se until recently. She feels that filing a federal lawsuit is the only means to stopping these
8 crimes and the defendants, and seeking retribution.

18 a. Whether Defendants Deborah Davids, Peter Davids, of San Francisco County,
19 Sergeant Raymond Beazley, and Michelle Beazley, of Contra Costa County, retaliated against
20 Plaintiffs for exercising their right to complain to government officials, which is protected by the
21 guarantee of freedom of speech in the First Amendment to the Constitution of the United States,
22 in violation of 42 U.S.C § 1983.

23 b. Whether Defendants Deborah Davids, and Peter Davids, of San Francisco County, and
24 Sergeant Raymond Beazley, and Michelle Beazley of Contra Costa County conspired to retaliate
25 against Plaintiffs for exercising their right to complain to government officials, which is
26 protected by the guarantee of freedom of speech in the First Amendment to the Constitution of
27 the United States, in violation of 42 U.S.C § 1983.

1 c. Whether Defendants Deborah Davids, and Peter Davids, of San Francisco County and
2 Sergeant Raymond Beazley, and Michelle Beazley, deprived Plaintiffs of their right to be
3 protected from having one's freedom of movement restrained, which is protected by the
4 guarantee of freedom from unreasonable seizures in the Fourth Amendment to the Constitution
5 of the United States, in violation of 42 U.S.C § 1983.

6 d. Whether Defendants County of San Francisco, Deborah Davids, and Peter Davids, and
7 Sergeant Raymond Beazley, and Michelle Beazley, conspired to deprive Plaintiffs of their right
8 to be protected from having one's freedom of movement restrained, which is protected by the
9 guarantee of freedom from unreasonable seizures in the Fourth Amendment to the Constitution
10 of the United States, in violation of 42 U.S.C § 1983.

11 e. Whether Defendant Deborah Davids, Peter Davids, Sergeant Raymond Beazley, and
12 Michelle Beazley, interfered with Plaintiff Christine Harris's Fourth Amendment right under the
13 United States Constitution to be free from unreasonable seizures by threatening or committing
14 violent act in violation of California Civil Code Section 52.1.

15 f. Whether Defendant of County of Contra Costa, Sergeant Raymond Beazley trespassed
16 upon Plaintiffs' real property when stalking her on the property, and, if Michelle Beazley gave

25 i. Whether Defendants Deborah Davids, Peter Davids, Sergeant Raymond Beazley, and
26 Michelle Beazley, violated Plaintiffs' equal protection rights under the 14th Amendment of the
27 Constitution to be free from "irrational and wholly arbitrary" actions.

6 (S.D.N.Y) 1972]. And subjection to organized stalking and stealth technologies utilized to
7 conduct myriad intrusions upon our person [See United States of America v. Lawrence Maynard,
8 (08-3030), p32 (U.S. Court of Appeals, D.C., August 6, 2010) where the court found that U. S.
9 Government’s prolonged GPS tracking of Jones “Indeed violates the intrusions every police
10 practice the Supreme Court has deemed a search under Katz].

11 dd. Deprivation of victim’s right to privacy, as well as the privacy of thought, as
12 interpreted by the U. S. Supreme Court Through our Bill of Rights, the 1st Amendment, (Privacy
13 of Beliefs), 3rd Amendment (Right Against Search and Seizure).

14 ee. The courts recognize that the stealth technologies exist and are in the hands of law
15 enforcement. In *Kyllo v. United States* [(99-8508) 533 U. S. 27 (2001) 190 F. 3d 1041], the
16 Supreme Court found that the use of an Agema Thermovision 210 thermal scan Kyllo’s home
17 was a violation of the 4th Amendment and his privacy rights. The Court also noted that: “The
18 ability to see through walls and other opaque barriers is a clear, and scientifically feasible, goal
19 of law enforcement research and development.” The National Law Enforcement and Corrections
20 Technology Center, a program within the United States Department of Justice, features on its
21 Internet Website projects that include a “Radar-Based Through-the-Wall Surveillance System,
22 Handheld Ultrasound Through the Wall Surveillance”, and a Radar Flashlight that “will enable
23 law officers to detect individuals through interior building walls” (nlectec.org/tech/proj. visited
24 May 3, 2011). Some devices may emit low levels of radiation that travel “through-the-wall,”
25 but others, such as more sophisticated thermal imaging devices, are entirely passive, or “off-the-
26 wall” as the dissent puts it [FN3].
