3. 10047 Hearing on the status of the October 26, 2010, Order of Determination in Kellee Lanza v District Attorney's Office.

Complainant Kellee Lanza said the District Attorney's Office representatives gave her a stack of documents a few minutes before the hearing started, and she had yet to inspect it to see if her request for public documents was satisfied. She also said in the interest of full disclosure, she has filed a petition with the Superior Court in San Francisco to force the DA's office to comply with the request.

Respondent Paul Henderson with the DA's Office presented members with a copy of the cover letter his office had provided to Ms. Lanza. Accompanying him were his staff who worked on Ms. Lanza's request.

To Member Johnson, Sandip Patel of the DA's Office said they have responded to all but two of the requests. He said they have asked the requestor to narrow two items on the list because it involved thousands of documents.

Chair Washburn said the response by the DA's Office this time around shows that the issue could have been solved months ago. She told them to work closely with the requestors and also to help identify the documents they need.

Member Johnson said the complainant clearly identified at the very beginning that she was from a public relations firm and with Karmala Harris running for the state Attorney-General's office, it was very clear that she wanted the documents before the elections. She said the cover letter that was provided to Ms. Lanza suggested that the DA's Office turned over more documents than was actually happened. She also said that in her view all indications was that the DA, who under Section 67.29-5 is required to provide her calendar within three days, did not want to turn it over before the election.

Mr. Henderson said the implication was incorrect because the political climate does not have any effect on the day-to-day operations of the department.

In closing, Mr. Henderson said a lot of effort and hard work was put into responding to the request. Ms. Lanza said she would be contacting the Task Force after having her counsel review the documents.

A motion was not presented because members did not know if the Order of Determination had been met.

Member Knee said as Task Force chair he will calendar the item for the November 30 meeting to review the status of the case.

Public Comment: Allen Grossman said Mr. Henderson knows that the work of responding to a public-records request and preparing documents for disclosure shall be considered part of the regular work duties of any city employee. He said there is a willful component in this matter because the DA's Office had taken five months to respond to the request.

4. Ethics Commission proposed policy for handling Sunshine-related complaints

Chair Washburn invited Mr. Grossman to participate as a non-voting member and be seated with other members of the committee. He declined the offer and said he preferred to stand at the dais.

Members then debated their approach to the Ethics Commission's proposal and agreed to meet December 4 to finalize their counter proposal. Member Snyder said he will have a comparison report ready by November 23 for inclusion in the November 30 agenda packet.
