No, these documents do not satsify my request. Section 67.29-7(c) regards the maintenance of financial records for "any contract, agreement or permit between the City and any outside entity that authorizes that entity to demand any funds or fees from citizens."

Clearly, any permits issued by the Permits & Reservations Division, whether at a for profit or not for profit fee category that authorize the permittee to demand any funds or fees from citizens for activities, programs, services, leagues, etc. that are conducted on public property are covered by the requirements of Section 67.29-7(c).

While Property Management permits for athletic instruction would be covered by this Section so to would any permits issued by the Permits & Reservations Division that allow the permittee to charge a fee or collect funds for any camps, clinics, programs, trainings, or leagues that are conducted on public property.
