# **Remote Meeting**

Members: Chris Hyland (Chair), Matt Yankee and Jaya Padmanabhan

1. CALL TO ORDER, ROLL CALL, AND AGENDA CHANGES

Chair Hyland called the meeting to order at 5:38 p.m. On the call of the roll Chair Hyland and Members Yankee and Padmanabhan were noted present. A quorum was present.

There were no agenda changes.

2. Adoption of the minutes for the August 10, 2021, Education, Outreach, and Training Committee meeting.

Action: Moved by Member Yankee, seconded by Chair Hyland to approve the August 10, 2021, meeting minutes with amendments.

**Public Comment:** 

Peter Warfield, Executive Director Library Users Assn., <a href="mailto:libraryusers2004@yahoo.com">libraryusers2004@yahoo.com</a>, P.O. Box 170544, San Francisco, California 94117-0544. Mr. Warfield expressed concern regarding incomplete minutes and provided examples.

Zack Karnazes commented on errors in the agenda and draft minutes.

3. **Public Comment**: Members of the public may address the Education, Outreach and Training Committee on matters that are within the Committee's jurisdiction but not on today's agenda.

# Speakers:

Zack Karnazes expressed concern regarding the passed meeting minutes and requested his email be added. Mr. Karnazes commented on disallowed disability accommodations, errors in scheduling and incorrect listing of Respondents.

Peter Warfield, Executive Director, Library Users Association expressed support of Mr. Karnazes and commented on summaries listed in the minutes by the Administrator. Mr. Warfield requested that members state their name when speaking.

Anonymous No. 3 expressed support of the previous speakers and commented on various improvements to committee procedures. Anonymous No. 3 stated that legal actions against boards and commission can get results.

4. **File No. 21081**: Complaint filed by Mary Miles against Tiffany Lin-Wilson, Philip Ginsberg and the Recreation and Parks Department for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.21 by failing to respond to a records request in a complete and/or timely manner; 67.24 by failing to provide public information; 67.25 by failing to respond in a complete and timely manner to an Immediate Disclosure Request; 67.26 by failing to provide non-minimum withholding, 67.27 by failing to provide written justification for withholding, 67.29-2 by failing to provide access to the Department Web Page; and 67.29-7 by failing to keep and preserve correspondence and records.

Mary Miles (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Ms. Miles provided a timeline on their request for records regarding the Great Highway. Ms. Miles stated that responsive documents have not yet been provided. Ms. Miles questioned why it took so long to get a response that no documents exist.

Tiffany Lin-Wilson (Recreation and Parks Dept.) (Respondent), provided a summary of the department's position. Ms. Lin-Wilson acknowledged that the response was not timely but stated that all responsive documents have since been provided. Ms. Lin-Wilson stated that there are no environmental review documents regarding the project as it does not exist. Ms. Lin-Wilson stated that the closure of the Great Highway was not planned but was in response to Covid-19 and there is the potential for an environmental review in the future.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Padmanabhan, seconded by Member Yankee, to find that the SOTF has jurisdiction, the records are public and to refer the matter to the SOTF for hearing with the recommendation to find a violation of Section 67.25 and 67.21(c) for timeliness and failing to provide assistance.

#### **Public Comment:**

Anonymous No. 3 expressed agreement with the motion with exceptions and suggestions. Anonymous stated that Capital Planning is part of the Recreation and Parks Department and not a separate department.

Moved by Member Padmanabhan, seconded by Member Yankee, to amend the motion to add recommended violations of Section 67.21(b) and CPRA 6253(c).

5. **File No. 21084**: Complaint filed by Charles Perkins and Concerned Residents of the Sunset against Phil Ginsburg and the Recreation and Parks Department for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.24 by failing to provide public information that must be disclosed; 67.25 by failing to respond in a complete and timely manner to an Immediate Disclosure Request; 67.27 by failing to provide written justification for withholding.

Charles Perkins (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Mr. Perkins provided a timeline and stated that no documents or response have been received regarding the closure of the Great Highway. Mr. Perkins stated that there has been no transparency in the process.

Tiffany Lin-Wilson (Recreation and Parks Dept.) (Respondent), provided a summary of the department's position. Ms. Lin-Wilson stated that she is the sole responder to Sunshine requests and there has been a significant increase in requests. Ms. Lin-Wilson acknowledged that she is still working on responding to the large/robust request from Mr. Perkins.

The Committee suggested the Respondent provide a summary and timeline of their proposed response.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Yankee, seconded by Member Padmanabhan, to find that the SOTF has jurisdiction, the records are public and to refer the matter to the SOTF for hearing. The Committee noted the Ethics Commission has previously found violations and referred the matter to the SOTF for hearing. The Committee found that no records have been disclosed since the Ethics Commission referred to the SOTF and suggest consideration of willful violation (Section 67.34) of General Manger Phil Ginsberg, Recreation and Parks Department.

#### **Public Comment:**

Anonymous No. 3 expressed agreement with the motion with exceptions and suggestions.

Peter Warfield, Executive Director, Library Users Association expressed support of the motion and previous comments. Mr. Warfield provided suggestions to amend the motion.

Moved by Member Yankee, seconded by Member Padmanabhan, to amend the motion to add a recommended violation of Section 67.25(d) by failing to provide documents on a rolling basis.

The motion PASSED by the following vote:

Ayes: 3 - Yankee, Padmanabhan, Hyland

Noes: 0 - None

6. **File No. 21096**: Complaint filed by Michael Petrelis against District Attorney Chesa Boudin and the Office of the District Attorney for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.25 by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner.

The Petitioner was not present and did not communicate with the SOTF.

Robin Burke (Office of The District Attorney); (Respondent), provided a summary of the department's position. Ms. Burke stated a response was provided by the next day requesting an extension of time of 14 days. Ms. Burke stated they requested a narrowing of the request but did not receive a response. Ms. Burke stated that a response was not received and therefore proceeded to provide documents on a rolling basis.

Moved by Member Yankee, seconded by Member Padmanabhan, to table/file the matter without prejudice due to non-attendance by the Petitioner.

#### **Public Comment:**

Anonymous No. 3 commented on the fact that the Respondent changed their mind and provided documents two days prior to the meeting. Anonymous No. 3 stated that the Department may request a narrowing of the request but it is not required.

Peter Warfield, Executive Director, Library Users Association expressed concerns related to last minute compliance. Mr. Warfield stated that the Petitioner is not required to attend the SOTF hearing and requested a definition of tabling.

Chair Hyland commented that it is the practice of the SOTF to add full contact information the first time it is presented and is abbreviated throughout the remainder of the agenda.

#### **Public Comment:**

Peter Warfield, Executive Director, Library Users Association, stated that it is not clear where the policy was created and where is it documented regarding the contact information listed in the minutes. Mr. Warfield stated the others are not familiar with the process and suggested changes to agenda information provided.

Anonymous No. 3 suggested that SOTF develop ideas for citywide training on future agendas.

There being no further business the meeting was adjourned at 7:47 p.m.

Public Comment will be taken before or during the Committee's consideration of each agenda item. Speakers may address the Task Force for up to three minutes on that item. During General Public Comment, members of the public may address the Task Force on matters that are within the Task Force's jurisdiction and are not on the agenda. Any person speaking during a public comment period may supply a brief written summary of their comments, which shall, if no more than 150 words, be included in the official file.

Each member of the public will be allotted the same maximum number of minutes to speak as set by the Chair at the beginning of each item, excluding persons requested by the Task Force to make presentations, except that public speakers using interpretation assistance will be allowed to testify for twice the amount of the public testimony time limit. If simultaneous interpretation services are used, speakers will be governed by the public testimony time limit applied to speakers not requesting interpretation assistance.

Each member of the public who is unable to attend the public meeting or hearing may submit to the City, by the time the hearing begins, written comments regarding the agenda items.
