1. CALL TO ORDER, ROLL CALL, AND AGENDA CHANGES

Chair Hyland called the meeting to order at 5:35 p.m. On the call of the roll Chair Hyland and Members Pilpel and Hill were noted present. Also present Cheryl Leger, SOTF Administrator, Patricia Peterson, Clerk of the Board staff and Victor Young, Clerk of the Board staff (on line). A quorum was present.

There were no agenda changes.

2. Approval of the minutes from the Education, Outreach, and Training Committee September 26, 2023 regular meeting.

Action: Moved by Member Pilpel, seconded by Member Hill to approve the minutes with recommended edits.

3. **Public Comment:** Members of the public may address the Education, Outreach, and Training Committee on matters that are within the Committee's jurisdiction, but not on today's agenda. (*No Action*).

4. **File No. 20055:** Hearing on the status of Complaint filed by Liza Murawski against the Department of Public Health for violating Administrative Code (Sunshine Ordinance), Section 67.21, by failing to respond to a records request in a timely and/or complete manner.

Liza Murawski (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Ms. Murawski stated that this case is about client to case management ratio, not Chapter 12L (access to nonprofit organization records) 12(L) exemptions. Ms. Murawski stated that former Department of Public Health (DPH) employee Veronica Vien did provide some records, including dates for case management ratios with breakdowns of organizations and mental health service support programs.

Victor Lim (DPH, Respondent), provided a summary of the department's position. Mr. Lim stated that this case took place before his time at DPH. Mr. Lim stated that DPH employee Natalie Pojman told Ms. Murawski that there are no responsive records. Mr. Lim stated that he will investigate the matter further and compile a list of records to be disclosed.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Chair Hyland, seconded by Member Hill, to close the matter.

Public Comment:

Liza Wynn suggested following the money trail.

Ms. Joy stated that she used to live in a rent-controlled building, has since moved and that this experience has been the worst of her life.

5. **File No. 21125:** Complaint filed by Liza Murawski against Conard Mental Health Inc. and the Department of Public Health for violating Administrative Code (Sunshine Ordinance), Section 67.21, by failing to respond to a records request in a timely and/or complete manner.

Liza Murawski (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Ms. Murawski stated that Conard House took a survey about contracted support which is against the law. Ms. Murawski stated that this process has been a waste of her time.

Victor Lim (DPH, Respondent), provided a summary of the department's position. Mr. Lim stated that he investigated the last response from Ann Quaintance of Conard and the survey results are not public and DPH doesn't have any responsive records.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Pilpel seconded by Member Hill to refer the matter to the Task Force Consent Agenda with a recommendation for no violation of Administrative Code, Sunshine Ordinance, Section 67.21. The Committee also requested that the Department of Public Health treat this case as a 12.L5(b) matter and conduct a review.

6. **File No. 23065:** Complaint filed by Maria Schulman against Lila LaHood, Chair of the Sunshine Ordinance Task Force Compliance and Amendments Committee, for allegedly violating Administrative Code (Sunshine Ordinance), Section 67.25, by failing to respond to an Immediate Disclosure Request in a complete and/or timely manner.

Maria Schulman (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Ms. Schulman stated that the Respondent has already acknowledged the complaint and taken immediate steps to correct the issue. Ms. Schulman stated that there was a committee meeting and Ms. Schulman's complaint was removed from the agenda without first consulting her. Ms. Schulman stated that she is concerned about Task Force procedures being followed.

Lila LaHood (Sunshine Ordinance Task Force, Respondent), was not present for the hearing and did not notify the Task Force Administrator of her absence.

A question and answer period occurred.

Action: Moved by Member Hill, seconded by Chair Hyland to find that the Task Force has jurisdiction, the requested records are public and to forward to the Task Force with no recommendation for a violation. The Committee recommends that all Task Force members set up an auto responder on their Task Force email accounts that direct inquiries to the Task Force clerk.

The Committee recommended that all Task Force members set up an auto responder on their Task Force email accounts that direct inquiries to the Task Force Administrator.

7. **File No. 23043** Complaint filed by Maria Schulman against the Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Section 67.21, by failing to respond to a records request in a timely and/or complete manner.

Maria Schulman (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Ms. Schulman stated that the Respondent did not provide keyed redactions and failed to keep redactions to a minimum. Ms. Schulman also stated that the names of various city employees were also redacted and that the redactions seemed random. Ms. Schulman also noted that attachments to emails were not provided.

Lt. William Toomey (Police Department, Respondent), provided a summary of the department's position. Lt. Toomey stated that there is only person who works the Vicious and Dangerous Dogs Unit and redacts records. This person is not familiar with city employees or the records used and sought advice from the City Attorney. Lt. Toomey further stated that they receive emails as pdfs without attachments. The attachments are screen shots, and the Police Departments makes every effort to provide those records when requested.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Pilpel seconded by Member Hill to find that the Task Force has jurisdiction, that the requested records are public, and to refer the matter to the Task Force Consent Calendar with recommendation to find violations of Administrative Code (Sunshine Ordinance) Section of 67.21 by failing to provide records in a timely and/or complete manner and 67.27 for improper justification for redactions. The Committee also requested the Police Department to codify its redaction policy and provide that policy to the Task Force.

8. **File No. 23047:** Complaint filed by Maria Schulman against the Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a records request in a timely and/or complete manner, and 67.26, by failing to keep withholding to a minimum.

Maria Schulman (Petitioner) withdrew the complaint.

Lt. William Toomey (Police Department, Respondent), was present for the hearing.
