Public Comment: Kimo Crossman expressed disappointment that it took more than two months for the City Attorney's Office to respond to his petition.

6. Administrator's Report, Complaints, Communications, and Meeting Schedule.

Administrator Leger presented the Administrator's Report to the Task Force and responded to questions.

Member LaHood stated that the Compliance and Amendments Committee meeting scheduled for December 24, 2024 is canceled.

7. **Public Comment:** Members of the public may address the Sunshine Ordinance Task Force (SOTF) on matters that are within SOTF's jurisdiction, but not on today's agenda. *Public comment shall be taken at 5:00 p.m. or as soon thereafter as possible.* (No Action)

Chris Ward Kline stated that he gave a presentation on August 5, 2024 to the Health Commission outlining how our City has partnered with Johns Hopkins University to hide records. Mr. Kline also noted that he spoke to the House of Representatives Judiciary Committee on how records are being hidden.

- 8. **CONSENT AGENDA** The Sunshine Ordinance Task Force shall review **File Nos. 23068**, **24020**, **24025** and **24028** to affirm the Committee's findings regarding the Sunshine Ordinance Task Force's jurisdiction; violations of the Sunshine Ordinance, Brown Act, or California Public Records Act; and, if applicable, to issue an Order of Determination and refer matters to a Committee for monitoring. The Complainant and Respondent are *not required to attend the August 7*, **2024**, Sunshine Ordinance Task Force meeting but may attend to provide testimony during the public comment period. (*Discussion and Action*)
  - **8A. File No. 23068:** Complaint filed by Laurent Philonenko against Phil Ginsburg and the Recreation and Parks Department for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to provide public records in a timely and/or complete manner; 67.28, by failing to make public records available for inspection and copying; and California Public Records Act (CPRA) Section 6253(a), by failing to allow public records to be available for inspection.

(On 7/16/2024, the Complaint Committee found that the Task Force has jurisdiction over the matter, that the requested records are public, and referred the matter to the Task Force Consent Agenda with a finding of no violation because the requested records appeared to have been provided in a timely manner.

**8B. File No. 24020** Complaint filed by Beth Winegarner against David Serrano Sewell and the Office of the Chief Medical Examiner for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a public records request in a timely and/or complete manner.

(On 5/28/2024, the Education, Outreach and Training Committee found that the Task Force has jurisdiction over the matter, that the requested records are public, and referred the matter to the Task Force Consent Calendar with a recommendation to find a violation that the Office of the Medical Examiner violated Administrative Code Section(s) 67.21(b) by failing to respond to a public records request in a timely and complete manner.

The Respondent acknowledged that the referenced violation occurred.

8C. File No. 24025: Complaint filed by Anonymous (SFPD) against the Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a public records request in a timely and/or complete manner; 67.25(a)(d), by failing to respond to an Immediate Disclosure Request in a timely and complete manner and if needed provide requested records on a rolling basis, and 67.34, for willful violation.

(On 5/28/2024, the Education, Outreach and Training Committee found that the Task Force has jurisdiction over the matter, that the requested records are public, and referred the matter to the full Task Force Consent Calendar with a recommendation that no violation occurred.

The EOTC also recognized that the efforts of the Police Department were above and beyond what was necessary to satisfy Complainant's request for higher-resolution photos.

**8D. File No. 24028:** Complaint filed by HVSafe against the Municipal Transportation Agency for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.25, for failing to respond to an Immediate Disclosure Request in a timely and/or complete manner, and California Public Records Act Section 6253, for failure to provide a determination of disclosable public records within 10 days.

(On 7/16/2024, the Complaint Committee found find that the Task Force has jurisdiction over the matter, that the requested records are public, and referred the matter to the Task Force Consent Agenda with a finding of a violation of Administrative Code (Sunshine Ordinance), Section(s) 67.25 for failing to respond to an Immediate Disclosure Request in a timely manner as both Petitioner and Respondent acknowledge that the documents were provided late.

Action: Moved by Member Pilpel, seconded by Member Anderson, to accept the recommendations of the Committee and approve the Consent Agenda.

Public Comment: Anonymous speaker questioned the citation of the identification.

9. **File No. 23067** Complaint filed by Kimo Crossman against the Office of the Chief Medical Examiner for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to provide public records in a timely and/or complete manner; 67.28, by failing to make public records available for inspection and copying; California Public Records Act (CPRA) Section 6253(a), by failing to allow public records to be available for inspection; and Section 6253.1(a), by failing to allow access to an electronic public record.

Kimo Crossman (Petitioner) provided a summary of his complaint. Mr. Crossman had a neighbor who died suddenly and was left in his apartment for two weeks before anyone noticed that the neighbor had not been seen. Mr. Crossman contacted the Office of the Chief Medical Examiner and asked for a report on the neighbor's death and was told that the cost was \$49 for a certified copy. Mr. Crossman eventually paid the fee, and the records were provided. Mr. Crossman believes that people should not be charged for a public record such as this.

Vivian Po (City Administrator's Office, on behalf of the Respondent) provided a summary of the department's position. Ms. Po stated that the requested records were provided timely, that the Office did not refuse to allow Mr. Crossman to go to the office, just that he cannot use any recording devices due to the sensitive nature of the records in the office. Ms. Po stated that going forward the Office of the Chief Medical Examiner will no longer charge a fee for a non-certified copy of a record and that Mr. Crossman will be refunded his money.

Action: Moved by Member LaHood, seconded by Member Schmidt, to find a violation of Administrative Code (Sunshine Ordinance) Section 67.28, against the Office of the Chief Medical Examiner, for charging a member of the public for a public record and ordered the Off,ice of the Chief Medical Examiner to make available to members of the public an electronic copy at no charge and send a verification to the Task Force Administrator that these changes will take place within 10 days.

Public Comment: Nick Pasquariello asked why in all these past years the office had not been challenged about this issue before.

The meeting was in recess from 6:04 p.m. until 6:38 p.m.. Roll call was taken. Per Item No. 1, Item 11 was heard before Item 10.

10. **File No. 23086:** Complaint filed by Mike Spencer against the Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a records request in a timely and/or complete manner.

Mike Spencer (Petitioner) provided a summary of his complaint. Mr. Spencer requested access to audio recordings of this case in 2001 and 2014 but was denied access both times. Mr. Spencer stated that 64 people were interviewed and the file has some handwritten notes which included case notes for six or seven specific witnesses.

Lt. Christopher Beauchamp (Police Department, Respondent) provided a summary of the department's position. Lt. Beauchamp stated that he was in receipt of the document and was able to verify that the Police Department provided it. Lt. Beauchamp noted that there remain approximately 700 pages of records and hopes to have 450 of those reviewed by the end of the month. Lt. Beauchamp stated that there are CLETS records that are confidential and cannot be released and that there are recordings that could be easily damaged while handling.

A question-and-answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Chair Yankee, seconded Member Pilpel, to find a violation of Administrative Code (Sunshine Ordinance) Section(s) 67.21, for lack of timely disclosure of public records and the improper reliance on Section 67.24(d); requesting that the Police Department propose a procedure to implement Section 67.24(d) in coordination with the District Attorney and provide that language to the Task Force for a follow-up hearing at the Compliance and Amendments Committee.

11. **File No. 23081** Complaint filed by Zahir Nasri against San Francisco International Airport (Ground Transportation Unit) for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21. by failing to provide public records in a timely and/or complete manner.

Zahir Nasri (Petitioner) provided a summary of his complaint. Mr. Nasri stated that in July 2023 he requested surveillance records and the directions to zoom the first five minutes of footage. Mr. Nasri stated the Airport only provided footage of the back of him. Mr. Nasri stated that there was a camera that did not provide information but that clearly shows unlawful actions and requested those documents in the Airport's possession. Mr. Nasri also requested the radio communications that show the staff using derogatory and racist slurs over the radio.

Doug Yakel (San Francisco International Airport's Respondent) provided a summary of the department's position. Mr. Yakel stated that on July 10, 2023 and July 17, 2023, the Airport provided responsive records. Mr. Yakel also stated that on July 21, 2023 the Airport produced another batch of records but withheld some documents due to a pending investigation. Mr. Yakel stated that 226 pages of records were provided to Mr. Nasri. In addition, Mr. Nasri was provided with all recordings in real time and video records that can zoom in at any time.

A question-and-answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Pilpel, seconded by Member Anderson, to find a violation of Administrative Code, Sunshine Ordinance Section 67.21 for failure to provide public records in a timely manner regarding three radio communications provided in October 2023 and orders the Airport to review five video camera feeds of 18 minutes each and initial radio communications and either provide those to the requestor, or confirm that they are unavailable, and copy the Task Force Administrator.

Public Comment: None.

12. **File No. 23095:** Complaint filed by Mark LaCroix against the San Francisco Fire Commission for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.10(b), by failing to consider the appointment, employment, evaluation of performance, or dismissal of a City employee, if the policy body has the authority to appoint, employ, or dismiss the employee, or to hear complaints or charges brought against the employee by another person or employee unless the employee complained of requests a public hearing; 67.21, respond to a public records request in a timely and/or complete manner; 67.11 prior to any closed session, a policy body shall state the general reason or reasons for the closed session, and shall cite the statutory authority, including the specific section and subdivision, or other legal authority under which the session is being held; and 67.12, by failing to properly disclose closed session discussions and actions.

Mark LaCroix (Petitioner) provided a summary of his complaint. Mr. LaCroix stated that on November 26, 2022 the Fire Commission held a meeting and voted to go into closed session to deliberate the validity of the dismissal charges against Mr. LaCroix from the Fire Department. Mr. LaCroix states that the Fire Department did not properly notice the closed session and the Department contends that proper notice was provided.

Maureen Conefrey (Fire Commission's Respondent), provided a summary of the department's position. Ms. Conefrey stated that in September 2022 the Fire Chief filed a non-disciplinary separation from the Department of Mark LaCroix that included the correct statutory citations. The parties were to submit records prior to the November 29, 2022. The hearing was rescheduled to April 26, 2023 and the agenda was posted prior to the meeting. The Fire Commission held deliberations in closed session, then in open session, deliberated and then in closed session. Ms. Conefrey stated that Administrative Code (Sunshine Ordinance) Section 67.10 allowed the closed session regarding a personnel matter. Ms. Conefrey also noted that an employee has the right to ask that the body conduct deliberations in open session.

Action: Moved by Chair Yankee, second by Member Kumar, to find a violation of Administrative Code (Sunshine Ordinance) Section 67.11, for not citing the proper statutory authority.

Public Comment: Anonymous noted that Ms. Conefrey is confusing the hearing dates and that it was impossible to dismiss Mr. LaCroix from his job based if the procedures were followed properly. Anonymous #2 stated that this hearing decides the validity of the process and not the charges against Mr. LaCroix.

Action: Moved by Member Pilpel, to find a violation of Administrative Code (Sunshine Ordinance) Section 67.10(b), for holding a closed session on a motion to dismiss.

The motion FAILED due to a lack of a second.

13. **File No. 23099:** Complaint filed by Mark LaCroix against the San Francisco Fire Commission for allegedly violating Administrative Code (Sunshine Ordinance) Section 67.5, by failing to conduct open and public meetings of a policy body; 67.10, by conducting a closed session hearing on a non-permitted topic, and 67.11, by failing to properly notice a closed session hearing.

Mark LaCroix (Petitioner) provided a summary of his complaint. Mr. LaCroix stated that his separation hearing should have been noticed as a separation hearing, but it was not. Mr. LaCroix stated that the information on the agenda did not include items that were to be addressed. Mr. LaCroix stated that there was no information on the agenda that indicated his dismissal would be reviewed.

Maureen Conefrey (Fire Commission's Respondent) provided a summary of the department's position. Mr. Conefrey stated that the closed session was entirely proper and the process regarding a dismissal can include a discussion of other dismissals by the Commission. Ms. Conefrey also stated that the body can go into closed session to discuss dismissal of specific employees.

A question-and-answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Pilpel, seconded by Member LaHood, to find a violation of Administrative Code (Sunshine Ordinance) Section 67.10(b), regarding the January 12, 2022 Fire Commission meeting as to item 5C.

Public Comment: Anonymous #1 stated that the Sunshine Ordinance is a great thing and he wants to thank Mr. LaCroix for his brave service. Anonymous #2 stated that it is important to have procedures at Fire Commission hearings and to have protection for due process. Anonymous #3 stated that this is a red flag for the Task Force to consider because there may be multiple violations.

Public Comment: Anonymous stated that even though the Fire Commission destroyed the due process by violating every code and to disseminate the changes, the Task Force has the power to end all this.
