Public Comment: Mark LaCroix stated that he did not know if the Fire Commission had been notified of the Order of Determination in File 23099 and that the Order of Determination needs to be corrected to indicate the correct date of the meeting at issue.

Peter Warfield, Executive Director, Library Users Association, libraryusers2004@yahoo.com, P.O. Box 170544, San Francisco, California, 94117-0544, stated that he wants items for follow up sent to the State Office of the Attorney General, and wants the Administrator to work with Chair Yankee for a letter to be sent to the Board of Supervisors.

Maureen Conefrey stated that the conversation following Mark LaCroix's public comment regarding whether to agendize a discussion of a process for Mr. LaCroix to return to the Task force to confirm whether a violation of the Order of Determination had occurred was unfair.

(On 2/25/2025, Respondent responded to a Notice to Respondent, and stated that SF 311 declared no-contest to all allegations in the complaint, had reassessed its processes, and would be adding the functionality for submitting written records requests to its website.)

9. File 25014: Complaint filed Anmarie against the Fine Arts Museums of San Francsico for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.5, by failing to hold open meetings, 67.7 by failing to post an agenda, and 67.16, by failing to record and post minutes of regular and special meetings of the board or commission. (On 2/25/2025, Respondent responded to a Notice to Respondent, and stated that the Fine Arts Museums of San Francisco declared no-contest to all allegations.)

COMPLAINT HEARING AGENDA – Items 10 through 14

10. File No. 22010: Complaint filed by Ron Cicero against the Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a public records request in a timely and/or complete manner. (02:24:55)

(On 2/4/2025, the Ethics Commission's Director of Enforcement issued a letter dismissing the Task Force's Ethics Complaint No. 24-818 after conducting a preliminary review, and an investigation was not opened. The SOTF's legal counsel determined that the 2/4/2025 letter is not an investigatory record and may be shared publicly.)

The members discussed the response from the Ethics Commission.

Action: Moved by Member Schmidt, seconded by Member Wolfe, to find that the Ethics Commission failed to act properly and handle the matter as required by Administrative Code (Sunshine Ordinance), Section 67.34, with reference to Section 67.30(c) where it states that the Task Force shall, from time to time as it sees fit, issue public reports evaluating compliance with this ordinance and related California laws by the City or any Department, Office, or Official thereof.

Public Comment: Mark LaCroix commended Deputy City Attorney Lopez for her response regarding whether the letter from the Ethics Commission was an investigatory record.

11. **File No. 25004**: Complaint filed by Gabriel Greschler v. Human Rights Commission (Request 24-5534) for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a public records request in a timely and/or complete manner. (03:24:52)

Gabriel Greschler (Complainant) stated that the Human Rights Commission has public records beyond the deadline in response to a request sent 9/17/2024. Mr. Greschler stated that Respondent exercised the option of an extension, but nearly half a year later these records have not been produced.

Mawuli Tugbenyoh (Respondent) stated that no records have been produced. Mr. Tugbenyoh further stated that they have communicated to Complainant that the department has insufficient staff and that ongoing investigations are affecting their ability to issue responses. Mr. Tugbenyoh stated that Amelia Martinez, Operations Manager, steps in to assist with Public Records Requests when the Public Information Officer is unavailable, and that they had previously received part-time assistance the Department of Human Resources. Mr. Tugbenyoh stated that some of the documents had been pulled, that they can provide some of the documents 10 days and the rest on a rolling basis.

Action: Moved by Chair Yankee, seconded by Member Pilpel, to find that the Task Force has jurisdiction, that the requested records are public, and find a violation of Administrative Code (Sunshine Ordinance), Section 67.21(b), by failing to respond to a public records request in a timely and/or complete manner, and order the department to fulfill the request within five (5) business days, and refer the matter to the Compliance and Amendments Committee for compliance monitoring.

Public Comment: Charlie Obermeyer stated there is now reason to not provide the records requested here, particularly when there is value in producing financial records.

12. File No. 25007: Complaint filed by Gabriel Greschler v. Human Rights Commission (Request 24-5723) for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a public records request in a timely and/or complete manner. (04:03:15)

Gabriel Greschler (Complainant) stated that this request is for records about non-profit receiving funds from the Human Rights Commission that were spent on first class flights, expensive meals, and tickets to a San Francisco musical. Mr. Greschler further stated that these expenses were found in the non-profit's financial records.

Mawuli Tugbenyoh (Respondent) stated that documents have not been provided to Mr. Greschler documents and is unable to say how long it will take to produce the records.

Action: Moved by Chair Yankee, seconded by Member Pilpel, to find that the Task Force has jurisdiction, that the requested records are public, and find a violation of Administrative Code (Sunshine Ordinance), Section 67.21(b), by failing to respond to a public records request in a timely and/or complete manner, and order the department to fulfill the request within five (5) business days, and refer the matter to the Compliance and Amendments Committee for compliance monitoring.

Public Comment: None.

13. File No. 25006: Complaint filed by Mark LaCroix against the San Francisco Fire Commission for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.5, regarding public meetings or a permitted closed session within a public meeting, Section 67.15 by failing to provide the right to an opportunity to address a policy body on items within the policy body's subject matter jurisdiction, and 67.21, by failing to respond to a public request in a timely and or complete manner. (04:19:21)

(On 2/18/2025 the Complaint Committee found that these are public meetings and records involved, that there is one jurisdiction question to be considered by the full Task Force because there is potential jurisdiction on two specific items that the Committee recommends, that the Task Force find no violation of 67.21(b) but consider the other claims, and whether the Task Force has jurisdiction associated with the decision-making process that was done administratively on the closed session denial and the back pay appeal denial (documents Item 3 and 5 in the request), primarily in reference to 67.15.)

Mark LaCroix (Complainant) stated he wants to know if the open meeting laws were when the department brought the wrong charges against me and he was suspended for four months and denied back-pay despite what the Charter provides and the guarantees under the Firefighter Bill of Rights.

Maureen Conefrey (Respondent) stated that on 11/25/2024 Complainant sent a PRR referencing five (5) communications among the Fire Commissioners and staff. Ms. Conefrey stated that a response was sent without consulting the Commissioners and explained on 2/14/2025 that the Fire Commission responds to Public Records Requests.

The parties provided rebuttals.

Action: Moved by Chair Schmidt, seconded by Member Anderson, to find no violation.

14. **File No. 25009**: Complaint filed by Liza Murawski against the Behavioral Health Commission for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21 by failing to respond to a public records request in a timely and/or complete manner. (04:56:43)

Liza Murawski (Complainant) stated that requests were emailed to Amber Gray and Marlo Simmons, and that Human Resources has not responded. Ms. Murawski further stated that she has received the Marlo Simmons email from July 7 from the Department of Public Health but wants to know who at HR received a copy.

Victor Lim (Respondent) stated Complainant's 1/17/2025 emailed request to Amber Gray for emails from Commissioner Humphrey to Human Resources were not treated as a public records request, that the communications with Amber Gray are internal pursuant to their bylaws, and that records may be requested between Commissioners. Mr. Lim further stated that responsive records were provided as a response to a Public Records Request once the department received the Task Force complaint on 2/14/2025, and responded within five days that the department would respond by 2/28/2025.

The parties provided rebuttals.

Member Hyland was noted absent at 9:48 p.m.

Action: Moved by Chair Yankee, seconded by Member Wolfe, to find that the Task Force has jurisdiction, that the requested records are public, and to find a violation of 67.21(b) by failing to respond to a public records request in a timely and/or complete manner.

Public Comment: Charlie Obermeyer stated that there are processes within the Behavioral Health Commission that are working to not include Ms. Murawski and wants to know what resources are available outside of the Task Force. Anonymous Caller #1 (Joy) stated that it should not have taken six months to address Commissioner Murawski's request, and an investigation is needed along with more rules and regulations in the chain of command. Anonymous Caller #2 stated their disappointment that a letter mentioning a suicide attempt would be forwarded to the Supervisors; that it is challenging to find out where it went, and that the issue needs to be looked at.

Any representative who fails in this manner will be determined as violating Administrative Code Sections 67.21(e) and 67.22. (06:12:32)

Public Comment: Honest Charley Bodkin commended the Task Force on its efforts.
