- Superior Court ruling that redactions of public records does not fall within the state law that allows for charges related to "data compilation, extraction, or programming to produce the record."
- Development of training regarding the Sunshine Ordinance
- Appointments of members to the Sunshine Ordinance Task Force Committees

Chair Bruce Wolfe provided a summary of the Superior Court ruling regarding charges related to data compilation, extraction, or programming to produce the records.

Deputy City Attorney Colla provided comments and responded to questions from the Task Force.

#### **Public Comment:**

Ray Hartz provided his experience related to the Police Department's resistance to providing public information.

Peter Warfield requested specifics of the court case and its relation to San Francisco.

Chair Bruce Wolfe provided a summary of his intention to conduct training for members of the Task Force, stated his intentions for changes to the committee schedule and procedure, provided his appointments to the committee of the Task Force and stated his intention to rotate the membership of the committee at least once during the next year.

#### **Public Comment:**

Ray Hartz stated that the complaint form allows for complainants to decide whether or not they wish to have a public hearing and provided other related information.

Nick Pasquariello stated that the education of Task Force members should be open to the public.

Peter Warfield stated training is valuable and the custodian of records should provide responses to requests as soon as possible.

4. **File No. 16060: Report -** Board of Supervisors (File No. 160478) proposed amendment to the Campaign and Governmental Conduct Code requiring Commissioners to file Behested Payment Reports regarding the solicitation of charitable contribution over \$5,000.

Task Force Administrator provided an update and the Task Force discussed the matter.

Member Tesfai, seconded by Member Cannata, moved to continue the matter to the call of the chair.

Ray Hartz questioned the Public Library's encouraging donation/participation to the Friends of the Public Library.

#### Speakers:

Ray Hartz commented on the combining of his complaints against the Library Commission and stated it is up to staff to insure the agenda complies with Sunshine. Mr. Hartz stated that although violations may be corrected the violations still occurred.

Peter Warfield expressed appreciation that the Task Force is changing for the better and for the active membership.

### **Recommendation from the Compliance and Amendments Committee.**

(The Compliance and Amendments Committee held a hearing to review File Nos. 16023, 16042, 16043, and 16054, and issued a report and/or recommendation for the Sunshine Ordinance Task Force's (SOTF) review. Upon review of the Committee's recommendations the SOTF shall: 1) accept the recommendation of the Committee; or 2) schedule the complaint for a hearing before the SOTF at a future date.

6. **File No. 16023:** Complaint filed by Nick Pasquariello against Mayor Edwin Lee and Steve Kawa, Office of the Mayor, for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.21 (b) and 67.25, by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner. (01:16:00 – )

(On June 21, 2016, the Compliance and Amendments Committee referred the matter to the Task Force with the recommendation to find jurisdiction and to find that Mayor Edwin Lee and Chief of Staff Steve Kawa, Office of the Mayor, violated Administrative Code (Sunshine Ordinance), Section 67.21 (b) by failing to respond to a public records request in an appropriate manner and Section 67.25, by failing to respond to an Immediate Disclosure Request in a timely manner.)

Nick Pasquariello (Complainant) provided an overview of the complaint and requested the Task Force to find violations. Kirsten Macaulay, Office of the Mayor (Respondent), provided a summary of the department's position and stated that Mr. Pasquariello was verbally informed that additional time was needed to responded to his request and that all records have been provided. A question and answer period followed.

Member Tesfai, seconded by Member Eldon, moved to adopt the recommendation of the Compliance and Amendments Committee to find that the Task Force has jurisdiction and that Mayor Edwin Lee, and Steve Kawa, Office of the Mayor, violated Administrative Code (Sunshine Ordinance), Section 67.21 (b) by failing to respond to a public records request in an appropriate manner and Section 67.25, by failing to respond to an Immediate Disclosure Request in a timely manner.

#### Public Comment:

Peter Warfield summarized the complaint and stated the documents provided were not responsive to the Immediate Disclosure Request.

Ray Hartz stated that a violation of the Sunshine Ordinance occurred and the requested documents were not provided.

Ray Hartz stated that the Complaint Committee can streamline the process by combining files but the members of the full Task Force should be allow to ask questions and make final determinations.

Peter Warfield inquired about repeated violation resulting in willful violations.

Geoffrea Morris (Complainant) provided an overview of the complaint and requested the Task Force to find violations. In addition to the listed complaints Ms. Morris alleged that members of the public were present during closed session discussions. There were no speakers in support of the Complainant. Renee Willette (Respondent), provided a summary of the department's position and stated that Executive Director Toye Moses has retired and is no longer with the Commission. Ms. Willette acknowledged that the Sunshine information required by Administrative Code, Sections 67.7 (g)(h), did not appear on the agenda and the issue has been addressed for all future agendas. Ms. Willette stated that only members of the Commission, staff and relevant applicants were present during the closed session portion of the meeting. There were no speakers in support of the Respondent. A question and answer period followed. The issue of bodies subject to Charter, Section 4.101.5 and the 60 day limit for holdover appointee was discussed. However, it was determined that Charter, Section 4.101.5 does not apply to the Southeast Community Facility Commission. The Respondent and Complainant were provided the opportunity for rebuttals.

Member Maass, seconded by Member Hinze, moved to find that former Executive Director Toye Moses, Renee Willette, and the Southeast Community Facility Commission violated Administrative Code (Sunshine Ordinance), Sections 67.7 (g)(h), by failing to include required information regarding the Sunshine Ordinance in their April 20, 2016, agenda.

Ray Hartz stated that finding a violation is needed in order to establish a possible pattern of violation.

Regina Dick-Endrizzi, Office of Small Business (Respondent), provided a summary of the department's position and provided a description of the department's structure in an effort to show that the Office of Small Business is not the custodian of the requested record. Ms. Dick-Endrizzi stated that the records request was forwarded to the appropriate party for processing. However, the custodian of the requested records had not previously processed personnel records requests and was unaware of the proper compliance procedures which resulted in a delayed/incorrect response. There were no speakers in support of the Respondent. A question and answer period followed. The Task Force opined that a department cannot invalidate an Immediate Disclosure Request but may request, by the end of the next business day, an extension 10 day pursuant to Administrative Code, Section 67.25 (a). The Respondent and Complainant were provided the opportunity for rebuttals.

Member Cannata, seconded by Member Tasfai, moved to find that Regina Dick-Endrizzi and the Small Business Commission violated Administrative Code (Sunshine Ordinance), Section 67.25 (a), by failing to respond to and Immediate Disclosure Request in a timely manner.

#### **Public Comment:**

Peter Warfield stated that there was a willful violation of the Sunshine Ordinance as the request for records provided clear and detailed information

Joel Ekno (Complainant) provided an overview of the complaint and requested the Task Force to find violations. There were no speakers in support of the Complainant. Sgt. Maria Hermina Ciriaco, Legal Division, Police Department (Respondent), provided a summary of the department's position. Sgt. Ciriaco stated that Officer Anderson (Star #835) accepted the incident report from Mr. Enko and that Officer Candy Hilder, Special Victims Unit, Missing Persons, processed and denied the request for a copy of the incident report. Sgt. Ciriaco stated that the record request was denied pursuant to California Government Code, Section 6254 (f), in order to protect the victim of a crime and to avoid the disclosure of protected medical information included in the report. However, Sgt. Ciriaco could not provide an explanation as to reason for the delay in responding to the request for records. There were no speakers in support of the Respondent. A question and answer period followed. The Respondent and Complainant were provided the opportunity for rebuttals.

Member Wolfe, seconded by Member Hinze, moved to find that Officer Candy Hilder and the Police Department violated Administrative Code (Sunshine Ordinance), Sections 67.21 (a) (b)and (c), by failing to provide public records without unreasonable delay; failing to provide public records within 10 days or justify withholding any record by demonstrating, in writing as soon as possible and within ten days following receipt of a request, that the record in question is exempt; and failing to assist a requester in identifying the existence, form and nature of any records or information maintain or assist a requester in directing a request to the proper office or staff person.

#### **Public Comment:**

Ray Hartz provided a summary of the complaint and stated that the department did not justify the request denial.

Peter Warfield expressed support for the motion and the efforts of the Task Force. Mr. Warfield stated that a person knowledgeable of the complaint did not appear for the hearing.

Member Wolfe, seconded by Member Hinze, moved to amend the motion to find that Officer Candy Hilder and the Police Department violated Administrative Code (Sunshine Ordinance), Sections 67.21 (a) (b) (c) and (e), by failing to provide public records without unreasonable delay; failing to provide public records within 10 days or justify withholding any record by demonstrating, in writing as soon as possible and within ten days following receipt of a request, that the record in question is exempt; failing to assist a requester in identifying the existence, form and nature of any records or information maintain or assist a requester in directing a request to the proper office or staff person; and failing to send an authorized representative of the custodian of the public record able to explain the basis for the decision to withhold the records requested.

Ray Hartz stated that an addition violation of Administrative Code, Section 67.34, should be consider for willful violation.

Peter Warfield expressed agreement with Mr. Hertz's statement.
