Thank you very much for confirming your understanding about the timeframe for our response to this complaint under the Mayor's Proclamation. I appreciate your flexibility.

The Brown Act and the San Francisco Sunshine Ordinance provide that any gathering of a majority of the members of the Board of Supervisors or of a committee of the Board to discuss matters within the Board's subject matter jurisdiction constitutes a meeting of the Board of Supervisors. These laws require that any such meeting be open to the public and noticed and conducted in compliance with the Brown Act and the Sunshine Ordinance.

As you probably know, the Clerk of the Board of Supervisors' website includes a special notice regarding members of the Board of Supervisors participating in meetings of the San Francisco Democratic County Central Committee (SF DCCC). I am filing a complaint against Supervisors Ronen, Mar and Haney for violating the Sunshine Ordinance's Open Meeting requirements. I am requesting a public hearing before the Sunshine Ordinance Task Force. You may contact me through this email address. Here are the facts and the violations:

Members of the San Francisco Democratic County Central Committee (SFDCCC) met secretly this past weekend after being summoned by Chair David Campos. Among other things, the group discussed the SFDCCC's pending endorsement in Supervisor Districts 1 and 7. In the meeting, Chair Campos coordinated votes to support Connie Chan and Vilaska Nguyen. As I file this complaint, no endorsement has yet been made, but is expected on Wednesday, July 22.

The secret SFDCCC meeting about the District 7 endorsement was attended by Supervisors Ronen, Mar and Haney who are all SFDCCC members, but the meeting was not publicly noticed or open to the public per the Sunshine Ordinance or the Brown Act. These requirements are triggered by the fact that the attending Supervisors constituted a majority of the following committees of the Board of Supervisors: Rules Committee (Supervisors Ronen, Stefani, and Mar) and the Government Audit and Oversight Committee (Supervisors Mar, Peskin, and Haney). Please see SF Admin. Code sections 67.3(a),(d), 67.5, 67.6, 67.8. This is why meetings of the SFDCC are typically noticed and open to the public, but this did not happen this time, in part because Chair Campos, the three Supervisors, and others did not want the public to see the lining up of votes for the District 1 endorsement in favor of Connie Chan and District 7 endorsement in favor of Vilaska Nguyen

To confirm my allegations, the Task Force should contact Supervisors Ronen, Mar and Haney who were obviously at the meeting. Thereafter, please take appropriate action.

Dear SOTF Petitioners, Respondents and other Stakeholders:

As you most likely know SOTF operations have been delayed over the last few months due to the Covid-19 emergency. The SOTF have started to conduct remote meetings via videoconference and are working to establish procedures to resume all operations including the processing of complaints.

While the Sunshine Ordinance requires that certain actions be taken within 45 days, the Covid-19 emergency has forced delays and immense new backlogs for complaint hearings. We write today to ask if you are willing to waive the 45 day rule for your complaint.

The SOTF intends to resume hearing complaints on a limited basis and complaints will be queued to be heard in the near future.
