1. **CALL TO ORDER, ROLL CALL, AND AGENDA CHANGES**

Chair Yankee called the meeting to order at 4:05 PM. On the call of the roll Chair M. Yankee and Members Wolfe, Schmidt, LaHood, Padmanabhan, Wong, Hyland and Neighbors were noted present. Members Stein and Hill were noted absent. A quorum was present.

Public Comment:

Anonymous #3 stated that Item 8 on the Agenda is not the complaint that was referred to the SOTF by the Ethics Commission.

1A. **FINDINGS TO ALLOW TELECONFERENCED MEETINGS UNDER CALIFORNIA GOVERNMENT CODE SECTION 54953(e).**

The Task Force is expected to consider a motion setting forth findings required under Assembly Bill 361 (AB 361) that would allow the committee to hold the meeting remotely according to the modified Brown Act teleconferencing set forth in AB 361.

The SOTF noted that every thirty days, the SOTF must have findings for continued meetings of this body, to recognize that the state of emergency will continue to impact the body and as long as local officials continue to recommend that emergency procedures remain in place. The SOTF is required to approve these findings, or the remote meeting cannot take place.

Anonymoose #3 stated that if it is the case that something is closed due to the Petitioner receiving the records, they urge that the SOTF to not use the term "in a timely manner" and not conclude that the response was timely unless the Petitioner said the complaint/documents were received in a timely manner.

3. Administrator's Report, Complaints and Communications.

Chair Yankee asked if the Rules Committee is willing to piggyback after another committee?

Member Schmidt wanted to know why the number of outstanding cases went up by 26 since last month.

Administrator Young stated that over the last few years the number of cases has been ticking up and this year we are on the way to 150 or more cases.

Member Wolfe requested that Legislative Deputy Director of the Board of Supervisors, Alisa Somera, send an official memo regarding the Rules Committee meeting date change.

Public Comment:

Anonymous #3 noted that the number of new cases went up by more than 11 cases. Anonymous #3 stated that that number will continue to grow.

- 3A. **Communication and Referral from the Ethics Commission:** Development of appropriate procedures for handling this matter and related matters when the Sunshine Ordinance Task Force is named as a respondent. Communication from the Ethics Commission.

The SOTF discussed the communication from the Ethics commission. Chair Yankee stated that the Ethics Commission looked at this item as an alleged willful violation, but because the SOTF Chair is not elected or a department head, they referred the matter back to the SOTF. Deputy City Attorney Price-Wolf requested that this item be included in the Agenda.

Member Wolfe noted that as far as an official complaint, there is no other body in the City to take up this complaint except in court. Member Wolfe also stated that the SOTF should review it, but upon reflection of item in the complaint and how to make things work better, it should not take this matter on as a complaint and adjudicate it. Member Wolfe stated that the Ethics Commission concluded that they do not have jurisdiction. Member Wolfe also stated that the SOTF should accept the complaint if there needs to be changes in SOTF processes.

Member Schmidt withdrew himself from this matter.

Action: Moved by Vice-Chair Wong, seconded by Member Hyland, to refer this item back to the Ethics Commission and include an item on the next Education, Outreach and Training Committee agenda to discuss noticing.

Public Comment:

Anonymous #3 stated that the Ethics Commission will look for a technicality to dismiss the complaint and not hear it. Anonymoose #3 stated that they do not know how anybody complies with Administrative Code, Sunshine Ordinance Section 67.6.

David Pilpel suggested that if the SOTF is referring the matter back to the Ethics Commission, the SOTF should include a cover letter explaining why they are returning the matter and why the SOTF feels there is a lack of jurisdiction.

Mark Sullivan hoped that Vice-Chair Wong's motion passes.

Peter Warfield, Executive Director Library Users Association, libraryusers2004@yahoo.com, P.O. Box 170544, San Francisco, California, 94117-0544. Mr. Warfield stated that the motion is okay but that it doesn't really cover the territory that the agenda item is taking.

Chair Yankee stated that there is a conflict of interest and suggested including some reasoning and a new motion.

Anonymous #3 noted that his comments are regarding a variety of his complaints that are pending given the two complaints per committee rule and that it would be helpful to know which complaints are still pending.

David Pilpel noted three things that touch on recusal.

Mark Sullivan recited Administrative Code, Sunshine Ordinance, Section 67.6(f).

Peter Warfield stated that agendas need to be clearer because the format of the agenda does not explain the document.

Chair Yankee called a recess at 6:01 pm and to conclude at 6:11 pm.

5. **File No. 22036:** Complaint filed by Anonymous (ARE) against Charles Jung (Elections Commission) for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.25, by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner.

Member Schmidt provided a synopsis of the complaint heard at the Complaint Committee.

Anonymous (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Anonymous stated that on April 6, 2022, he prepared a general Immediate Disclosure Request to Charles Jung asking for one week of communications regarding the Redistricting Task Force. Mr. Jung resigned and never responded and violated Administrative Code 67.25 for failure to respond to an Immediate Disclosure Request. Anonymous' only issue is whether Mr. Jung responded to his records request regarding redistricting issues in a timely manner which he did not.

Charles Jung (Elections Commission) (Respondent), was not present for the hearing and did not notify the SOTF Administrator of their absence.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Schmidt, seconded by Member Wolfe, to find that Charles Jung (Elections Commission) violated Administrative Code, Sunshine Ordinance, Section(s) 67.21(b) by failing to respond to an Immediate Disclosure Request in a complete and timely manner and 67.21(e) by failing to send a knowledgeable person to the hearing and explain the decision to withhold records.

Member Schmidt restated his motion and incorporated Member Wolfe's comments.

Action: Moved by Member Schmidt, seconded by Member Wolfe, to find that Charles Jung (Elections Commission) violated Administrative Code, Sunshine Ordinance, Section(s) 67.21(b) by failing to respond to an Immediate Disclosure Request in a complete and timely manner; 67.21(e) by failing to send a knowledgeable person to the hearing and explain the decision to withhold records; 67.25 by failing to acknowledge receipt of an Immediate Disclosure Request within one business day and California Public Records Act 6253(c) by failing to provide notice that there were any disclosable records within 10 days.

David Pilpel stated that there are several things that do not involve the Clerk of the Board and that the Clerk of the Board has no relationship to this matter. Mr. Jung was an officer of the City not an employee and filed a Form 700 Leaving Office on August 1.

Member Schmidt provided a synopsis of the complaint heard at the Complaint Committee.

Anonymous (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Anonymous stated that this complaint was filed on April 9, 2022, and is related to the other complaints. Anonymous stated there are nine members of the RTF and he emailed each of them and the Clerk of the RTF and Wilson Ng of the Clerk of the Board's Office who often helps commissioners respond to requests. Anonymous made the request at the time Rev. Townsend was the chair of the RTF. Anonymous stated that Rev. Townsend responded with a request for a 10-day extension of time to respond. Anonymous stated he has not received anything from Rev. Arnold Townsend.

Respondent Rev. Arnold Townsend (Redistricting Task Force) was not present for the hearing and did not notify the SOTF Administrator of their absence.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Padmanabhan, seconded by Member Schmidt, to find Rev. Arnold Townsend, the previous Chair of the Redistricting Task Force, in violation of Administrative Code, Sunshine Ordinance, Section(s) 67.21(b) by failing to provide the requested records within 10 days of receipt; 67.25(a) by failing to acknowledge receipt of an Immediate Disclosure Request within one day and California Public Records Act 6253(c) by failing to provide notice that there were any disclosable records within 10 days.

David Pilpel stated that Arnold Townsend has said he is not technically savvy and would not surprise Mr. Pilpel if Mr. Townsend's use of email was nonexistent. Mr. Townsend also has not filed a Form 700 Leaving Office document.

Peter Warfield stated that these issues are significant with respect to accountability and agrees with what Anonymous said.

Member Schmidt provided a synopsis of the complaint heard at the Complaint Committee.

Anonymous (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Anonymous stated that he made two requests of Ms. Ho on April 7, 2022. Anonymous stated that on April 21, 2022, Ms. Ho responded to the one of the requests by asking for a 10-day extension of time to respond from the date the records were due. On May 10, 2022, Ms. Ho responded to the City Attorney, Clerk of the Board of Supervisors, but not the SOTF, that she did not have records responsive to several other requests of Anonymous' requests. Anonymous noted that after May 10, 2022, Ms. Ho had access to her sfgov email account.

Lily Ho, Respondent (Redistricting Task Force). Ms. Ho was not present for the hearing and did not notify the SOTF Administrator of their absence.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Member Padmanabhan, seconded by Member Wolfe, to find that Lily Ho violated Administrative Code, Sunshine Ordinance, Section(s) 67.21(b) by failing to provide the requested records within 10 days of receipt; 67.25(a) by failing to acknowledge receipt of an Immediate Disclosure Request within one day and California Public Records Act 6253(c) by failing to provide notice of determination within 10 days from receipt of the request that there were any disclosable records.

Anonymous (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Anonymous stated that on April 7, 2022, two requests for records were sent to Ditka Reiner which were not responded to in a timely manner. Ms. Reiner responded one of the two requests on April 18, 2022, 11 days after receiving both requests, however Anonymous has complaints about the quality of the response. On April 27, 2022, Anonymous pointed out there are missing responsive records. Anonymous provided the following email address for Ms. Reiner which was unknown to the SOTF Administrator ditka@reinerassociates.com.

Ditka Reiner, Respondent (Redistricting Task Force). Ms. Reiner was not present for the hearing and did not notify the SOTF Administrator of their absence.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Anonymous stated that because the only email he received was on April 9, 2022. Anonymous stated this was not a request and he has never received an acknowledgement and asks that the SOTF find violations of 67.25(a) for failing to acknowledge both Immediate Disclosure Requests; 67.21(b) for failure to respond to the request within 10 days and violation of the CPRA 6253(c) and continue the process of having the other relevant agencies search for records.

Matthew Castillon, Respondent (Redistricting Task Force). Mr. Castillon was not present for the hearing and did not notify the SOTF Administrator of their absence.

Anonymous stated two issues regarding recusal; there is the requirement on who has to be recused and ensuring that the SOTF maintains a lack of conflict of interest and second as you lose people up to quorum you may lose the ability to have six people do something when deciding about actual motions.

Peter Warfield stated that there are specific guidelines for recusal including financial conflict of interest.

David Pilpel stated that Member LaHood's recusal is appropriate.

Will Jarrett (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Mr. Jarrett stated that the complaint was directed to Ditka Reiner and Reverend Arnold Townsend. Mr. Jarrett, on November 8 and 9, 2021, he asked for emails from both parties. Mr. Townsend never responded. Ms. Reiner provided up to 300 emails not including personal emails or texts received from other Task Force members. Mr. Jarrett stated that at the end of June 2022, Ms. Reiner said that she made every attempt to fulfill the request and there were no more records. Mr. Jarrett noted that members of the SOTF asked to find out if this was true and on April 9, 2022, emails about lunch the next day with Ms. Reiner were provided which shows that there are records that were never provided.

Member Schmidt was noted present at 10:41 pm and provided a synopsis of the case.
