ORDER OF DETERMINATION September 29, 2020

DATE DECISION ISSUED September 2, 2020

CASE TITLE – Anonymous v. Chief William Scott, Lt R. Andrew Cox and the Police Department (File No. 19112)

FACTS OF THE CASE

The following petition/complaint was filed with the Sunshine Ordinance Task Force (SOTF):

Complaint filed by Anonymous against Chief William Scott, Lt. R. Andrew Cox and the Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.25, 67.26, 67.27, by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner, failing to respond to a public records request in a timely and/or complete manner; failing to justify withholding of records and failing to maintain a Proposition G calendar.

HEARING ON THE COMPLAINT

On December 17, 2019, the Complaint Committee acting in its capacity to hear petitions/complaints heard the matter.

Anonymous (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Anonymous stated that he made an Immediate Disclosure Request for Police Chief Scott's Proposition G and Non-Proposition G calendars. Anonymous stated that only the Proposition G calendar provided was in an incomplete and untimely manner. Anonymous stated that many calendar entries were redacted without legal citations.

Lt. Andrew Cox (Police Department) (Respondent), provided a summary of the department's position. Lt Cox stated that there was a miscommunication and acknowledged that the responses were late. Lt Cox stated that the Police Department has provided Chief Scott's Proposition G calendar with redactions.

Action: Moved by Member Yankee, seconded by Chair Martin, to find that the SOTF has jurisdiction, find that the requested records are public and to refer the matter to the SOTF for hearing.

On September 2, 2020, the SOTF held a hearing to review the recommendation from Committee and/or to review the merits of the petition/complaint.

Anonymous (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Anonymous stated that on October 8, 2020, he sent an Immediate Disclosure Request to the Police Department for Prop G and non-Prop G past and future calendars. Anonymous stated that on October 23, 2019, he was told that he would not be provided future Prop G calendars. However, the calendars were provided long after the events listed on the calendars had taken place. Anonymous stated that he received only two weeks of calendar entries after his complaint was filed and that the response was not timely.

Lt. Andrew Cox (Police Department) (Respondent), provided a summary of the department's position. Lt. Cox stated that the Police Department takes full responsibility for not providing the records in a timely manner. Lt. Cox stated that Anonymous refused to use the Police Department's records request portal. Lt. Cox stated that when the request came in it was auto sorted into a file that became an archivable request. Lt. Cox stated that this IDR was not simple and got in touch with the Petitioner to request an additional 10 days to respond. On March 27, 2020, the Petitioner was sent an updated version of his requested records.

Member LaHood noted that the initial request was funneled to an email not regularly monitored and because this was an Immediate Disclosure Request there is a timeliness issue.

Lt Cox stated that his department did develop a different email account and will closely monitor emails so that they do not go through auto sort. Lt Cox also noted that there was no request for future calendars. However, his department provided the requested records.

Anonymous stated that on October 23, 2019, he was told that he would not be provided future calendars. However, they were provided long after the calendars were no longer in the future.

Action: Moved by Member Yankee, seconded by Chair B. Wolfe, to find that the Police Department violated Administrative Code, (Sunshine Ordinance), Sections 67.25, by failing to provide the requested records in a complete and timely manner, 67.26, for withholding all future calendars instead of providing them with minimal redactions, and 67.27 for incorrectly citing 67.29-5 for withholding non Prop G calendars.

FINDINGS OF FACT AND CONCLUSION OF LAW

Based on the testimony and evidence presented, the SOTF found that the Police Department violated Administrative Code (Sunshine Ordinance), Sections 67.25 for failing to provide the requested records in a complete and timely manner, 67.26 for withholding all future calendars instead of providing them with minimal redactions and 67.27 for incorrectly citing 67.29-5 for withholding non Prop G calendars.

DECISION AND ORDER OF DETERMINATIONS

On September 2, 2020, Member Yankee, seconded by Chair Wolfe moved to find that the Police Department violated Administrative Code (Sunshine Ordinance), Sections 67.25 for failing to provide the requested records in a complete and timely manner, 67.26 for withholding all future calendars instead of providing them with minimal redactions and 67.27 for incorrectly citing 67.29-5 for withholding non Prop G calendars.

The motion PASSED by the following vote:

COMPLAINT

An anonymous complainant ("Complainant") alleges that the San Francisco Police Department, Chief William Scott, and Lt. R. Andrew Cox (collectively, "Respondents"), violated the Sunshine Ordinance by failing to respond to Complainant's requests in a timely and complete manner.

COMPLAINANT FILES COMPLAINT

Complainant filed this complaint with the Task Force on October, specifically alleging that Respondents violated Administrative Code sections 67.21, 67.26, and 67.27.

JURISDICTION

Respondents are subject to the Sunshine Ordinance and the California Public Records Act ("CPRA"), Respondents do not dispute jurisdiction.

APPLICABLE STATUTORY SECTION(S)

Section 67 of the San Francisco Administrative Code:

- Section 67.21 governs responses to a public records request in general.
- Section 67.26 provides that withholding of public records shall be kept to a minimum.
- Section 67.27 sets forth requirements for justifying the withholding of information.
- Section 67.29-5 sets forth requirements for certain City officials with respect to their calendars.

Cal. Government Code (CPRA)

- Section 6253 sets forth the general requirements for the production of records.
- Section 6253.9 governs the formats in which documents should be produced.

APPLICABLE CASE LAW

• City of San Jose v. Superior Court (2017) 2 Cal.5th 608 (holding that when a city employee uses a personal account to communicate about public business, the writings may be subject to disclosure under the CPRA).

On October 8, 2019, Complainant requested the following categories of documents from Respondents:

- 1a). IMMEDIATE DISCLOSURE: an electronic copy of the department head's *prospective/expected* calendar or schedule, with all expected events/items, from Oct 21 to Oct 28, 2019 (inclusive). Calendar items must include (but are not limited to): the exact start and end time of the meeting, the location, the title, all invitees and whether they accepted or not, attachments, inline images, if they exist in the record. We are specifically requesting ALL calendar/scheduling items, individually, for the department head, whether the department head themselves possesses them or their staff, whether they are labeled "Prop G" or not, and whether they are on a computer or in physical form (such as a diary, a physical calendar on a wall, etc.). You are welcome to virtually print/exporteach item (not the summary view) directly to .PDF form in Outlook and redact them. Do not cutoff information like long text that does not fit on the screen - that would be unjustified withholding. and headers are NOT specifically requested (though you are welcome to provide them if it can be provided rapidly).

3. REGULAR DISCLOSURE: Furthermore, I request that a City of San Jose v Superior Court (2017) search be performed of the department head, their seniormost deputy, their chief of staff (or equivalent, and deputy chiefs), and all personal/secretarial/administrative assistants, such that each such official either provide all records responsive to #1 that are present on their personal accounts/devices/property (solely to the extent the record or portion thereof relates to the public's business), or provide a declaration/affidavit that no such records exist. All such affidavits are also requested. In order to ensure rapid disclosure, in this and only this request, particular formats and headers are NOT specifically requested (though you are welcome to provide them if it can be provided rapidly).

The chronology of Respondents' response is not entirely clear. It appears that, either on October 15 or 16, 2019, Respondents provided an initial response, and invoked their right to extend the time to respond to the immediate disclosure requests.¹

(Emphasis added.) The document attached to this email does not appear to be in the record. Further, it is unclear from the record why, as asserted, Respondents did not receive the initial October 8 request until approximately one week later.

¹ In an October 23, 2019 letter, Respondents stated that "[t]he San Francisco Police Department (SFPD), Legal Division received your Public Records Act request on October 15, 2019." Later in that letter, Respondents state, "[o]n that same date SFPD informed you that your request was not simple, routine, or otherwise answerable, and it was considered a standard public records request that allows SFPD up to 10 days to respond." The record before the Task Force does not appear to include that response. However, an email chain that is in the record suggests that Respondents provided a response on October 16. It reads as follws, in relevant part:

On October 23, 2019, Respondents provided a written response as well as responsive documents. In the cover letter, Respondents informed Complainant that certain information was withheld on four grounds:

1. Personal information, pursuant to Government Code §6254(c);

2. Attendees who "fall under" Administrative Code §67.29-5(e), "including labor/employee groups and organizations, as well as members of the public who wished to remain anonymous;

3. Pursuant to Administrative Code §67.29-5(e), the names of Department members

when all attendees are in the official's City department; and

4. As to responsive document for the time period of October 21 · 28, the documents were not being provided at that time pursuant to Administrative Code §67,29-5(a), but Respondents agreed to provide Complainant an update with respect to these documents by October 29, 2019.

Three of the four justifications come from Section 67.29-5, which was added to the Administrative Code in 1999, via Proposition G, and requires particular City officials to keep calendars that conform to the content requirements of the section.

Complainant objected to the scope of withholding and filed a petition with the Supervisor of Records. The central thrust of Complainant's argument is that, merely because Proposition G does not require the recording of certain information in official calendars, that does not mean that it *permits* the withholding of public records (whether denominated "Proposition G" calendars or otherwise) that already happen to reflect that information.² In other words, Complainant's position that the "exemptions" from the material required to be recorded in a Proposition G-required calendar do not operate as general exemptions to the requirement to produce those responsive records that exist (including where any such calendars regarding official business are maintained on a personal device).

Complainant asserts that this case is indistinguishable from Complaint No. 19047, which was heard by the Task Force at its October 2, 2019, meeting. However, Complaint No. 19047 raised certain issues regarding the production of metadata that are not raised by the present complaint. The summary of the respondents' argument with respect to that matter focused solely on issues related to the format of production. The minutes reflect that the complainant in that case did "state[] that the [respondents] did not provide the Mayor's non-Prop G or second calendar account under months later, and those non-Prop G calendars are public records," but the Task Force's finding of a violation states only generally that repondents "fail[ed] to provde records in a timely and/or complete manner, keep withholdings to a minimum, and justify the

withholding of records." Thus, at least from the minutes, this finding could have rested on the failure to timely produce documents in the format required.

QUESTIONS THAT MIGHT ASSIST IN DETERMINING FACTS

- Did the Supervisor of Records issue a decision? If so, what was the result?
- Are Respondents relying on the minimum requirements of Proposition G calendars as a basis for withholding information that exist and would otherwise be facially responsive to Complainant's requests? What is Complainant's basis for alleging that such documents exist?
- Respondents contend that they did not receive Complainants' October 8, 2019 request until, at the earliest, October 15, 2019. What accounts for this delay? What impact does this delay have on the Task Force's determination of timeliness?

LEGAL ISSUES/LEGAL DETERMINATIONS

• Did Respondents violate the Sunshine Ordinance or the CPRA by failing to provide a timely and complete response to Complainant's document requests?

CHAPTER 67, SAN FRANCISCO ADMINISTRATIVE CODE (SUNSHINE ORDINANCE)

SEC. 67.21. PROCESS FOR GAINING ACCESS TO PUBLIC RECORDS; ADMINISTRATIVE APPEALS

- (a) Every person having custody of any public record or public information, as defined herein, (hereinafter referred to as a custodian of a public record) shall, at normal times and during normal and reasonable hours of operation, without unreasonable delay, and without requiring an appointment, permit the public record, or any segregable portion of a record, to be inspected and examined by any person and shall furnish one copy thereof upon payment of a reasonable copying charge, not to exceed the lesser of the actual cost or ten cents per page.
- (b) A custodian of a public record shall, as soon as possible and within ten days following receipt of a request for inspection or copy of a public record, comply with such request. Such request may be delivered to the office of the custodian by the requester orally or in writing by fax, postal delivery, or e-mail. If the custodian believes the record or information requested is not a public record or is exempt, the custodian shall justify withholding any record by demonstrating, in writing as soon as possible and within ten days following receipt of a request, that the record in question is exempt under express provisions of this ordinance.
- (c) A custodian of a public record shall assist a requester in identifying the existence, form, and nature of any records or information maintained by, available to, or in the custody of the custodian, whether or not the contents of those records are exempt from disclosure and shall, when requested to do so, provide in writing within seven days following receipt of a request, a statement as to the existence, quantity, form and nature of records relating to a particular subject or questions with enough specificity to enable a requester to identify records in order to make a request under (b). A custodian of any public record, when not in possession of the record requested, shall assist a requester in directing a request to the proper office or staff person.
- (d) If the custodian refuses, fails to comply, or incompletely complies with a request described in (b), the person making the request may petition the supervisor of records for a determination whether the record requested is public. The supervisor of records shall inform the petitioner, as soon as possible and within 10 days, of its determination whether the record requested, or any part of the record requested, is public. Where requested by the petition, and where otherwise desirable, this determination shall be in writing. Upon the determination by the supervisor of records that the record is public, the supervisor of records shall immediately order the custodian of the public record to comply with the person's request. If the custodian refuses or fails to comply with any such order within 5 days, the supervisor of records shall notify the district attorney or the attorney general who shall take whatever measures she or he deems necessary and appropriate to insure compliance with the provisions of this ordinance.
- (e) If the custodian refuses, fails to comply, or incompletely complies with a request described in (b) above or if a petition is denied or not acted on by the supervisor of public records, the person making the request may petition the Sunshine Task Force for a determination whether the record requested is public. The Sunshine Task Force shall inform the petitioner, as soon as possible and within 2 days after its next meeting but in no case later than 45 days from

when a petition in writing is received, of its determination whether the record requested, or any part of the record requested, is public. Where requested by the petition, and where otherwise desirable, this determination shall be in writing. Upon the determination that the record is public, the Sunshine Task Force shall immediately order the custodian of the public record to comply with the person's request. If the custodian refuses or fails to comply with any such order within 5 days, the Sunshine Task Force shall notify the district attorney or the attorney general who may take whatever measures she or he deems necessary to insure compliance with the provisions of this ordinance. The Board of Supervisors and the City Attorney's office shall provide sufficient staff and resources to allow the Sunshine Task Force to fulfill its duties under this provision. Where requested by the petition, the Sunshine Task Force may conduct a public hearing concerning the records request denial. An authorized representative of the custodian of the public records requested shall attend any hearing and explain the basis for its decision to withhold the records requested.

- (f) The administrative remedy provided under this article shall in no way limit the availability of other administrative remedies provided to any person with respect to any officer or employee of any agency, executive office, department or board; nor shall the administrative remedy provided by this section in any way limit the availability of judicial remedies otherwise available to any person requesting a public record. If a custodian of a public record refuses or fails to comply with the request of any person for inspection or copy of a public record or with an administrative order under this section, the superior court shall have jurisdiction to order compliance.
- (g) In any court proceeding pursuant to this article there shall be a presumption that the record sought is public, and the burden shall be upon the custodian to prove with specificity the exemption which applies.
- (h) On at least an annual basis, and as otherwise requested by the Sunshine Ordinance Task Force, the supervisor of public records shall prepare a tally and report of every petition brought before it for access to records since the time of its last tally and report. The report shall at least identify for each petition the record or records sought, the custodian of those records, the ruling of the supervisor of public records, whether any ruling was overturned by a court and whether orders given to custodians of public records were followed. The report shall also summarize any court actions during that period regarding petitions the Supervisor has decided. At the request of the Sunshine Ordinance Task Force, the report shall also include copies of all rulings made by the supervisor of public records and all opinions issued.
- (i) The San Francisco City Attorney's office shall act to protect and secure the rights of the people of San Francisco to access public information and public meetings and shall not act as legal counsel for any city employee or any person having custody of any public record for purposes of denying access to the public. The City Attorney may publish legal opinions in response to a request from any person as to whether a record or information is public. All communications with the City Attorney's Office with regard to this ordinance, including petitions, requests for opinion, and opinions shall be public records.

- (j) Notwithstanding the provisions of this section, the City Attorney may defend the City or a City Employee in litigation under this ordinance that is actually filed in court to any extent required by the City Charter or California Law.
- (k) Release of documentary public information, whether for inspection of the original or by providing a copy, shall be governed by the California Public Records Act (Government Code Section 6250 et seq.) in particulars not addressed by this ordinance and in accordance with the enhanced disclosure requirements provided in this ordinance.
- (I) Inspection and copying of documentary public information stored in electronic form shall be made available to the person requesting the information in any form requested which is available to or easily generated by the department, its officers or employees, including disk, tape, printout or monitor at a charge no greater than the cost of the media on which it is duplicated. Inspection of documentary public information on a computer monitor need not be allowed where the information sought is necessarily and unseparably intertwined with information not subject to disclosure under this ordinance. Nothing in this section shall require a department to program or reprogram a computer to respond to a request for information or to release information where the release of that information would violate a licensing agreement or copyright law.

SEC. 67.26. WITHHOLDING KEPT TO A MINIMUM.

No record shall be withheld from disclosure in its entirety unless all information contained in it is exempt from disclosure under express provisions of the California Public Records Act or of some other statute. Information that is exempt from disclosure shall be masked, deleted or otherwise segregated in order that the nonexempt portion of a requested record may be released, and keyed by footnote or other clear reference to the appropriate justification for withholding required by Section 67.27 of this Article. This work shall be done personally by the attorney or other staff member conducting the exemption review. The work of responding to a publicrecords request and preparing documents for disclosure shall be considered part of the regular work duties of any City employee, and no fee shall be charged to the requester to cover the personnel costs of responding to a records request.

SEC. 67.27, JUSTIFICATION OF WITHHOLDING.

Any withholding of information shall be justified, in writing, as follows:

- (a) A withholding under a specific permissive exemption in the California Public Records Act, or elsewhere, which permissive exemption is not forbidden to be asserted by this ordinance. shall cite that authority.
- (b) A withholding on the basis that disclosure is prohibited by law shall cite the specific statutory authority in the Public Records Act or elsewhere.

(c) A withholding on the basis that disclosure would incur civil or criminal liability shall cite any specific statutory or ease law, or any other public agency's litigation experience, supporting that position.

(d) When a record being requested contains information, most of which is exempt from disclosure under the California Public Records Aet and this Article, the custodian shall inform the requester of the nature and extent of the nonexempt information and suggest alternative sources for the information requested, if available.

SEC. 67.29-5. CALENDARS OF CERTAIN OFFICIALS.

- (a) The Mayor, City Attorney, Treasurer, Assessor-Recorder, District Attorney, Public Defender, Sheriff, every member of the Board of Supervisors, and every Department Head shall keep or cause to be kept a daily calendar wherein is recorded the time and place of each meeting or event attended by that official, either in person or by teleconference or other electronic means, with the exclusion of purely personal or social events at which no City business is discussed and that do not take place at City Offices or at the offices or residences of people who do substantial business with or are otherwise substantially financially affected by actions of the City. For meetings not otherwise publicly recorded, the calendar shall include a general statement of issues discussed. Such calendars shall be public records and shall be available to any requester three business days subsequent to the calendar entry date.
- (b) For meetings or events with ten or fewer attendees, the calendar shall also identify the individual(s) present and organization(s) represented at the meeting or event if known by the official, unless the official is aware that the information would reveal the identity of a confidential whistleblower, would interfere with an individual's right to petition government where the individual has sought and been assured confidentiality, would disclose the attendance of members or representatives of a labor organization at a meeting to discuss matters within the scope of representation, as that term is defined in California Government Code Section 3504, would reveal personnel information not subject to disclosure, or is otherwise exempt from disclosure under State and local law.
- (c) At any meeting or event with ten or fewer attendees, officials subject to subsection (a) of this Section 67.29-5 shall attempt to identify names of attendees present, and the organizations they represent; provided that an official shall not require any attendees to identify themselves, unless the official is aware that those attendees are campaign consultants registered with the Ethics Commission under Campaign and Governmental Conduct Code Article I, Chapter 5; lobbyists registered with the Ethics Commission under Campaign and Governmental Conduct Code Article II, Chapter 1; permit consultants registered with the Ethics Commission under Campaign and Governmental Conduct Code Article III, Chapter 4; Developers of Major Projects, as defined in Campaign and Governmental Conduct Code Section 3.510, if the Major Project is discussed at the meeting or event; and employees or representatives of any entity that has received a grant from or entered a contract with any City department within the previous 12 months. The official has no duty to ascertain whether any attendees fall into these categories.

Within three business days after a meeting or event subject to this subsection (e), the official shall update the daily calendar to include the names of the attendees and organizations identified by or known to the official.

- (d) For the purpose of calculating the total number of attendees at a meeting or event under subsections (b) and (c), an official shall not include himself or herself.
- (e) The obligations imposed under subsections (b) and (e), and the obligations imposed upon members of the Board of Supervisors under subsection (a), shall not apply to meetings or events where City business is discussed only incidentally; to unplanned, casual conversations with residents; to campaign-related meetings, events, and appearances; or to meetings or events where all attendees are employees or officers in the official's City department, which for members of the Board of Supervisors shall mean that all attendees are members of the Board of Supervisors, legislative aides, or employees of the Office of the Clerk of the Board. Officials are not in violation of subsections (b) or (c), and members of the Board of Supervisors are not in violation of subsection (a), if they have made a good faith effort to comply with their obligations thereunder.

CALIFORNIA GOVERNMENT CODE (CPRA)

SEC. 6253.

- (a) Public records are open to inspection at all times during the office hours of the state or local agency and every person has a right to inspect any public record, except as hereafter provided. Any reasonably segregable portion of a record shall be available for inspection by any person requesting the record after deletion of the portions that are exempted by law.
- (b) Except with respect to public records exempt from disclosure by express provisions of law, each state or local agency, upon a request for a copy of records that reasonably describes an identifiable record or records, shall make the records promptly available to any person upon payment of fees covering direct costs ofduplication, or a statutory fee if applicable. Upon request, an exact copy shall be provided unless impracticable to do so.
- (c) Each agency, upon a request for a copy of records, shall, within 10 days from receipt of the request, determine whether the request, in whole or in part, seeks copies of disclosable public records in the possession of the agency and shall promptly notify the person making the request of the determination and the reasons therefor. In unusual circumstances, the time limit prescribed in this section may be extended by written notice by the head of the agency or his or her designee to the person making the request, setting forth the reasons for the extension and the date on which a determination is expected to be dispatched. No notice shall specify a date that would result in an extension for more than 14 days. When the agency dispatches the determination, and if the agency determines that the request seeks disclosable public records, the agency shall state the estimated date and time when the records will be made available. "unusual circumstances" means the following, but only to the extent reasonably necessary to the proper processing of the particular request:

- (1) The need to search for and collect the requested records from field facilities or other establishments that are separate from the office processing the request.
- (2) The need to search for, collect, and appropriately examine a voluminous amount of separate and distinct records that are demanded in a single request.
- (3) The need for consultation, which shall be conducted with all practicable speed, with another agency having substantial interest in the determination of the request or among two or more components of the agency having substantial subject matter interest therein.
- (4) The need to compile data, to write programming language or a computer program, or to construct a computer report to extract data.
- (d) Nothing in this chapter shall be construed to permit an agency to delay or obstruct the inspection or copying of public records. The notification of denial of any request for records required by Section 6255 shall set forth the names and titles or positions of each person responsible for the denial.
- (e) Except as otherwise prohibited by law, a state or local agency may adopt requirements for itself that allow for faster, more efficient, or greater access to records than prescribed by the minimum standards set forth in this chapter.
- (f) In addition to maintaining public records forpublic inspection during the office hours of the public agency, a public agency may comply with subdivision (a) by posting any public record on its Internet Web site and, in response to a request for a public record posted on the Internet Web site, directing a member of the public to the location on the Internet Web site where the public record is posted. However, if after the public agency directs a member of the public to the Internet Web site, the member of the public requesting the public record requests a copy of the public record due to an inability to access or reproduce the public record from the Internet Web site, the public agency shall promptly provide a copy of the public record pursuant to subdivision (b).

SEC. 6253.9.

- (a) Unless otherwise prohibited by law, any agency that has information that constitutes an identifiable public record not exempt from disclosure pursuant to this chapter that is in an electronic format shall make that information available in an electronic format when requested by any person and, when applicable, shall comply with the following:
- (1) The agency shall make the information available in any electronic format in which it holds the information.

- (2) Each agency shall provide a copy of an electronic record in the format requested if the requested format is one that has been used by the agency to create copies for its own use or for provision to other agencies. The cost of duplication shall be limited to the direct cost of producing a copy of a record in an electronic format.
- (b) Notwithstanding paragraph (2) of subdivision (a), the requester shall bear the cost of producing a copy of the record, including the cost to construct a record, and the cost of programming and computer services necessary to produce a copy of the record when either of the following applies:
- (1) In order to comply with the provisions of subdivision (a), the public agency would be required to produce a copy of an electronic record and the record is one that is produced only at otherwiseregularly scheduled intervals.
- (2) The request would require data compilation, extraction, or programming to produce the record.
- (c) Nothing in this section shall be construed to require the public agency to reconstruct a record in an electronic format if the agency no longer has the record available in an electronic format.
- (d) If the request is for information in other than electronic format, and the information also is in electronic format, the agency may inform the requester that the information is available in electronic format.
- (e) Nothing in this section shall be construed to permit an agency to make information available only in an electronic format.
- (f) Nothing in this sectionshall be construed to require the public agency to release an electronic record in the electronic form in which it is held by the agency if its release would jeopardize or compromise the security or integrity of the original record or of any proprietary software in which it is maintained.
- (g) Nothing in this section shall be construed to permit public access to records held by any agency to which access is otherwise restricted by statute.

Request for Relief:

The Complainant respectfully requests that the Task Force move to:

- 1. Find Lt. Cox, Chief Scott, and SFPD have willfully failed to discharge their duties under SFAC 67.26 by withholding in entirety Chief Scott's future calendars instead of providing them with minimal redactions and justifying lawfully each and every redaction, after the Task Force unanimously found that the Police Department must in fact do so.
- 2. Find that Lt. Cox, as a "managerial city employee," engaged in official misconduct under SFAC 67.34 by willfully failing to comply with SOTF Order 19112.
- 3. Refer Chief Scott as department head to the Ethics Commission under SFAC 67.34 for willfully failing to comply with SOTF Order 19112.
- 4. Refer the on-going refusal by SFPD to provide future Scott calendars in minimally redacted form and comply with SOTF Order 19112 to the District Attorney and/or Attorney General under SFAC 67.30(a)/67.21(e).

Background:

On Sept. 2, 2020 the Sunshine Ordinance Task Force passed a 7-0 motion in SOTF Case 19112 Anonymous v. Scott, et al. finding, inter alia, a violation of Sunshine Ordinance, Sec. 67.26 for withholding in entirety future calendars instead of providing them with minimal redactions. During that hearing, Lt. Cox, on behalf of himself, Chief Scott, and SFPD (Respondents), stated that SFPD had changed its position, decided that its attorneys were previously wrong, and they would provide such records. On Sept. 6, the Complainant tested Respondents' concession and compliance, and SOTF's finding, by requesting, inter alia, "all calendars/schedule records (with all meeting details in Outlook or anywhere else, including all attachments and metadata) for Chief William Scott (both Prop G and non-Prop G) for (a) Oct 1 through Oct 14, 2020 as the schedule exists at this time and (b) Aug 24-Sep 1, 2020 (all dates inclusive)." (part (b) is not relevant to the finding of willful violation here and we discuss only part (a) - namely records which at the time of the request were for future events).

On Sept. 15, Lt. Cox issued a response letter stating: "SFPD declines to produce future calendar events for the Chief of Police. We understand that at the September 2, 2020 Sunshine Ordinance Taskforce Hearing, SFPD did not fully explain this position and we apologize for any confusion or misunderstanding. In general, SFPD is producing documents that are in its possession and applied exemptions and exceptions. For the Chief of Police's Calendar, producing future calendar events presents security risks and therefore we decline to disclose them under Cal. Gov't Code § 6254(f); Cal. Gov't Code § 6254(k); Cal. Evid. Code. § 1040; Times Mirror Company v. Superior Court, 53 Cal.3d 1325 (1991)." This rejection is a willful violation, pursuant to SOTF 19112. The Compliannat requested that Chair Wolfe of the SOTF thus schedule the Case for a Compliance hearing before the Compliance Committee. Lt. Cox issued a further letter to the SOTF on Sept. 21 raising new defenses and justifications. Respondents did not raise any of these exemptions during the hearing and prior to the motion in Case 19112. The Committee on Sept. 22 did not find the new exemptions and justifications acceptable to exempt the entire future calendar records and recommended a finding of willful violation to the full Task Force.

On Sept. 29, the Task Force's Sept. 2 decision was published as Order 19112 to Scott and Cox, and the Complainant re-demanded the relevant future calendar entries.

Reasoning:

The request was for Chief Scott's own calendars and he is also responsible as department head for the administration of the Sunshine Ordinance within the SFPD.

Pursuant to Sunshine Ordinance, Sec. 67.34, please refer Chief Scott's willful violations as department head to the Ethics Commission for an investigation into official misconduct.

Further pursuant to Sunshine Ordinance 67.34, Lt. Cox, as a "managerial city employee," should be found by your Task Force to have engaged in willful violation and official misconduct (non-department heads/elected officials are not referred to the Ethics Commission).

What Respondents and their attorneys refuse to accept is that each and every part of the calendar entries would have to be exempt in order to withhold the entire record. To comply with Sec. 67.26, Respondents would have to explain a lawful exemption for each and every part of the future calendar entries and justify to you how that law applies to the portion withheld. This provision of Sec. 67.26 is one of the key barriers to public official mischief in the Sunshine Ordinance: by being forced to justify the withholding of each and every part of a record in particularity, the public and tribunals such as your Task Force can more easily show that the government is lying. If the Task Force permits this blanket exemption by using not one but multiple

exemptions simultaneously, it fails to enforce the purpose of Sec. 67.26. Otherwise, in the future, the City Attorney's office can simply recommend its clients to cite every single CPRA exemption and withhold everything, counting on the fact that at least one may be applicable to some part of the record. Within the attached presentation are arguments disproving each of Respondents' citations.

The Task Force should further reject the spurious arguments made by Lt. Cox that he is (solely) personally responsible for misleading this Task Force during its Sept. 2, 2020 hearing and that his testimony does not bind Chief Scott and the SFPD. If SFPD or Chief Scott disavow Lt. Cox's Sept. 2 testimony, then Chief Scott and SFPD should be found additionally in willful violation of Sunshine Ordinance, Sec. 67.21(e) for failing to send an "authorized representative" to the Sept. 2, 2020 Task Force hearing. Chief Scott and the SFPD cannot escape the law by disavowing the actions of their authorized agent, after the fact.

Questions to ask Respondent to ascertain Compliance

- Did you search for and personally review each responsive record? Did a supervising attorney or other staff member personally review each responsive record? (Requirement of SFAC 67.26)
- Or did you, without reviewing the records, simply deem them all exempt? If you haven't reviewed the responsive records how can you be certain all portions of them are legally exempt?
- Did you determine that each and every portion of every responsive record is exempt?
- Which portions of the records were exempt under each legal citation?
- Explain each citation and how it applies to each portion of each responsive record.

Chief Scott's future meeting information is **not entirely exempt** under Gov Code 6254(f)

- GC 6254(f) is a permissive CPRA exemption for: "Records of complaints to, or investigations conducted by, or records of intelligence information or security procedures of, the office of the Attorney General and the Department of Justice, the Office of Emergency Services and any state or local police agency, or any investigatory or security files compiled by any other state or local police agency, or any investigatory or security files compiled by any other state or local agency for correctional, law enforcement, or licensing purposes.
- Calendars are not in their entirety "records of" "security procedures of" SFPD. Much of the future calendar records are political, staff, financial, or policy related, including the titles and descriptions of meetings and who the meetings are with.
- City must redact the security procedure information, and provide everything else.
- If specific meeting entries are entirely "investigatory" files, only those entries can be withheld.
- Moreover, when a meeting is virtual, how can that calendar entry be at all a security procedure? We can't figure anything out about the Chief's physical location.

19112 Anonymous v Scott, et al.

Evid. Code 1040 (official information privilege) does not apply. Chief Scott is himself a respondent.

- Chief Scott is a respondent, not just Cox and SFPD. This privilege requires BOTH that:
 - Information was "<u>acquired in confidence</u> by a public employee in the course of his or her duty and not open, or officially disclosed, to the public prior to the time the claim of privilege is made" <u>AND</u>
 - ONE OF the following:
 - "Disclosure is forbidden by an act of the Congress of the United States or a statute of this state." (clause is irrelevant to this case) OR
 - "Disclosure of the information is against the <u>public interest</u> because there is a necessity for preserving the confidentiality of the information that <u>outweighs</u> the necessity for disclosure in the <u>interest of justice</u>"
- Respondent Chief Scott cannot "acquire[] in confidence" his own calendar.
 Disclosing future meetings for any event that is not a secret investigation causes no harm to "justice" at all. "Justice" benefits from the public knowing who public officials plan to do business with and what they plan to do (for example, so that the public can petition the government to do or not do those things).
- Official information privilege is for whistleblowers, informants, witness protection, etc.

Gov Code 6254(k) is an incomplete reason on its own for any exemption

- "(k) Records, the disclosure of which is exempted or prohibited pursuant to federal or state law, including, but not limited to, provisions of the Evidence Code relating to privilege."
- Which federal or state law prohibits or exempts disclosure of <u>all</u> calendar information?
- Without citing the underlying law, this is a meaningless citation.

Nothing in *Times Mirror* applies to Chief Scott's calendars

ORDER OF DETERMINATION September 29, 2020

DATE DECISION ISSUED September 2, 2020

CASE TITLE – Anonymous v. Chief William Scott, Lt R. Andrew Cox and the Police Department (File No. 19112)

FACTS OF THE CASE

The following petition/complaint was filed with the Sunshine Ordinance Task Force (SOTF):

Complaint filed by Anonymous against Chief William Scott, Lt. R. Andrew Cox and the Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.25, 67.26, 67.27, by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner, failing to respond to a public records request in a timely and/or complete manner; failing to justify withholding of records and failing to maintain a Proposition G calendar.

HEARING ON THE COMPLAINT

On December 17, 2019, the Complaint Committee acting in its capacity to hear petitions/complaints heard the matter.

Anonymous (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Anonymous stated that he made an Immediate Disclosure Request for Police Chief Scott's Proposition G and Non-Proposition G calendars. Anonymous stated that only the Proposition G calendar provided was in an incomplete and untimely manner. Anonymous stated that many calendar entries were redacted without legal citations.

Lt. Andrew Cox (Police Department) (Respondent), provided a summary of the department's position. Lt Cox stated that there was a miscommunication and acknowledged that the responses were late. Lt Cox stated that the Police Department has provided Chief Scott's Proposition G calendar with redactions.

Action: Moved by Member Yankee, seconded by Chair Martin, to find that the SOTF has jurisdiction, find that the requested records are public and to refer the matter to the SOTF for hearing.

On September 2, 2020, the SOTF held a hearing to review the recommendation from Committee and/or to review the merits of the petition/complaint.

Anonymous (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Anonymous stated that on October 8, 2020, he sent an Immediate Disclosure Request to the Police Department for Prop G and non-Prop G past and future calendars. Anonymous stated that on October 23, 2019, he was told that he would not be provided future Prop G calendars. However, the calendars were provided long after the events listed on the calendars had taken place. Anonymous stated that he received only two weeks of calendar entries after his complaint was filed and that the response was not timely.

Lt. Andrew Cox (Police Department) (Respondent), provided a summary of the department's position. Lt. Cox stated that the Police Department takes full responsibility for not providing the records in a timely manner. Lt. Cox stated that Anonymous refused to use the Police Department's records request portal. Lt. Cox stated that when the request came in it was auto sorted into a file that became an archivable request. Lt. Cox stated that this IDR was not simple and got in touch with the Petitioner to request an additional 10 days to respond. On March 27, 2020, the Petitioner was sent an updated version of his requested records.

Member LaHood noted that the initial request was funneled to an email not regularly monitored and because this was an Immediate Disclosure Request there is a timeliness issue.

Lt Cox stated that his department did develop a different email account and will closely monitor emails so that they do not go through auto sort. Lt Cox also noted that there was no request for future calendars. However, his department provided the requested records.

Anonymous stated that on October 23, 2019, he was told that he would not be provided future calendars. However, they were provided long after the calendars were no longer in the future.

Action: Moved by Member Yankee, seconded by Chair B. Wolfe, to find that the Police Department violated Administrative Code, (Sunshine Ordinance), Sections 67.25, by failing to provide the requested records in a complete and timely manner, 67.26, for withholding all future calendars instead of providing them with minimal redactions, and 67.27 for incorrectly citing 67.29-5 for withholding non Prop G calendars.

FINDINGS OF FACT AND CONCLUSION OF LAW

Based on the testimony and evidence presented, the SOTF found that the Police Department violated Administrative Code (Sunshine Ordinance), Sections 67.25 for failing to provide the requested records in a complete and timely manner, 67.26 for withholding all future calendars instead of providing them with minimal redactions and 67.27 for incorrectly citing 67.29-5 for withholding non Prop G calendars.

DECISION AND ORDER OF DETERMINATIONS

On September 2, 2020, Member Yankee, seconded by Chair Wolfe moved to find that the Police Department violated Administrative Code (Sunshine Ordinance), Sections 67.25 for failing to provide the requested records in a complete and timely manner, 67.26 for withholding all future calendars instead of providing them with minimal redactions and 67.27 for incorrectly citing 67.29-5 for withholding non Prop G calendars.

Dear Sunshine Task Force Committee Members,

I am writing to clarify my responses made during the SOTF Hearing on September, 2, 2020, File No. 19112: Complaint filed by Anonymous against Chief William Scott and Lt. R. Andrew Cox and the Police Department. Specifically, I was asked by the committee if SFPD would release future Prop. G calendars upon request and I answered yes. I apologize for causing confusion. When I provided that answer, I did not mean to infer that SFPD would waive any rights to exempt Prop. G calendars in whole or any portion thereof if warranted. We continue to apply exemptions and exceptions to the Chief's future calendar entries that have not yet occurred under Cal. Gov't Code § 6254(f); Cal. Gov't Code § 6254(k); Cal. Evid. Code. § 1040; Times Mirror Company v. Superior Court, 53 Cal.3d 1325 (1991).

Chief Scott is the head Law Enforcement Official for the City and County of San Francisco, which carries a higher risk to his personal safety. His job presents unique security risks that requires unique security procedures and protocols to ensure his safety. Releasing information from his calendar reveals the timing and details of his whereabouts as well as the patterns and habits of the Chief of Police. While we are cautious to release his calendar at all under the laws cited above, we have done so after a careful review of events that have occurred in the past and redact information according to the cites listed above. However, this careful review may only be done by looking back at events that have already occurred. Releasing future calendar entries presents a new set of security issues.

Releasing future calendar entries inherently increases the risk to his security. This would seriously impair the ability of the Department to assure his personal safety and it would constitute a potential threat to his safety because this information would enable a reader to know in advance and with relative precision when and where the Chief may be found, the timing of his departures and arrivals from events or locations. In addition, the reader would know the persons who will be with him, and when he will be alone. We have redacted past Prop. G calendars entries under Cal. Govt Code section 6254(f) Cal. Gov't Code § 6254(k); Cal. Evid. Code. § 1040; Times Mirror Company v. Superior Court, 53 Cal.3d 1325 (1991).SFPD has never produced future Prop. G calendars in the past.

In retrospect, I understand that I answered the question poorly and I should have elaborated on our position. I sincerely apologize for any confusion and did not mean to mislead the committee and/or Anonymous. My statement to the committee was of my own volition and should not reflect any misconduct by Chief Scott or the SFPD.




