Staff Estrada: please review the document and provide feedback. I will finalize this throughout the week and present it at the next EXEC meeting.

Feedback:

Commissioner Santos: a lot of youth language, important, but what i've noticed is that youth is being dropped, but not necessarily be specific about the demographic of those youth.

Examples: BIPOC youth, public school students or SFUSD, immigrant & undocumented communities, etc. Also, putting some accountability for presenters

- my last feedback: questions asking specifically about D9, D10, D11 - south east part of SF
- What are the action steps taken to ensure this? are you meeting them where they are at? specifically for black youth, in this example.

Commissioner Zhang: I added similar feedback under community presentations, acces

Commissioner Quick: I didn't add too many things. Under BOS Leg Referred, reminding people that if a question has been asked don't need to ask again, but don't be afraid to ask for clarification because we are in charge

Commissioner Asfaw: I added the part of youth being compensated and what it would like - another thing in YC meetings there will always be a part when - verbally saying "i have nothing more to add"

Commissioner Hylton: I added something at the bottom and thought it'd be helpful to ask clarifying questions - it's ok to ask about the department or the body of the organization

Commissioner Santos: Thanks for that Nora, I feel that way too. Maybe we can say "for those of us who don't know..."

If I heard Arsema correctly, would you be comfortable with me asking if undocumented youth are/will be compensated?

Commissioner Asfaw: Yes, go ahead.

Commissioner Hylton: maybe add something about not supporting something. Not a bad idea to add that it's okay to not support something. You don't need to make people feel good.

Commissioner Santos: Maybe staff can help refine the language around saying No. Something about the census and Rome said he didn't support the rigidity of the census. Maybe something along the lines of adding that there is an opportunity to explain your stance, even when its a NO.



Commissioner Quick: Some procedural issues we've had is the order - we take a vote and some vote no - and then sometimes we've stopped the meeting to go back and have that person share after the fact. Add in the FAQ that the discussion portion is the opportunity to share why you are voting the way you are. It's always awkward when we go back and have them share at that point
