### Legislation referred:

- Sugar Sweet Beverage:
  - BOS isn't making major changes. Making very small changes. Think about asking Natalie "why" they are changing the words.



- Class Cuts at City College:
  - o self-explanatory. will be having a hearing about CCSF budget.
  - Staff Hosmon: I would encourage you all to think about the dignity fund. How can they find funding for certain classes versus others. Is there other types of funding? Ask questions, be inquisitive. Read the YC archives and review history YC has done in the past.
- Secondhand Smoke: staff to email them and ask to postpone their presentation with a date that aligns with the hearing.
- Navigation Center: requires each district to have a NAV center in 2 years, right now D6, D8, and D10. YC interests: NAV law is already in place, this would only amend. In that law, there is a statement about 1 TAY NAV center. However, this law would remove that provision and add a new list of provisions (6 categories). They are backing off the requirement of a NAV center to a specific marginalized identity. YC can give input on this ordinance and give recommendations. This type of legislation opens up the door to ask hard questions about the implementation and motion to include last year's BPPs.

Motion to approve the agenda with the caveat that the hearing about Secondhand Smoke can be struck from the agenda if we don't hear from Yee's office by Friday 1/03 by Commissioner Quick, seconded by Commissioner Cureton.
