1 [Affirming All LGBTQ Youth & Denouncing all Forms of Bullying and Ridicule] 2 Resolution affirming the supportive voice of The San Francisco Youth Commission to 3 all Lesbian, Gay, Bisexual, Transgender and Questioning (LGBTQ) youth, denouncing 4 all forms of bullying and ridicule towards any youth in our City, and highlighting local 5 efforts to offer support, prevent bullying and raise awareness about services available 6 for San Francisco's LGBTQ youth. 7 8 WHEREAS, Rutgers University freshman Tyler Clementi committed suicide after 9 classmates invaded his privacy and streamed his intimate encounter with another man online; 10 and. 11 WHEREAS, Tyler Clementi's is one of several suicides in recent weeks by gay youth 12 across the U.S. that had been harassed by classmates prior to taking their lives; and, 13 WHEREAS, a recent survey of 22,000 San Francisco Unified School District (SFUSD) 14 middle school and high school students reported that over 80% of SFUSD students had heard derogatory statements based on sexual orientation in the previous school year;<sup>1</sup> and, 15 16 WHEREAS, over 50% of SFUSD students identifying as LGBTQ reported being bullied or harassed due to their sexual orientation in the previous 12 months;<sup>2</sup> and, 17 18 WHEREAS, SFUSD's LGBTQ students were 4 times more likely to have attempted 19 suicide with nearly 50% stating that they had seriously considered suicide in the previous 12 20 months; and, 21 22 <sup>1</sup> 2007-2008 SFUSD School Climate Survey (SCS). WHEREAS, SFUSD recognizes in its Anti-Slur Policy that harassment and bullying of
 any kind is "incompatible with the mission of SFUSD...that includes creating a learning
 environment that respects diversity, educates about the harm of name calling and imposes
 consequences for name calling;"<sup>3</sup> and,

WHEREAS, The San Francisco Bay Area is home to several LGBTQ organizations
offering support to youth in our schools, including Ally Action, AQU25A, COLAGE, Community
United Against Violence (CUAV), Dimensions Health Clinic, Frameline, Gay-Straight Alliance
Network, LYRIC, Parents, Families and Friends of Lesbians and Gays (PFLAG), Our Family
Coalition, Respect for All Project, and the San Francisco LGBT Center; and,

WHEREAS, the Board of Supervisors of the City and County of San Francisco has
 affirmed the importance of maintaining the City and County of San Francisco's social safety
 net for LGBTQ youth, especially mental health and youth support services; and,

13 WHEREAS, the San Francisco Unified School District Board of Education has 14 recognized its need to "reaffirm and strengthen its commitment to LGBTQ students (1996) 15 and has continued its work of the Student Support Services Department's Support Services 16 for LGBTQ youth, made curriculum enhancements involving sexual orientation, and has improved other counseling and wellness offerings for LGBTQ students;<sup>4</sup> now, therefore be it 17 18 RESOLVED, that the San Francisco Youth Commission offers its support and voice to 19 the actions of the City and County of San Francisco, its Board of Supervisors, the SFUSD 20 Board of Education, and the many teachers, parents, individuals and agencies that offer 21 valuable and much-needed guidance, support and understanding to all of our City's LGBTQ 22 Youth; and be it
