- F. Presentation on Know Your Rights Pamphlet and Police Accountability  
Presenter: Samara Marion, Attorney, Department of Police Accountability

Samara gave some background context to the Dept. of Police Accountability. The Youth Commission used to be meet with the Dept of Police Accountability (formerly known as the Office



Citizen Complaints) at least monthly and with other youth serving agencies. From these meetings, they collaborated on, and created, a Know Your Rights Pamphlet for youth in SF.

There are now new laws regarding Miranda laws and they would like to update the brochure. Samara requested from the YC:

- 1) Find the copyrighted picture that the YC obtained in the beginning
- 2) Review the new brochure for content, looks, and give feedback
- 3) See if we have a budget for translation, or if we know anyone who can proof it a second time in a different language other than English

Samara should have a draft brochure by June 11<sup>th</sup> and can present it to the JEC meeting that day for review.

She let us know that the Youth Commission has met, and held, a joint hearing with the Police Commission in the past and one of the issues was on the Policing the Teen Brain training, which they supported and were in favor of. In the future, we could hold another hearing to see how the trainings are working, now that the Training of Trainers is starting today, and identify monitoring youth arrests, use of force, race/ethnicity, gender, schools etc. Having the training si great and we need to see if it will be effective, if de-escalation does occur, and if resources are made available to youth.

A new Police Commission creates an opportunity to do another joint hearing and have concrete asks from them.

YC could also partner with the Dept of Police Accountability and host Know Your Rights trainings and do Juvenile Jeopardy. They would love to collaborate with us on this.

- G. Presentation on Memorandum of Understanding for SFUSD and School Resource Officers  
Presenter: Angel Carrion, Civic Engagement Coordinator, Coleman Advocates for Youth

Angel, former Youth Commissioner, is now staff at Coleman and does their civic engagement work. The MOU with SFUSD will expire in January 2019 and JECs reviewed documents to give insight and feedback on.

Down the line, they can present to the full YC and get more youth voices in the process. JECs will be happy to help push this work forward over the summer to get the next YC term set up on police related issues.
