Youth.

Community contacts (YWFC, Larkin Street Youth Services, AYO, CPA) are outreaching to their youth. Commissioner Hylton and Cureton designated time to outreach to their community networks. For public comment, TJ would like to note that they believe in youth rights and that incidences such as Balboa impact the whole community. There needs to be investment in community healing and community-oriented solutions that follow up with youth and their families. For the long term, commissioners would like to refocus and look into training for youth and police laws. They would like to empower youths and families with the knowledge of what police (authority figures) can and cannot do.
