Commissioner Santos: My concern is more so about the local efforts that are happening to inform the undocumented community? Getting there input at least.

Staff: Undocumented folks can support efforts through canvassing and letting those who can vote know about this campaign. I also encourage you to attend a CEC meeting and speak to the whole committee.
