Commissioners Quick & Zhang presented to HLU

- intro: in 2018-2019 the YC voted to close Juvenile Hall by December 31st, 2021
- background: in the fall of 2020 BOS shelved a long-term lease for an existing gas station on public land.



- proposed resolution: this reso would support the building of social housing on City Land, instead of a gas station or Juvenile Hall. Also urges the City to move away from the private sector and market rate. Basically, we need to build affordable housing even when it is fiscally challenging.
- What is social housing: it is a more unified way of building affordable housing. affordable housing is usually created by private orgs or non profits and a combination of tax credits, state, and local subsidies. Social housing has below market, at market, and above market rate housing.
- Rationale: affordable housing is a human right, better than juvenile hall
