In transportation, I would like to see free quality and frequent transportation everywhere in the city. evenly distributed, local busses and priority lanes - see larger transit be expanded all over the bay, thinking of bart extending to marin - getting rid of highways and building housing - i would also like for us to build quality and supportive housing (affordable) - rebuild SROs for nice apartments & i would love to see us (City) participate more actively in the regulation of housing, so we provide money and also capturing money from folks who make more money



- Jayden: quality affordable housing in D1, majority single family homes - destigmatize affordable housing - moving toward a world where people put each other first
- Erika: transportation, in my neighborhood is ignored, i hope muni can put more transportation in d11 bc so many seniors walking up hills - southside districts has little to no transportation - higher into the city has transit options that are more accessible
- lillian: i'd like if bus lines would arrive on time and more often - i live in opposite directions from my school and it's annoying to commute 1 hr to get to school
 - housing: Chinatown is predominantly SRO, which are meant for 1 person, but are occupied by multiple families sometimes. We have a lot of vacant housing spaces
- Plyfaa: the phrase "housing 4 all" sometimes eliminates quality - for me gives quality spaces for everyone, regardless of income - if income is still factored i hope to see more affordable housing and supportive housing
