Felix made the changes to the resolution and will be focusing on 16-18 year olds instead of 14-18 year olds. The previous ask was \$270,000 which now means \$60,000 when focusing on 16-18 year olds. He also put in the request for funds to be pulled from BOS and/or MO office and not just DCYF. Staff will send new updated resolution to DCYF.
