I. Debrief of last full Youth Commission meeting



The committee expressed content with how the past full commission meeting transpired. They also recapped the events to fill in Commission Yu due to her absence at the last full commission meeting. There was no public comment.

J. Discussion and updates on supporting fellow commissioners in coming term

Committee members shared updates from reaching out to their colleagues to see how they are doing at this point in the term, and if they need any support. No outstanding support measures or action items. There was no public comment.

K. Review of Updates on Commission Outreach and Communications

Due to the absence of the Outreach and Communications representative, the chair opened the discussion to contributions from the rest of the committee and staff. Staff person LaCroix reminded the group that Youth Commission applications are out and open. Additionally, during the visit with the Homestead Youth Commission (YC), they shared best practices around commission branding. Homestead YC discussed how they brand themselves through the use of collateral. The committee discussed the possibility of bringing collateral to the San Francisco Youth Commission in the future. There was no public comment.

L. Review of recent youth-related Board of Supervisors legislation

Commissioner Marshall-Fricker informed that the Board of Supervisors did not introduce legislation relevant to the commission at their March 20th meeting. There was no public comment.

- a. <u>Housing Environment and City Services:</u> was not able to meet at their March 26th committee time. They are completing their draft Budget and Policy Priorities.
- b. <u>Justice and Employment:</u> met March 26th and discussed movement forward on an employment resolution brought forward by Commission Vigil. Also, the justice focus group discussed a potential letter of support for their resolution brought forth to the full commission from the Office of Transgender Initiatives.
- c. <u>Civic Engagement and Immigration</u>: held their March 20th committee meeting to discuss a resolution brought forward by Commissioner Desgarennes and to follow up on the resolution brought forth by Commissioner Andam.
