E. Omnibus Resolution

Commissioner Quick did an update on the resolution with the understanding that executive committee is more of an oversight committee and procedural rather than actually determining the budget, and acts as a facilitator for committee conversations if necessary. The resolution has already been heard once, all three committees went through the process, and for next FYC options are to schedule next reading of full resolution which we could pass as it is with blanks, or proceed with the same game plan. There is potential to do a mini-committee report on budget priorities and add what policy areas are currently up for consideration and to correct grammatical errors in the next few meetings. Commissioners offered the feedback to make amendments with FYC in mid-November. On Monday, second reading shall be called and commissioners would like to table the second reading after a mini committee report back discussion and add what policy areas are currently up for consideration.
