The meeting was called to order at 5:03pm. Commissioner Mesler was absent and had requested a leave of absence that was pending full Youth Commission approval. Commissioners present: Franet, Gregory, Vigil; Staff present: Kiely Hosmon; There was quorum.

Commissioner Gregory, seconded by Commissioner Vigil, moved to approve the agenda. There was no public comment. The motion was approved by acclamation.

- B. Presentation on System Involved Young Women's Bill of Rights  
Presenter: Krea Gomez, Organizing & Advocacy Director, The Young Women's Freedom Center

Krea, along with two youth, presented to the JEC Committee.



Any work that Young Women's Freedom Center (YWFC) does must abide by their guiding principles and they have three organizational strategies: leadership development, movement building, and shifting the narrative.

Their unifying Bill of Rights is used to determine what campaigns to create/participate in, what legislation to support or oppose, and focuses on what it means to have dignity and respect when system involved.

Juvenile Center has decreased admission by 39%, but disparities persist with a portion of young people who cycle back through the system repeatedly. This is a system problem.

Main focus is on Juvenile Hall-they want a suspension or elimination of folks who are sent out of state. They also want the money that goes into the 50% empty juvenile hall to be put back into family and community support resources.

They are in the works of getting the Mayor of Stockton to approve the Bill of Rights there. They would like the Bill of Rights to be passed in SF. Reimagine SF Youth Justice Workgroup is a main entity of getting this to come to fruition. Their ultimate big dream is to shut down juvenile hall entirely and send youth to alternatives services.

Asking JECs to help push the Bill of Rights to be accepted by the city. Get YWFC on the March 19<sup>th</sup> agenda to present, and JEC could write a standalone BPP on this issue or envelope it under other justice issue related BPPs.

Commissioner Franet, not speaking as chair, and seconded by Commissioner Vigil, motioned to support the Young Women's Freedom Center Bill of Rights. The motion was approved by acclamation.

YWFC committed to writing a letter of support regarding the TAY decarceration resolution, showing up to public comment for the BLA and potentially gang injunction hearing, and willing to provide space to practice public comment.
