B. Presentation on the History of Vote16 Campaign Presenter: Joshua Park, Youth Commission Intern



Josh gave context to Vote16 issues from the last 1-2 years. Addressed who the Board of Education and the Student Advisory Council were and their roles.

In 2016 a resolution was passed by the Board of Ed that said American Democracy classes should have a lesson and information available regarding voter pre-registration for 16 & 17 year olds. Commissioner Andam wants to know why in those classes-it's based on age as it would make sense to do something that targets a 14 year old.

This resolution also helped give more support to the Vote16 campaign as it was voted in unanimously and youth used it as a talking point when discussing with Board of Supervisors on Vote 16 advocacy.

Prop F, which was the Vote16 campaign on the ballot, lost by 2% but we can still keep moving forward on the Board of Ed resolution to get implementation of lessons in SFUSD classrooms. What the YC can focus on is the implementation process of the resolution, to give specific guidelines and a process of what this could look like in classrooms.

D. Committee Priority Brainstorm Session

Chair Mao led the group in a review of our group agreements. The Committee is recommitting to accountability and better communication:

- -if asked to do something, do it
- -put 100% into your work
- -have a constant line of communication
- -be flexible if issues come up, don't take accountability too far (but communicate ahead of time)
- -ask questions
- -ask for help

Projects/Campaigns to focus on for rest of term:

- Prop N implementation
 - Get regular/quarterly updates from Chinese for Affirmative Action
- Immigration
 - Organize rallies/symbolic efforts/draft up and pass resolutions
- Vote16 work
 - Meet with supervisors (especially new ones) to talk about importance of youth voting in SF
 - Meet/talk with community organizations and youth
- Fee waiver for CA IDs
 - Start research (Arianna, Felix, and Jarret will create a research plan)
 - Staff will get presenters to help give us more info on parallel processes (ex: how did DACA get their fee waivers?)
- Implementation of 2016 Board of Education voter pre-registration resolution
 - o Josh, the YC intern, will focus on this and take on as his project
 - o CEI Cmte will show up if/when necessary



The three major areas of interest that CEI will take action on:

- 1) CA ID fee waivers for youth
- 2) Immigration issues
- 3) Vote16 2020

Four BPPs will be written on:

- 1) CA ID fee waivers for youth
- 2) Immigration issues
