Staff and Commissioner Marshall-Fricker informed that there is no new legislation from the Board of Supervisors due to the legislative recess for the holiday season. Staff informed that they will report back to the committee on the legislation that was referred to the YC and hear at their January 2<sup>nd</sup> meeting. Chair Amable asked commissioners their thoughts regarding the legislation, in particular the proposed budget set-aside charter amendment. On the whole commissioners shared that the meeting was fine but the presentation was confusing and they wanted more detailed information about the potential impacts this legislation can have on organization funded through these funds. There was no public comment.
