- -Get Kamala Harris to endorse it.
- -Get Nancy Pelosi to endorse it again.
- -Believes we would need to get him the language to introduce it at the BOS level by May 2020 to have the Supervisors vote on it by June 2020 to get it on the November 2020 ballot.
- -Strive for an actual political campaign so we can take money and not rely solely on grants/foundations/individual donors.
