B. Team Building Activity - Setting HLU Mission Statement

Staff Estrada led Commissioners in an activity that supported the development of HLU's mission statement. Staff asked Commissioners what the components of a strong mission statement are, and shared examples of other mission statements from schools, nonprofits, and grassroots organizations. Commissioners referenced their goals and values to help them draft their mission statement. They worked on the statement individually and then came together as a group to create a collective statement. After some discussion Commissioners wrote the following draft mission statement:

The Housing and Land Use Committee advocates for housing and supportive services for youth; while holding the City and County accountable to its commitments to resolving youth homelessness; and for creating equitable transportation options for young people in San Francisco.

Commissioners decided to wait for the next HLU meeting on 11/7 to vote this in as their official mission statement. They decided this because they want to have everyone's input and there was 2 Commissioners absent.

Commissioner Quick updated the committee on a piece of legislation that has left a BOS committee and will be voted on next Tuesday during the full board meeting. The proposed legislation will increase the cost of office space.

Housing and Land Use Committee Amendments: 1920-AL-02 October 24, 2019 – **MOTION TO RECOMMEND** Omnibus Preliminary Budget Priorities - Priority Programs

BE IT MOVED, That the Housing and Land Use Committee recommends the following language to be submitted to the full Youth Commission for consideration as an amendment to YC File No. 1920-AL-02 [Omnibus Preliminary Budget Priorities - Priority Programs], inserted on line 4 of page 3 of the aforementioned resolution as read into the record on September 23, 2019:

<u>FURTHER RESOLVED, That, following the recommendation of its Housing and</u> <u>Land Use Committee, the Youth Commission urges HSH to propose funding in its</u> <u>budget for FY 2020-2021 and FY 2021-2022 sufficient to create and maintain a</u> <u>minimum of 400 units of permanent supportive housing for TAY; and, be it</u>

<u>FURTHER RESOLVED, That, following the recommendation of its Housing and</u> <u>Land Use Committee, the Youth Commission urges HSH to propose funding in its</u> <u>budget for FY 2020-2021 and FY 2021-2022 for programs and services that target TAY</u> <u>experiencing homelessness proportionally to the size of the population of TAY within the</u> <u>larger population of individuals experiencing homelessness; and, be it</u>

<u>FURTHER RESOLVED, That, following the recommendation of its Housing and</u> <u>Land Use Committee, the Youth Commission urges HSH to propose funding in its</u> <u>budget for FY 2020-2021 and FY 2021-2022 for mental health and substance use</u> <u>treatment and counseling programs, particularly targeting TAY experiencing</u> <u>homelessness or living in supportive housing; and, be it</u>

<u>FURTHER RESOLVED, That, following the recommendation of its Housing and</u> <u>Land Use Committee, the Youth Commission urges HSH to propose funding in its</u> <u>budget for FY 2020-2021 and FY 2021-2022 for equipping TAY experiencing</u> homelessness with first-aid survival resources, and for increased support services for food, laundry, and transportation for that population; and, be it

<u>FURTHER RESOLVED, That, following the recommendation of its Housing and</u> <u>Land Use Committee, the Youth Commission urges HSH to collaborate with other</u> <u>agencies and community-based organizations to propose funding in its budget for FY</u> <u>2020-2021 and FY 2021-2022 for employment training for TAY, programs for life</u> <u>training for TAY, and financial support for education resources for TAY; and, be it</u>

<u>FURTHER RESOLVED, That, following the recommendation of its Housing and</u> <u>Land Use Committee, the Youth Commission urges HSH to propose funding in its</u> <u>budget for FY 2020-2021 and FY 2021-2022 for more accessible drop-in centers for</u> <u>TAY experiencing homelessness to enter a supportive system; and, be it</u>

<u>FURTHER RESOLVED, That, following the recommendation of its Housing and</u> <u>Land Use Committee, the Youth Commission urges SFMTA and SFCTA to propose</u> <u>funding in their budgets for FY 2020-2021 and FY 2021-2022 to establish a strategy to</u> <u>build an effective, equitable, and sustainable transportation system for San Francisco</u> <u>youth and students; and</u>
