#### 1. Call to Order and Roll Call

Chair Hylton called the meeting to order at 5:00pm. Quorum is met.

#### 2. Approval of Agenda (Action Item)

No public comment. Commissioner Cureton motioned to approve the agenda seconded by Commissioner Ibarra. Motion passes by a vote of acclamation.

  - A. Presentation from the Department of Police Accountability: Know Your Rights Draft Materials
    - a. Presenter: Danielle Motley-Lewis

Commissioner Hylton motioned to table this item until presenter arrives, seconded by Commissioner Ibarra. Motion passes by a vote of acclamation.



Danielle Motley-Lewis (DML): Samara Marion, Director of Policy worked previously with the Youth Commission on these rights. We've created something that can be created in a trifold card size on cardstock for youth, the wallet card is to have something easily accessible on to write your guardians phone numbers and QR code will send to the full pamphlet.

Commissioner Ibarra: What is QR code?

DML: It is a barcode that links to website and pamphlet with full information.

The commissioners provided the following suggestions and questions to DPA staff Danielle Motley-Lewis & Marie.

- 1) Commissioner Ibarra: It would be helpful to include alternative numbers to call outside of police, for example Homeless Outreach Team, Domestic Abuse Lines
- 2) Commissioner Cureton how do you plan on distributing this information?
  - a) DML: There will be presentations to schools and drop them off to partner schools & press release coming out next week stating that the initiative is finalized and that we can schedule trainings and let folks know where to pick up materials.
    - i) Commissioner Cureton: It would be helpful to connect with health teachers for youth rights presentations.
- 3) Commissioner Hylton: What workshops will you be hosting? Will it go into deeper details?
  - a) DML: It will cover an overview of dpa and what we do. Followed by a juvenile jeopardy game or qa
- 4) Commissioner Ibarra: Information that my young people, given my experience at Larkin Street: Young people would appreciate knowing your rights regarding:
  - a) outlining search clause, with a car
  - b) immigration other languages available:
  - c) suggestion: to know as a young person how and what do we document when we go to pd to inform how we can make the complaint
    - i) badge number and st number
    - ii) witness descriptions
- 5) Staff: It would be affirming to have gender-inclusive language throughout the documents.
- 6) Commissioner Cureton: The defining consensual contact and detention are good to have. And in the wallet card, the detention statement is cut off with the last statement. It would be mindful to figure out if putting "a few minutes" is a good idea for holding as it might lead young people to think that they can leave after 30 minutes for example.
- 7) Commissioner Ibarra: FAQ for youth
  - a) Example: For unhoused youth, what could they do to behavior-wise to come in contact with PD when loitering or selling items?
- 8) Commissioner Hylton: From the copwatch training we learned that many feet you have to be away for bystander training, for example 10 15 ft away in the bystander.



- 9) Commissioner Cureton: On the tiny card but it will highlight Miranda rights on there,
- 10) DML: How often do we meet with youth?
  - a) Commissioner Cureton: We've had opportunities with youth police roundtable, different districts, youth advisory boards, and youth townhalls, and depends on youth commissioners' capacity.
- 11) The QR barcode can include as a future, multiple contacts with police rights.
