Discussion:

- Commissioner Cheung: we did a lot of debrief in our committees

- Commissioner Cureton: don't want to go back either, but I did want to bring up that I haven't heard from CEC during that meeting
- Commissioner Cheung: Commissioner Ginsburg did participate, but maybe other CEC members didn't speak up because there are more 1st years?
- Commissioner Chan: I generally don't speak up during FYC meetings. I especially didn't feel comfortable when we had guests because my anxiety increases.
- Commissioner Santos: I was reflecting, am I taking up too much space as a non-black person? I don't feel connected to others in CEC.
- Commissioner Cureton: since crystal & sarah have more experience with cec members, how do you all think we can engage other members?
- Commissioner Cheung: it's going to be tough without calling them out. Echoing amara, there is a disconnect between cec & other committees. Maybe we can call upon each member?
- Commissioner Cureton: do you all think you can have a conversation with CEC at your next meeting? I think knowing the why is important too.
- Commissioner Cheung: yeah i think we could. not sure when our next meeting is, but we can add it into our discussion.
- Commissioner Santos: I feel like there were opportunities for folks in CEC to add to the discussion.
- Commissioner Quick: HLU + TJ works together more than other cmtes. there isn't more with CEC
- Commissioner Cureton: maybe it's just a culture change and we can emphasize this more next year.
- Staff: i think CEC has been heavily focused on Vote16. I don't think they
- Commissioner Chueng: maybe CEC members can sit in on other committees and get out of the Vote16 bubble.
- Commissioner Chan: I agree with sarah. it's harder to be involved in other committees' work since Vote16 has taken off.
- Commissioner Santos: I get that CEC is structured differently. I think there needs to be more of a personal investment. We can benefit from supporting each other's work.
- Commissioner Chueng: we are nearing our time for this meeting, but I would like to continue this conversation offline.
